MINUTES OF BOARD OF DIRECTORS MEETING April 18, 1953

The Board of Directors of Texas Technological College met in regular session in the Office of the President, Texas Technological College, Lubbock, Texas, at 9:30 A.M. on Saturday, April 18, 1953. The following directors were present: Chairman Thompson, Mr. Benson, Mr. Price, Mr. McLaughlin, Mr. Pfluger, Mr. Abbott, Mr. Moore and Mr. Watkins. In addition, President Jones, Vice President and Comptroller Pennington, Secretary Gaston and Assistant Secretary Wells were present.

- 1053. President Jones presented the Agenda under the date of April 3, 1953, and recommended its approval. Upon motion by Mr. Pfluger, seconded by Mr. Abbott, the Board approved the first twenty-one (21) pages of the Agenda (Items No. 771 to 1052, inclusive). A copy of the Agenda is attached and made a part of these minutes. Attachment No. 1.
- 1054. Upon motion by Mr. Benson, seconded by Mr. Price, the Board appropriated \$1,099.00 from the Building Funds of 1949 to the Music Building Equipment Fund for the purchase of a Hammond Organ, Model C-2 Console, HR-40 Tone Cabinet from the Jenkins Music Company of Lubbock, Texas, at a cost of \$2,599.00. This appropriation is to supplement a \$500.00 balance in the Music Building Equipment Fund and a gift from Mr. George E. Benson of \$1,000.00 to apply on the purchase of the organ. The Board voted to accept this gift and expressed its appreciation to Mr. Benson for this generous contribution.
- 1055. Upon motion by Mr. Abbott, seconded by Mr. Benson, the Board accepted a contribution from the Ex-Students' Association of Texas Technological College in the amount of \$17,574.45 to apply on the Student Union Building construction and directed the Secretary to write a letter of appreciation for the Board.
- 1056. Upon motion by Mr. Price, seconded by Mr. McLaughlin, the Board accepted a gift of two (2) Zenith Television Sets; one (1) a Console Model K-2260-R (value \$399.95) and one (1) Table Model K-2229-F (value \$274.95) for the Student Union Building from the Nunn Electric Supply Corporation, 2425 Texas Avenue, Lubbock, Texas, and directed the Secretary to write a letter of appreciation for the Board.
- 1057. Upon motion by Mr. Abbott, seconded by Mr. Benson, the Board approved a request from Miss Margaret Watson Weeks, Dean of the Division of Home Economics, that she be officially retired effective August 31, 1953. The Board also appointed Miss Weeks, Dean of Home Economics, Emeritus.
- 1058. Upon motion by Mr. McLaughlin, seconded by Mr. Pfluger, the Board approved the appointment of Dr. Willa Vaughan Tinsley as Dean of the Division of Home Economics at a salary rate of \$8,500.00 for 12 months, effective September 1, 1953.
- 1059. Dean W. L. Stangel, Division of Agriculture, was invited to appear before the Board and report on attempts to develop irrigation wells on the College Farm. In response to a question from the Board as to how much money would be required to develop the irrigation system, Dean Stangel itemized the estimated cost as follows:
 - (1) To cover deficit in Farm Irrigation Wells
 Account - - - \$ 177.80
 (2) To activate a well on Agronomy Farm - \$1,350.00
 - (3) 4000' of 12" Irrigation Pipe at \$1.30 per foot with risers on Agronomy Farm - \$5,200.00 (This pipe is to be used to connect wells 1, 2 & 3.)
 - (4) Rework well No. 6 on Animal Husbandry
 Farm - - - - - 5 650.00
 - (5) 5,800' of 12" Irrigation Pipe at \$1.30
 per foot with risers on Animal Husbandry
 Farm - - \$7,540.00
 (The pipe is to be used to connect wells 6
 and 7 (2,000 feet); and for extensions from
 well 6: 1,400 feet South; 900 feet North;
 and 1,300 feet East.)

- 1059. (continued)
- Upon motion by Mr. McLaughlin, seconded by Mr. Pfluger, the Board appropriated from the Unappropriated Balance the sum of \$15,000.00 to be used in developing the irrigation system on the Agronomy and Animal Husbandry Farms.
- 1059-A. Dean Stangel discussed with the Board the possibility of the Departments of Animal Husbandry and Agronomy farming land owned by the City of Lubbock, located three miles west of Shallowater on the Littlefield highway. The Board passed this item without any official action.
- 1059-B. The Board delayed consideration of a request from the County Judge of Carson County for additional right-of-way along the north line of the original Pantex properties for a Farm-to-Market road until May 18.
- 1060. Upon motion by Mr. Benson, seconded by Mr. Price, the Board gave the Athletic Council permission to negotiate a contract for the broadcasting right of all Athletic events either with some national advertising company or with a local broadcasting station. It was the consensus of the Board that all local stations should be given an opportunity to bid in event the council attempts to negotiate on a local basis.
- 1061. Upon motion by Mr. Benson, seconded by Mr. McLaughlin, the Board voted to request the Board of Directors of The Texas Technological College Foundation to earmark funds in the amount of \$1,125.00 to be used to assist the South-Central Division of the Modern Language Association with the publication of the Quarterly Bulletin of the Organization. The funds are to be used at the rate of \$375.00 during each of the school years 1953-1954; 1954-1955 and 1955-1956.
- 1062. Upon motion by Mr. Benson, seconded by Mr. Price, the Board approved the plan worked out with Mr. R. F. Ball, President of the R. F. Ball Construction Company to withhold \$6,000.00 from the final estimate on the Science Building until the Venetian blinds are put in first-class condition, and that March 3, 1953, be officially designated as the acceptance date for the Science Building, excluding the Venetian blinds.
- 1063. Upon motion by Mr. Price, seconded by Mr. Pfluger, the Board gave the Dean of Engineering permission to try to work out a cooperative relationship between Texas Tech and other Senior Colleges approved by the Administration of Texas Technological College relative to a student receiving an A.B. Degree from an approved Senior institution with three years work there and an Engineering degree from Texas Technological College with two years work here. Both degrees would be awarded after the completion of the five year program.
- 1064. Upon motion by Mr. Pfluger, seconded by Mr. Abbott, the Board requested Dr. Wiggins and Mr. McLaughlin to go to Washington, D. C., and try to determine the exact status of PanTech.
- 1065. Upon motion by Mr. Pfluger, seconded by Mr. Abbott, the Chairman of the Board was requested to appoint a special committee from the Board to work with a special committee from the Board of the Texas A.&M. College System on Co-ordinated Policies in Agriculture between the two Colleges. Chairman Thompson appointed the following Board members to this Special Committee: Mr. Pfluger, Mr. Abbott and Mr. Watkins. This Committee will select a chairman. (The following Board members from the Texas A.&M. College System have been appointed to the A.&M. Committee: Mr. James W. Witherspoon, P. O. Box 387, Hereford, Texas, Chairman; Senator H. L. Winfield, Fort Stockton, Texas; and Mr. Jack Finney, Greenville, Texas.)
- 1066. Dr. Jones reported that Mr. James H. Stewart, Executive Vice President and General Manager of The State Fair of Texas had extended Texas Technological College an invitation to be represented at the 1953 Fair with an exhibit. It was the consensus of the Board that Texas Technological College should plan for an exhibit at the 1953 State Fair.
- 1067. Upon motion by Mr. Pfluger, seconded by Mr. Abbott, the Board voted to invite all former Board members to visit the campus on each annual Homecoming Day as guests of the Board.
- 1068. Upon motion by Mr. McLaughlin, seconded by Mr. Pfluger, the Board voted unanimously to ask Dr. Wiggins to accept, on May 25, 1953, the Honorary Degree from Texas Technological College which was approved by Item No. 521, Board Minutes of December 6, 1952.

1069. Upon motion by Mr. Price, seconded by Mr. Pfluger, the Board gave the Department of Agronomy permission to sell one (1) Model WA. 36 M.E. Rotary Tiller Cut 36 Swath, Manufactured by Milwaukee Equipment Company, and purchased on May 28, 1948, Account No. P47-5870 at a cost of \$558.75. The estimated sale price is \$500.00. The proceeds from the sale are to be credited to the Agronomy Farm Account.

1070. Upon motion by Mr. Pfluger, seconded by Mr. Price, the Board approved an overlap in the salary schedule for the Instructional Staff, effective September 1, 1953.

1071. Mr. Thompson appointed Mr. Moore as a member of the special committee to work on the Guinn Estate. (Other members of the committee are Mr. Pfluger and Mr. Thompson.)

The Board went into an Executive Session at 3 P.M. and passed items 1072 to 1075, inclusive.

Mr. Thompson, Chairman of the Board of Directors, read a letter dated April 17, 1953, and addressed to the Board of Directors, the President, and the Faculty of Texas Technological College, stating that he had decided to submit his resignation as a member of the Board to the Governor.

1072. The Board appointed Dr. G. E. Giesecke, Dean of the School of Applied Arts and Sciences, North Dakota Agricultural College, Fargo, North Dakota, Academic Vice President of Texas Technological College, to be effective not later than September 1, 1953.

1073. Upon motion by Mr. McLaughlin, seconded by Mr. Benson, the Board elected Mr. Price. Vice Chairman of the Board of Directors.

1074. Upon motion by Mr. Benson, seconded by Mr. Price, the Board elected Mr. W. T. Gaston, Secretary of the Board of Directors.

1075. Upon motion by Mr. Benson, seconded by Mr. Price, the Board elected Mr. J. Roy Wells, Assistant Secretary of the Board of Directors.

Adjournment -- The Board adjourned at 3:50 P.M., April 18, 1953, until its next meeting on Monday, May 18, 1953, to be held at 3 P.M. in the Office of the President, Texas Technological College, Lubbock, Texas.
