DECEMBER 1, 1950

The Board of Directors of Texas Technological College met in regular session in the Hotel Herring, Amarillo, Texas, at 7:00 P.M., Friday, December 1, 1950, with the following present: Directors Thompson, Chairman, McGee, Vice Chairman, Ince, Weymouth, Wooldridge and Price; President Wiggins, Comptroller Pennington, Secretary Gaston and Assistant Secretary Smith.

466. President Wiggins presented the agendum under dates of October 25, 1950, and November 18, 1950, and recommended their approval. Upon motion made by Mr. McGee, seconded by Mr. Weymouth, the Board approved Items 212 through 465 of the agendum as presented.

467. Upon motion made by Mr. Price, seconded by Mr. McGee, the Board approved the following changes in the contracts covering the Administration Building Wings:

Approved installation of electric clocks for Administration Building Wings by W. G. McMillan at a cost of \$428.50.

Accepted a credit from W. G. McMillan in the amount of \$1203.60 for substitution of flex-aluminum venetian blinds in lieu of wood slat /blinds as specified.

Accepted a credit in the amount of \$207.00 from Empire Electric Company covering the deletion of the electric ground mat.

Approved change in asphalt tile which is to be placed in thirteen offices of the Administration Building Wings from Class C to Class D. The change over will not only provide a better grade of tile but will enable better color selections. The added cost to the contract with W. G. McMillan will amount to \$121.00.

468. Upon motion made by Mr. Weymouth, seconded by Mr. Wooldridge, the Board accepted a credit of \$400.00 from the R. F. Ball Construction Company covering the omission of floor outlet boxes in the architectural laboratories of the Engineering Building.

469. Upon motion made by Mr. McGee, seconded by Mr. Weymouth, the Board approved the following changes in the contract with the R. F. Ball Construction Company covering the Home Economics Building:

Approved an increase in the amount of \$393.46 to cover the following:

Omit storm sewer to roof conductors. Construct concrete splash block at foot of each roof conductor (no dowels in wall from blocks) and extend conductors down to blocks. Install complete vacuum pump as furnished by Owner. All as shown on Drawing dated June 19, 1950.

Accepted a credit in the amount of \$750.00 as follows:

For Textile Laboratory air conditioning unit from unit specified to air handling unit Trane No. 1-8 Horizontal Climate Changer; insulated casing; 12" x 18" 4-row D. E. coil, single standard Serp. supply right; 12" x 18" 1-row type SD Coil, series 54; supply right; 2 psi steam; steam grid humidifier, supply right; face and bypass dampers, rod right; filter section with dustip filters; 1/8 HP, 1/60/115 1725 RPM Constant speed motor and drive, motor right; fan speed 700 RPM. Compressor - General Electric CWC42T, 1 HP. Temperature Control - Minneapolis-Honey-Well as specified. Duct, grilles, insulation, etc., as shown on present plans and specifications. Type "K" fixtures in Textile Laboratory 202 shall be stainless steel of same size and design as Dura-Clay as specified.

- 470. Upon motion made by Mr. Price, seconded by Mr. Weymouth, the Board appropriated from the unappropriated balance the sum of \$1,964.60 to be used to pay the City of Lubbock for a water meter. This expenditure is in accordance with the terms of the contract entered into between the City of Lubbock and Texas Technological College under date of January 9, 1949.
- 471. Upon motion made by Mr. Weymouth, seconded by Mr. Price, the Board appropriated from the unappropriated balance the sum of \$3000.00 to Research for the year 1950-51. (As of August 31, 1950, \$3,133.00 of Research Funds for the year 1949-50 were lapsed).
- 472. Upon motion made by Mr. McGee, seconded by Mr. Ince, the Board authorized the use of \$84,000.00 from Legislative appropriations for repairs and improvements to be used in payment of contracts for the extension of the utility system on the campus.
- 473. Upon motion made by Mr. Price, seconded by Mr. Ince, the Board approved a resolution authorizing Doctor Joe Dennis, Professor and Head Department of Chemistry, to sign, execute and acknowledge Tax-Free Alcohol Permit documents in behalf of Texas Technological College. A copy of this resolution is attached to and made a part of these Minutes.
- 474. Upon motion made by Mr. Wooldridge, seconded by Mr. Ince, the Board approved the use of Jones Stadium by the American Business Club of Lubbock, Texas, for the Annual Boys' Club Rodeo during the month of June, 1951. A Memorandum of Agreement will be entered into between the Athletic Department and the American Business Club on the same basis as for the year 1950. (See Item 603 of Minutes for March 18, 1950 Meeting of Board).
- 475. Upon motion made by Mr. McGee, seconded by Mr. Price, the Board accepted the resignation of Mr. L. Edwin Smith, Assistant Secretary of the Board of Directors and Assistant to the President, effective December 15, 1950. The Board directed that a resolution of appreciation for Mr. Smith's services to the College and to the Board be prepared.
- 476. Upon motion made by Mr. McGee, seconded by Mr. Weymouth, the Board approved the appointment of Mr. J. Roy Wells as Assistant to the President, effective February 1, 1951 through August 31, 1951, at a salary rate of \$7500.00 for 12 months.
- 477. Upon motion made by Mr. Wooldridge, seconded by Mr. McGee, the Board authorized the Building Committee to proceed with the necessary action to have the plans and specifications for the Student Union Building completed in order that bids may be accepted at the next meeting of the Board to be held February 10, 1951.
- 478. Upon motion made by Mr. Wooldridge, seconded by Mr. Ince, the Board rejected all bids on a portion of the college depository heretofore received, and instructed that invitations be extended to all Lubbock banks to bid on the over-all college depository --- bids to be opened by the Finance Committee at 4:00 P.M. on Friday, February 9, 1951.

Adjournment --- The Board adjourned at 10:30 P.M., December 1, 1950, until its next meeting on February 10, 1951, to be held at 9:00 A.M. in the Office of the President, Texas Technological College, Lubbock, Texas.
