### OUTLINE OF STUDY

UNITS meeting second week of September: Sept. 11, 12, 14

Topic: Water Conservation - Adequate Water Supply

### A. General Information

Watershed - the region or area drained by a river, etc.; a drainage area.

Location of water-supply lakes is based on site with sufficient water-shed.

Acre foot - water sufficient to cover one acre in area one foot deep.

Study of maps of Wichita Falls area, considering possible sources of water supply.

Wichita Falls is in the Red River Basin.

- B. Present Water Supply
  - Lake Wichita on Holliday Creek completed 1901
     Capacity: 4½ billion gallons (3 or 4 months' standby if needed)

2. Lake Kemp on Wichita River completed 1924
Capacity: 132 billion gallons
(used for irrigation and by some industries to
save palatable water of Lake Kickapoo)

- Lake Diversion on Wichita River completed in 1924 Capacity: 13 billion gallons
- 4. Lake Kickapoo on Little Wichita River. Completed in 1947. Capacity: 34 billion gallons (101,000 acre-feet of water)

4 pump stations to be installed by October to eliminate using Lake Wichita water - Kickapoo has a 3-year supply of water if proper distribution facilities available.

### 5. Conservation measures:

- a. New elevated storage tank at Avenue Y near the Fort Worth and Denver Railroad soon to be in use to improve distribution in southwestern Wichita Falls IF water supply sufficient to fill.

  Capacity: One million gallons.
- b. City of Wichita Falls is participating in an evaporation control experiment by a method developed by an Australian which it is claimed reduces evaporation 45 per cent.

Annual evaporation at Lake Kickapoo takes twice the amount of water used by the city. Thus, if evaporation could be cut in half, the city would double its water supply.

- c. Underground clear well about completed at Bond and Jasper Streets which will store water that has been softened, settled and chlorinated. Capacity: Five million gallons.
- C. Need for Additional Water Supply

If Wichita Falls continues to grow in future at same rate as in past few years, present water supply will be totally inadequate within a period of from 8 to 14 years.

Not practical to enlarge Lake Kickapoo because the watershed is not very big, thus amount of increased water supply would not justify cost of enlargement.

In January 1956, Wichitans were using 7,500,000 gallons of water daily.

Summer 1955 averaged nearly 20,000,000 gallons per day with a peak of 24,000,000.

As of August 1956, 22 to 24 million gallons a day is being used. Record for August 9 was 23.14 million gallons, with 22,288 water meters in use.

In order to supply this daily amount Lake Wichita water is being mixed in varying amounts with Lake Kickapoo much more palatable water. On some days Lake Wichita water makes up more than half the raw water supply. The percentage varies downward to as little as 20 per cent at other times. Some improvements in distribution system will somewhat alleviate the situation but will not be long-term solution to adequate water supply.

Additional water supply will become imperative if city continues rapid growth and if industries are to be induced to come to Wichita Falls.

- D. Types of Water Projects
  - 1. Water Conservation U. S. Bureau of Reclamation
  - 2. Flood Control
    U. S. Corps of Engineers

- 3. Water Districts (Water Improvement and Control) State Water Board
- 4. Multiple-Purpose Integrated project with cooperation of all agencies.
- E. Proposed New Lakes Being Considered August 1956

All proposed sites, except the Waurika location, are on the Little Wichita River - between Lake Kickapoo and Red River.

All the water on the Little Wichita River watershed is good, palatable, similar to that of Lake Kickapoo.

1. Ringgold site on the Little Wichita River - favored at present.

Location: 6 miles northeast of Ringgold - 18 miles downstream from the Scotland site.

Estimated cost: \$19.8 million - 41 MGD - 840 ft. spillway 25.7 million - 70 MGD - 849 spillway

One proposal is to build high dam and a lower spillway to be followed later with another spillway to form a series.

Advantages: Includes no oil property. Few property owners.

Larger watershed. Deeper Lake bed.

Disadvantages: Due to distance from Wichita Falls, a higher operating expense - more miles of conduits, uphill all the way.

2. Scotland site on the Little Wichita River—recommended by the Bureau of Reclamation in 1952.

Location: About 9 miles west of Henrietta - 18 miles upstream from Ringgold Reservoir.

Capacity: 18 MGD (700,000 acre-feet)

Estimated Cost: \$12.2 million.

Advantage: Closer to Wichita Falls
Gravity can bring water economically.

- Disadvantages: (a) U. S. Highway 101 inundated for more than a mile, necessitating elevation of roadway 10 or 15 feet.
  - (b) High-power lines and pipes would have to be rerouted.
  - (c) Oil wells and oil property would be inundated.
  - (d) Because of oil, land costs would be higher.
  - (e) A city should own and not lease lake lands.
  - (f) Much smaller reservoir capacity than Ringgold site.
- 3. Waurika Project ruled "out" at present, but still being mentioned often.

Location: In Oklahoma on Beaver and Cow Creeks - 6 miles northwest of Waurika in Jefferson County.

Capacity: 30-50 million gallons daily - 227,000 acre feet of water.

Area: Will cover 9,300 acres of land.

Cost: A Federal project costing \$17,000,000, including a 42" pipe line to Wichita Falls.

This Waurika Reservoir would be a multiple-purpose project. The order of benefits from the reservoir would be:

- a. Municipal water
- b. Industrial water
- c. Irrigation water
- d. Flood control
- Recreation

If Wichita Falls should participate in this Waurika project, the city would enter into a contract to buy a certain amount of water for a certain number of years from the Waurika Reservoir at an agreed price per 1,000 gallons.

Advantages: Wichita Falls would not build or pay for the Reservoir.

Disadvantages: Cost of the conduits alone would be 3 or 4 million dollars, if not more, (37.5 miles to Wichita Falls). This would be considered in the price of the water bought by Wichita Falls.

> Reservoir would not belong to Wichita Falls or be controlled by it.

> An interstate compact between Texas and Oklahoma would have to be made regarding the Reservoir and participation of Wichita Falls in sharing water.

Oklahoma cities would have priority in use of weter.

Estimated it will take 10 to 12 years to get the project completed. Wichita Falls cannot wait so long for additional water supply.

#### 4. Other Sites

At least two other sites on the Little Wichita River have been considered at one time or another but have been discarded in favor of the Scotland and Ringgold sites.

Chief reason for ruling out these locations has been the presence in the areas considered of producing oil wells.

#### Twin Lakes

Some consideration has been given to combinations of sites at various spillway elevations.

For example - one combination of reservoirs, one above, one below Henrietta, has received favorable mention. Together, the twin lakes would have a capacity of 533,700 acre feet, with an estimated yield during a critical drought period of 69.3 million gallons per day. Total estimated cost: \$12,868,000.

Advantage: Could miss possible oil fields, railroad right-of-way, and highways.

### A. Water Conservation - Possible Action and Member Suggestions

### 1. Financing Proposed New Lake

a. Wichita County Water Control and Improvement District No. 1 will issue revenue bonds in the amount needed for construction of the lake and other required facilities - land acquisition, a dam or dams, and pipelines.

No tax bonds would be issued, thus no increase in taxes.

Because of its present bonded indebtedness, the city of Wichita Falls cannot pass any more bond issues until 1964, - too late on the time-table of need for a new water-supply lake. On the other hand, the Water District 1 is in good financial position to have a bond issue to pay for construction of the new lake, and the plan is for the city to reimburse the District by payments for water used from the new lake.

Qualified voters of Water District 1 will have to approve the bond issue at an election called for the purpose, if this plan is to be carried out.

b. Contract between the City and the Water District 1.

Wichita Falls will contract to buy water of the new reservoir from the Water District 1 at a rate sufficient to underwrite the project — that is, at a rate sufficient to enable the Water District 1 to retire the bonds as they mature.

c. Federal Aid.

Matching funds subject to the U. S. Bureau of Reclamation and the U. S. Corps of Engineers might be available if the project comes within certain limitations.

If Federal aid is wanted for the project, City and District Officials and Committees go to Washington, present the problem with pertinent data to our Representative, Congressman Frank Ikard, and through him make proper application for Federal Aid.

Government agencies then make their own surveys, investigations, and recommendations.

- 2. Stages in Planning and Execution of Lake Projects.
  - a. City Council considers need and possibilities.
  - b. Surveys and recommendations are requested by the City Council from the U. S. Bureau of Reclamation, U. S. Corps of Engineers, and Water District 1. (District 1 employed the engineering firm of Freese-Nichols to make surveys)
  - c. Water District makes application (August 23, 1954) to State Board of Water Engineers for water rights on the Little Wichita River petition granted.
  - d. On February 7, 1955, Water District makes application for extension of time on water rights - 18 months extension granted.
  - e. Time expires September 1, 1956, unless another extension is granted. About August 1, 1956, Water District 1 made "presentation" to State Board of Water Engineers for a one-year extension.

In case this further extension of time is granted, a definite project must be under way by the end of the time-extension or the water rights will revert to the State to be re-assigned to some other city.

- f. Reports from all sources studying the project are made from time to time to the City Council for consideration.
- g. Council requests further study, surveys, estimates, and recommendations.

Council makes final selection of a site. i. Elections are called: (1) Water District 1 calls election on issuing of revenue bonds-voted on by qualified voters of Water District 1. City Council calls election on authorizing the City of Wichita Falls to contract with the Water District to buy water from the new lake for city use -- voted on by qualified voters of the city. j. If both elections carry vote FOR the project, District begins process of financing and constructing the Lake. Member Suggestions Discussion Questions In your opinion, is Wichita Falls looking too far in the future in proposing a new city reservoir at this time or do you think the city is not looking far enough into the future with the present proposals? Give reasons to support your opinion. (b) Do you think municipal water problems should be solved by each city solely on the basis of local needs or do you think some sort of statewide or at least area-wide planning and allotment of water resources should be adopted as a regular policy in Texas? Give reasons for your point of view. Flood Control of Holliday Creek This problem is a complex, integrated one, involving action by City, Wichita and other Counties. Only a small portion of Holliday Creek goes through Wichita Falls. Creek banks belong to property-owners along the Creek. The Government owns only the bed of the Creek from bank-to-bank. 3. Any complete, satisfactory solution must be a joint project involving Lake Wichita, Holliday Creek, and the Wichita River. Anything less than an over-all project is only partial solution. Flooding on the lower reaches of Holliday Creek is caused by the backing up of the Wichita River at flood stage. This is because the level of Holliday Creek at the point of juncture with the river is lower than the flood level of the river. 4. So far as surveys show, cleaning and dredging Helliday Creek would somewhat alleviate the situation but would be only temporary improvement. Expense, some officials believe, would be greater than benefits unless other flood control measures with respect to Lake Wichita and Wichita River were also put into effect. 5. A number of proposals for flood control of Holliday Creek have been considered. In February 1956 a "reconnaisance visit" to determine flooding problems connected with Holliday Creek was made to Wichita Falls by an engineer from the U. S. Corps of Engineers. The visit and the study were requested by the City Government. As of August 1956 the City is awaiting the report and the recommendations from the U.S. Corps of Engineers and the Bureau of Reclamation before proceeding to any steps for control of flooding of Holliday Creek. Officials are optimistic that some solution will be found. The report is expected by October 1956. -6-

- 6. The August 1-3, 1950 flood along Holliday Creek resulted in damage estimated by the U. S. Army Corps of Engineers at \$291,500. There have been a number of floods almost as disastrous through the years.



Dear Mrs. Hughes,

In my morning mail I received the report blanks for LCA wgich you had mailed to Mrs. Wolf and which she, in turn, had mailed to me. I realize that I should very long ago have reported to you that Mrs. Wolf resigned as LCA chairman at the September Board meeting and that we have not yet persuaded any other member to take on the job.

That is bad, very bad. I am as full of excuses as a dog is of fleas, but the truth of the matter is that, as first vice president(program responsibility), I have done next to nothing with my job since May 12, 1958, and yet I have consented to stay on in the same capacity, provided I am elected at our Annual Meeting, now set for March 11! How presumptious can one get!

The truth is that I want so badly to serve as program vice president and most particularly to see the KNOW YOUR COUNTY item through to successful conclusion that I dare to hope that I can do much better during the coming year than during the past year. My now 86-year old mother who makes her home with me became very ill last May 12, after which she had two hospitalizations with radium treatments, followed by daily treatments almost all summer of x-ray and cobalt. Almost miraculously, she was able to stand the terrible ordeal and is now doing very nicely, very slowly gaining back some strength but quite naturally still requiring lots of very close attention and medication. That explains why I have had to neglect so greatly my responsibility in the League, and I feel sure you will understand.

As you already know, Betty Story's resignation as president, also at September Board meeting, left us pretty well stranded, until Mrs. Finnell stepped into the breach so nobly and so well. We have made an effort to get a replacement on the Board for Mrs. Wolf but most women balk at assuming responsibility for the LCA portfolio, though they are quite willing to help under the chairmanship of someone else! I have great hopes, however, for the coming year. A sort of "log-jam" now seems to have been broken.

In the meantime, I shall prepare and mail to you the LCA report on what we have actually done, meager though it has been, and I shall get it to you within the next day or so ahead of the February 20 deadline--I promise. I'm aching to go to Council but it's impossible: I have no one at all to leave with my Mother.





- The "Know Your County " survey will be a completely non-partisan, objective, fact-finding study of Wichita County government-how it is set up and how it operates-together with a directory of County Officials at the time the survey is complete and publication is made of material gathered in the survey in the form of a Wichita County Handbook. 1.
- The survey will be entirely impersonal; that is, it will 2. consider the office in each case, not the office-holder.
- The survey will follow a manual prepared by the National Board of the League of Women Voters of the United States 3.

Board of the League of Women Voters of the United States which is used, with slight variations from state-to-state, by Leagues in all of the 48 states in making similar studies of their county governments.

A number of Leagues in Texas have made, or are in the process of making, "Know Your County" surveys. Among them are: Edinburg, Harlingen, Odessa, San Angelo, Waco, Lubbock, San Antonio. San Antonio League's study was completed and the report published in October 1957 under the title: "Citizen's Handbook of Bexar County and Directory of County Offices, "-copies of which we have on hand.

- The survey is to be a serious, carefully planned study. Everything put in the final published report will be double-checked for accuracy. That is why it is anticipated the survey may possibly require approximately two years to complete. dare to hope, however, to have it finished short of that length of time.
- 5. The survey is an ALL-MEMBER project. Each member will participate in some way in the survey work.
- The survey will be made one or two sections of county government at a time, not all at once. Progress reports will be 6. made to the central planning committee and to the League Board. Each report will be discussed by members in unit meetings and general membership meetings before it is put in final form for publication.
- Members will participate in "go-see" tours for some sections of the survey. For other sections, one or two members may ask to spend a day or more in certain offices or plants in order to observe and to get an overall picture of activities carried on by that particular branch of county government. Personal interviews with county officials, arranged ahead of time, will be one of the main sources for information in the survey. 7. be one of the main sources for information in the survey. Public documents, such as the annual budget, will be given close attention and analysis.
- 8. The purpose of the League of Women Voters in undertaking a survey of county government is to give basic information first to League members and then to provide for all Wichita County citizens a convenient, available source of information on our county affairs.

In the course of the survey we may find some aspect of county government on which we may later concentrate and which we may possibly adopt as a special project. What that might be is just anybody's guess, now at the start of the survey!

michila Fails KNOW YOUR COUNTY Our Local Current Agenda, "Know Your County", is shaping up admirably under the direction of Mrs. Jack Story, with two more extremely informative speakers this month.

Mrs. Bessie Sloane, Supervisor of City-County Welfare, spoke at the Unit Meeting on May 13th, at the home of Mrs. N. R. Sloane and Mrs. Minnie Shafer are in sole custody of the City-County Welfare Agoncy at this time. Both ladies have emphasized to us the need for more workers in their field. We have heard of some of the problems concerning Medical Welfare from Mrs. Shafer. Some of the responsibilities coming under the supervision of Mrs. Sloane are encouraging transients to continue their travels to other destinations: helping unemployed to find employment; distributing groceries to indigent families; disbursing surplus commodities on a limited scale; securing aid for dependent children; helping to "tide over" injuréd workmen until Workmen's Compensation is paid; supplying clothing, travel and incidental expenses to charity patients who are sent to out-of-county hospitals; and of course, each applicant must be investigated and certified before any of these positive steps can be taken. Next to the need for additional workers. Mrs. Sloane stressed the need for a list of definite rules to follow in determining the eligibility of welfare applicants as a help in

Our Public Health Department has the responsibility of seeing that our water is sanitary, that products from local dairies meet certain rigid specifications, that health conditions following disasters such as floods are kept under control, that any hazard to the health of the public is eliminated at once. The Public Health Department, locally under the direction of Dr. Miller, is truly the watchdog of the health of each and every one of us. Dr. Miller earnestly requested the help and active support of the League of Women Voters in interesting the public in the work of his department.

Next Unit Meeting will be in the auditorium of the Wichita Health Unit, where we will hear a report from Mrs. Jack Story, Mrs. H. W. Coffman, and Mrs. V. A. Brockman, on the Juvenile Department of this County. This promises to be an extremely interesting and timely report, and all members, as well as the public, are urged to attend and learn more about the operation of our county. This report will be followed by a "Get-Acquainted" tour of the Health Unit, conducted by Dr.
