Women's Rodeo Claims Third Place as Team Eyes Final Stretch

With three regular season rodeos left for the 2006-07 season, the Texas Tech women's team may clinch one of two top spots on their quest for the national championships.

The Texas Tech University Women's Rodeo Team took first place at the Western Texas College host rodeo March 29-31 and barrel racer Brittany Bennett solidified her position as the top contender in the Southwest Region by winning her event at this and several events this season.

Texas Tech won the women's team championship for the weekend with 360 points. This puts the team in 3rd of 17 schools in the region, trailing Tarleton State University and Vernon College.

The team now trails Tarleton by 165 points for the top spot with three rodeos to go. The top two teams from the Southwest Region, as well as the best three contenders in each of nine individual events, will advance in June to the College National Finals Rodeo held in Casper, Wyo.

"Tarelton's team has always been bad to the bone," said Texas Tech rodeo coach Chris Guay. "We've done really well so far, but we can't rest. We're going to have to have three outstanding rodeos. We head to West Texas A&M, Howard College, and finish up at Tarleton April 19-21".

Bennett, a junior agricultural communications major from Portales, N.M. has now solidified first place for the Southwest Regional championship title in the barrel racing event. Romany Gordon, Castle Rock, Colo. won second in the barrels and moved into fourth place in the regional standings. The other team members include Kaily Richardson, Pampa and Abbie Marvel Paradise Valley, Nev.



Fiftieth Mesonet Station Opens to Provide Meteorological Data

As 37th tornado anniversary nears, venture provides weather data across South Plains.

In the 37 years since one of the costliest tornadoes in U.S. history killed 26 people in Lubbock, Texas Tech University has established itself as one of the nation's authorities in wind research.

University wind researchers have now reached a new milestone: its West Texas Mesonet Group has installed a 50th station to provide a rich array of meteorological data to residents of Childress County, meaning the venture now has a station in every county on the South Plains.

The stations calculate wind speed, temperature, humidity, precipitation and other data used by farmers, researchers, meteorologists and local media. They are implemented through partnerships between Texas Tech and serviced communities.

Mesonet's first station came online at Reese Technology Center in June of 2000. The project has since expanded to cover a region spanning 33 counties from Pampa to Andrews.

About WISE

The Wind Science and Engineering Research Center was founded after the Lubbock tornado of May 11, 1970, which did more than \$100 million in damage, and Hurricane Celia, which devastated Corpus Christi later that year.

Spanning a range of disciplines from engineering to economics, the Wind Science and Engineering Research Center has pioneered the design of in-home tornado shelters, established field laboratories to study wind effects, guided the development of national standards to help buildings withstand high winds, created the tornado hazard model for the nuclear industry and developed and tested storm-resistant shelters and glass.

Texas Tech Graduate Student Earns Second Prestigious Fellowship

A doctoral student in the Department of History at Texas Tech recently won a Hall J. and Kate Peterson Fellowship for 2007-08, awarded by the American Antiquarian Society in Worcester, Mass.

Valerie McKito will spend the month of July 2008 with the society, where she will use its research collection to study historical documents relating to her dissertation work. The society is the premier research library for American history and culture prior to 1876.

Approximately 20 fellows are named each year from a national competition that includes all ranks in all fields of the humanities working in the time period.

"The American Antiquarian Society was founded in 1812 and has since become one of the premier libraries for America's early period from colonialism to the Civil War," McKito said. "One of the Loyalists I am researching for my dissertation actually helped found the society. Needless to say, the Peterson Fellowship to its library is tremendously important to my project."

McKito's dissertation is called In the Shadow of Victory: Loyalists in the Aftermath of the Revolution. She is studying the influence of Loyalists who left America after the Revolutionary War, went to various countries within the British Empire, and then returned to the United States, rising to prominence in their communities.

"It's a topic in history that hasn't really been explored," McKito said. "Upon their return, these men really weren't seen as Loyalists. It's a very different take on the creation of America."

Valerie McKito also earned one of 14 short-term residential research fellowships awarded by the Gilder Lehrman Institute of American History in New York. The first fellowship winner from Texas Tech, she will spend the month of July 2007 researching her dissertation at the institute.

Department of Psychology Receives Endowed Professorship, Faculty Excellence Endowment

Texas Tech University officials have announced the establishment of the John G. Skelton Jr. Regents Endowed Professorship in Psychology in the amount of \$500,000.

Also, officials announced the \$96,000 John G. Skelton Jr. Psychology Faculty Excellence Endowment.

The announcement took place at 1:30 p.m. Tuesday (April 17) during a news conference at the Board of Regents Room in the Administration Building, No. 1 Memorial Circle.

"This endowment provides the opportunity for the Department of Psychology to bring in a nationally recognized leader in counseling, clinical and health service psychology," said David Rudd, chairman for the department. "We hope to bring in someone that cuts across traditional boundaries – someone who can help us bridge the gap between traditional academic departments and those in applied medical centers and health science centers. The net result we hope is someone with a research program that helps solidify our relationship with Texas Tech University Health Sciences Center."

A \$346,000 donation from the estate of the San Antonio psychologist, who earned a doctorate in psychology from Texas Tech in 1967, created the professorship and a faculty excellence endowment.

The professorship is part of the Regents Faculty Endowment Program. The goal of the program is to recruit and retain quality faculty members. Of Skelton's donation, \$250,000 was matched with existing university funds to create the named professorship.

The remaining \$96,000 created the John G. Skelton Jr. Psychology Faculty Excellence Endowment, which will help enhance psychology department faculty research.

"We appreciate Dr. Skelton's desire to give back to his university," said Kent Hance, Texas Tech University System chancellor. "This endowed professorship not only honors faculty, but also emphasizes research in the area of psychology."



A national search will begin soon for a faculty member to fill the position.

"Texas Tech is poised to increase its level of influence on a national scale," said Texas Tech President Jon Whitmore. "Progress toward superior academic standing must begin with a commitment to our faculty. This faculty endowment program will allow us to recruit and retain an excellently qualified professors and researcher."

Wind Experts Available to Speak About Panhandle Tornadoes

How do homeowners ensure an in-home shelter will withstand a wind storm? Where is the best place to hide during a tornado? How does the new Enhanced Fujita Scale work?

Texas Tech University wind engineering experts are available to speak to issues involving tornadoes that touched down in the South Plains over the weekend, injuring Panhandle residents and destroying homes.

Through the collaborative Wind Science and Engineering Research Center, scientists and engineers have collected one of the country's largest repositories of wind data and helped develop the Enhanced Fujita Scale implemented by the National Weather Service this year.

Experts include:

Ernst Kiesling, professor of civil engineering and executive director of the National Storm Shelter Association, specializes in debris impact and above-ground shelters. Food Safety Expert Available to Speak about E. coli in Beef

E. coli scare prompts voluntary recall of frozen beef.

Mindy Brashears, director of the International Center for Food Industry Excellence at Texas Tech University, can speak about issues involving beef safety and *E. coli* O157:H7.

Brashears is involved in a number of endeavors to eliminate harmful bacteria like salmonella and E. coli in cattle and poultry before they are slaughtered or to eliminate the pathogens altogether before meat reaches the kitchen table.

For example, she recently developed a mixture of lactic acid bacteria shown to reduce foodborne pathogens in processed beef and poultry by as much as 99.99 percent. As head of the International Center for Food Industry Excellence, Brashears has helped attract more than \$6 million in funding for its innovations in food safety.

Weighing the financial impact of 2007 Farm Bill

Proposed farm bill may mean double-digit cut in cotton farm income.

As work in Washington continues on the 2007 Farm Bill, a new analysis on the effects of the proposed legislation reveals that cotton farmers will take a significant whack to the wallet if the law were to go forward as written.

Researchers with Texas Tech University's Cotton Economics Research Institute said today that net farm income for cotton would fall a stunning 15 percent during the first year under the new law, and continue to dip the next four, averaging an 11 percent decline over the five years.

According to their model, some of the major effects of the proposed 2007 Farm Bill would be:

- Direct payments, which is the amount cotton farmers get whether they plant cotton or not, would go up.
- The loan rate, or more simply put the cotton market's economic floor, would go down.
- Changes to the counter-cyclical program will result in lower payments.
- And, finally, the overall market price for cotton would go up.

The market price for U.S. cotton is expected to rise because of a reduction in overall acreage planted due to a loss of government support. In addition, the returns of other competing crops are predicted to be relatively high.

"Acreage declines are marginal, about 2.5 percent over a five year period," said Samarendu Mohanty, an agricultural economist and associate director of the institute. "There's a big shift initially, and then smaller as farmers adapt."

The question is whether market prices will go up enough to compensate for the losses in government support for cotton, and the answer is no.

"We lose more in government support than we gain in increased market returns, and so cotton farmers are worse off by 11 percent over a five year period," said Mark Welch, a research scientist with the Cotton Economics Research Institute.

The Texas Tech World Fiber Model baseline projections are based on assumptions of normal weather patterns and current farm policies, along with estimated economic fundamentals such as population and income growth, and prices for crops that would compete with cotton.

Among the factors not included in the researchers' model were unknown variables such as payment limitations and extra assistance to individuals just starting out in farming.

The Tech researchers said the world price for cotton during this five-year period will rise slightly, in part due to the small drop in U.S. production. If U.S. production acreage falls – even slightly – it will have ripple effect on the world market. Today, the U.S. is the second largest producer of cotton at 19 percent.

The Cotton Economics Research Institute provides cotton economic analysis for policy makers and other interested in agricultural economy. The group conducts economic research on all aspects of cotton production, marketing, trade and processing.

Texas Tech Signs Major Agreement with Vietnamese Government

Officials from Texas Tech University and representatives from the government of the Socialist Republic of Vietnam will sign an historic agreement at 4 p.m. today (April 24) in the Board of Regents Committee Room in the Administration Building on the Texas Tech University campus.

The agreement will create a joint graduate degree program for Vietnamese students attending the Institute for International Relations in Hanoi, Vietnam, and the Graduate School at Texas Tech. The Institute trains all of Vietnam's future diplomats and is similar to the United States State Department's Foreign Service Institute.

The joint degree program, more than two years in the making, will allow qualified Vietnamese students to receive their first year of graduate study in Hanoi followed by a year at Texas Tech. Vietnamese students who successfully complete the rigorous program will receive a master of arts degree in Interdisciplinary Studies with a focus on International Relations and American Studies from Texas Tech.

The agreement is historic as it is the first joint degree program approved by the Vietnamese Ministry of Education and Training. While Vietnamese students have long been attending courses of study in the United States, this is the first program where students will receive part of their graduate training in both countries culminating in an American degree.

Dr. John Borrelli, dean of Texas Tech's Graduate School, along with staff at the Vietnam Center at Texas Tech, has been working on the details of the program with representatives in Vietnam to ensure it conforms to the highest standards of education in both nations. The final discussion and successful conclusion of these negotiations took place on Monday (April 23) during meetings with Texas Tech President Jon Whitmore and Provost William Marcy.

Three Texas Tech Professors Honored with CAREER Awards

Researchers honored with prestigious National Science Foundation Award.

The National Science Foundation (NSF) honored three Texas Tech University professors with the prestigious CAREER award.

The award is a highly competitive honor reserved for outstanding scientists and engineers who, early in their careers, show an exceptional commitment to research and education.

"That Texas Tech received three of these prestigious awards is a testament to the quality of our faculty," said Kathleen Harris, senior associate vice president for research. "These awards will allow the three recipients to build foundations for long and successful research careers. The awards also will directly benefit our students because each of these projects integrates research and education."

Lenore Dai

Lenore Dai, assistant professor of chemical engineering, will receive \$400,000 during five years to research her proposal, "CAREER: Heterogeneous and Competitive Self-assembly at Liquid-Liquid Interfaces."

Dai's research involves the study of solid-stabilized emulsions – one liquid dispersed into another, then stabilized by solid particles. In the past, most emulsions were stabilized using chemicals called surfactants. Dai also will establish research-related open-ended projects in existing courses, establish a new summer program to broaden the participation of minority groups and promote technology transfer.

Jorge A. Morales

Jorge A. Morales, assistant professor of chemistry, will receive \$570,000 throughout five years for his proposal, "Building a Direct Dynamics with Coherent States."

Morales' research involves inventing and developing a new theory to computationally describe chemical reactions. The theory is then coded into a computer program to perform simulations of chemical reactions. Morales will use the proposal funds to buy more computers to conduct the research and to support undergraduate and post-doctoral students developing the project.

Brandon Weeks

Brandon Weeks, assistant professor of chemical engineering, will receive \$400,000 during five years for his research proposal, "Understanding Nanoscale Properties of Energetic Materials."

Weeks will study the properties of energetic materials at the nanometer scale – a level invisible to the naked eye – then use the findings on the macro-level to develop new energetic materials. Included in Weeks' proposal were plans to participate in an undergraduate-mentoring program, work with a seventh-grade teacher at Atkins Junior High School to introduce math and science activities, develop courses and a minor in energetic materials, and to participate in continuing-education activities. The goal is to cultivate students' curiosity and encourage them to pursue education in science and engineering fields.

Newest Addition to Texas Tech Public Art Collection Takes on Acoustical Mysteries

The newest addition to Texas Tech University's Public Art Collection is titled "Comma" by artist Po Shu Wang. It was commissioned by Texas Tech in September 2005.

The shining stainless steel sphere was installed on April 17 between the Student Union Building and the Library.

Wang's sculpture encourages passers by to interact with and muse on natural phenomena, such as what sounds the movement of the earth's crusts makes or what sounds the sun makes.

"Although not always audible, the natural world is full of vibrations that can be measured as sounds. In other words, the world 'hums' its own tune. This is true of the planets and stars, as well as the molecules and atoms of our DNA," Wang said.

The sun, like Wang's sculpture, is a spherical resonator. Acoustical waves bounce from one side of the sun to the other, causing its surface to oscillate and make a sound.

By pushing the knob attached to his sculpture at Texas Tech, viewers can, in essence, sample the sound of the sun. This is made possible because of two specially tuned bronze bells inside the sphere.

The sphere contains two specially made bells, tuned at slightly different pitches. The first is tuned to 1782.6 Hz, which is the musical tonal center of the sun. The second is tuned at one Comma interval from the first.

The Comma, a musical acoustical phenomenon, is a very small interval between two enharmonic notes. This minute difference in pitch has upset listeners' natural instinctive sensibility for harmonics throughout history and across cultures.

"In natural harmonics, the notes should sound the same over many octives," said Wang. "For example a high C and a low C are the same note, but when you hear them together, you know instinctively that it's different."

It's a fluke that has bothered musicians for centuries.

"All music tradition has been bothered by the Comma," "People from the Middle Ages to the Renaissance, have called it kind of an evil philosophically because it upsets the otherwise natural harmony."

Pythagoras of ancient Greece is thought to have been the first to explore the phenomenon mathematically, and the Comma was eventually neutralized through Johann Sebastian Bach's promotion of the equal temperament tuning system.

Bach split the Comma among the 12 notes of an octave so that we can more easily ignore the even smaller mismatches. The Temperament Tuning System is in use today.

Po Shu Wang grew up in Hong Kong. The artist received classical training in sculpture at the Academy of Fine Arts in Rome. Yet, today, the artist aims to blend art with science.

His public works can be found in numerous cities in the United States and abroad, including the Saatchi and Saatchi Museum of London, Oregon State University's Kelley Engineering Center, Oakland's Chabot Space and Science Center, the Bay Area Discovery Museum, the Anchorage Museum of History, and many others.

The bell on the east side produces the sound of the sun's sound waves. The west-side bell is tuned one comma interval from the first. The comma is a naturally occurring fluke of physics that causes the sound to be different.

The Comma is one of 84 pieces of public art displayed across the Texas Tech university campus. Texas Tech has been ranked one of the top 10 university public art collections in the country.

Texas Tech Student Wins Academic Freedom Scholarship Essay Contest

Eric Braden, a Natural History and Humanities/English Major in the Honors College from Katy, is the winner of the Texas Tech University 2007 Academic Freedom Scholarship Essay Contest is Eric Braden.

Braden's 1,000 word essay on "The Role and Importance of Academic Freedom in the University" referred to a 1903 controversy at Duke University, then called Trinity College. Professor John Spencer who wrote an article that in part criticized the Democratic Party in the South for its racist politics. The school's president defended the professor, even though he disagreed with his views. After a long meeting of Trinity's Board of Trustees decided not to request Mr. Bassett's resignation.

Braden, who is also a cartoonist for the Daily Toreador, will use \$1,000 scholarship to help defray expenses while studying in Kenya, Africa, in the fall. He plans to graduate from Texas Tech in Dec. 2008.

The scholarship is given by the Texas Tech Faculty Legal Action Association, which was formed in 1985-1986 school year to fight a proposed change to the university's tenure system. When the proposal was later modified, the scholarship was created with money originally contributed by faculty members to a fund to possibly challenge the original proposal in the courts.
