LUBBOCK--Texas Tech regents will meet in regular session Friday (May 11) and take under consideration new degree programs in biochemistry, geography and nursing; revision of undergraduate admission standards; a revision of the university tenure policy; and student fee schedules.

Other business of the regents will be consideration of construction contract awards for: a laboratory theater addition to the University Theatre; completion of the second level of the Amarillo Regional Academic Health Center; a new parking lot for the Texas Tech University Health Sciences Center in Lubbock; a new sewage effluent storage reservoir on the western portion of the Lubbock campus; and replacement of air washer units in the Bledsoe-Gordon Residence Halls kitchen.

The board will consider a contract with Odessa's Medical Center Hospital providing for a maximum of seven residency training positions, five first year and two second year positions. These would be the first residency positions in the Permian Basin for the Texas Tech Health Sciences Center.

Degree programs the regents will consider include a proposed doctor of nursing science and master of science in nursing; a master of arts with a major in geography; and bachelor of science and bachelor of arts degrees each with a major in biochemistry.

Undergraduate admission standards provide for both unconditional and conditional admissions. In addition to acceptable scores on either the Scholastic Aptitude Test (SAT) or the American College Test (ACT), students would be required to have four units of high school English, three of mathematics, 2.5 of social science, two of science --biology, chemistry, geology or physics, and 3.5 units of electives. -more-

REGENTS/ADD ONE

Colleges of Engineering and Business Administration require additional units in some areas. The standards "strongly recommend" at least two elective units chosen from computer science, economics, foreign language, mathematics beyond the beginning algebra course, public speaking and debate, science and social science.

Students admitted conditionally may be expected to take specific courses during the first two semesters of enrollment, must follow prescribed advising procedures and seek counseling assistance from academic deans. Summer sessions for these students, preceding enrollment in a regular semester, are recommended.

The proposed admission standards would not, if approved, go into effect until fall 1985.

The tenure policy to be considered was developed by an ad hoc committee of the Board of Regents, working with Texas Tech President Lauro F. Cavazos.

Regents will review a student fee schedule that calls for a decrease in the maximum student service fee from \$60 to \$51; creation of a medical service fee of \$20 per semester; and a 6.4 percent increase in residence hall rates. The proposed housing fee scale seeks the lowest increase in five years and would leave Texas Tech at the lower end of the scale among Southwestern universities of comparable size.

LUBBOCK--Texas Tech regents Friday (May 11) approved new degree programs in biochemistry, geography and nursing; stiffer standards for unconditional admission to the university, and changes in student fee schedules.

In regard to a proposed tenure policy, originally on the board's agenda, regents acquiesced in a request of its ad hoc Committee on Tenure Policy to delay consideration until fall. The committee's suggestion was based on a request of the university's Academic Counsel -- comprised of deans of colleges and schools, which was forwarded to the committee with the recommendation for acceptance by Texas Tech President Lauro F. Cavazos.

The board approved a contract with the Medical Center Hospital in Odessa, providing for a maximum of seven residency training positions -- the first in the Permian Basin for the Texas Tech University Health Sciences Center. The resident physicians are specializing in family practice.

Degree programs approved by the requests include doctor of nursing science and master of science in nursing; a master of arts with a major in geography, and bachelor of science and bachelor of arts degrees, each with a major in biochemistry. The programs will be submitted to the Coordinating Board, Texas College and University System, for its approval.

REGENTS/ADD ONE

New admission standards, to go into effect in the fall of 1985, provide for both unconditional and conditional admissions. Students conditionally admitted would be required to take certain courses and accept counseling services to help assure their academic success at the university.

In regard to student fees, the addition of a medical service fee of \$20 allowed reduction in regular student fees. University students, however, will pay a total of \$11 more in fees, used to pay for student services. The fee schedule was recommended to the regents by a student advisory group.
