My dear Captain Carter:

I have received notice of your appointment as a member of the Commission for the Inspection of the Battlefields and Surrender Grounds of the old Appomattox Courthouse, Virginia, under the Act of Congress approved February 25, 1926.

1. This is in reference to your correspondence with the Commanding General, 8th Corps Area, Fort Sam Houston, requesting copies of reports made by General R. S. MacKenzie, colonel, 4th Cavalry, on his Indian campaigns in Texas in 1874 and 1875. The Commanding General, 8th Corps Area, transmitted your letter to this office stating that the retained records of the old Department of Texas were boxed and sent to this office January 26, 1916, there being many boxes of them.

- 2. The reports of General MacKenzie for 1874 and 1875 were probably received here in 1916, but they have never been unboxed, arranged or indexed; this by reason of the exigencies of the Mexican Border Disturbance the World War and the continued inadequate clerical force of the office since the time when the records in question were shipped to the War Department.
- 3. An attempt has been made recently to locate the box containing General MacKenzie's reports of 1874-1875, but without success. To find those reports would possibly involve an examination of the contents of all of the boxes, which is impracticable at the present time by reason of the shortage of the clerical force here.
- 4. I find on file here <u>copies</u> of reports made by General MacKenzie dated as follows: May 23,1873 (3 reports) and November 24,1874, which were sent by General Augur in 1873 and 1874. But I have no assurance that these include all reports made by General MacKenzie in those years. Copies of any of these can be made and sent you upon request.


