Enclosed please find two articles recently published. The first shows that Latino newspapers reach 65% more readers per copy than daily newspapers. This study was done by the National Association of Hispanic Publication. The study mentioned in the article was published exclu-  $\vee$ sively by El Editor here in Lubbock.

The second articles gives the results of a local marketing survey conducted by Banker's Economic Services of Texas. The survey determined that of all Hispanic people who read a minority newspaper in Lubbock, 61% read El Editor. The remaining 39% was spread between the Lubbock Digest and the West Texas Hispanic News.

I hope thes information will prove helpful and you will show your clients the effectiveness of El Editor to reach the Hispanic market.
