Minutes

Board of Regents Meeting August 20, 1971

M154. The Board of Regents of Texas Tech University met in regular session on Friday, August 20, 1971, at 3:30 p.m. in the Board Room on the Texas Tech University campus. The following Regents were present: Frank Junell, Chairman, R. Trent Campbell, Bill Collins, Clint Formby, Dr. John Hinchey, Field Scovell, and Judson F. Williams. Regents absent were: Waggoner Carr, Vice Chairman, and Charles G. Scruggs. University officials and staff present were: Dr. Grover E. Murray, President; Dr. Glenn E. Barnett, Executive Vice President; Dr. S. M. Kennedy, Vice President for Academic Affairs; Leo Ells, Comptroller and Treasurer; Dr. John Buesseler, Vice President for Health Affairs; Bill J. Parsley, Vice President for Public Affairs; Dr. Orlo Childs, Vice President for Research and Special Programs; Mrs. Jean K. Baker, Assistant to the President; Clyde Morganti, Special Assistant to the President; Mrs. Freda Pierce, Secretary of the Board; Dr. Owen L. Caskey, Associate Vice President for Academic Affairs; Fred J. Wehmeyer, Assistant Vice President for Administrative Services; Lewis N. Jones, Dean of Students; Carlton Dodson, Resident Counsel; Norman Igo, Director of New Construction; B. K. M155. Chairman Junell called the meeting to order, and asked Dr. S. M. Kennedy, Vice President for Academic Affairs, to give the invocation.

M156. Upon motion made by Dr. Hinchey, seconded by Dr. Williams, the Board by unanimous vote approved the minutes of the regular Board meeting of May 14, 1971, and the special meeting of July 9, 1971.

M157. Upon motion made by Mr. Collins, seconded by Mr. Campbell, the Board by unanimous vote approved administrative action not previously acted upon by the Board, Items 10a. through 13n.

M158. Dr. Williams gave the report for the Academic and Student Affairs Committee. The next seven items (M159 through M165) are a record of the official action on the committee recommendations.

M159. Upon motion made by Dr. Williams, seconded by Mr. Formby, the Board by unanimous vote approved the travel regulations and absence reports as attached; Attachment No. 1.

M160. Upon motion made by Dr. Williams, seconded by Mr. Collins, the Board by unanimous vote approved the following policy on emeritus appointments:

(1) The title "emeritus" shall be conferred as a recognition for long and faithful service, or for very distinguished service to the institution.

(2) Members of the faculty with rank of professor or associate professor shall at retirement be given emeritus appointments, provided they shall have completed at least ten years of service at Texas Tech University, or shall have been recommended on the basis of "very distinguished service." In the latter event, the advice of the Executive Committee of the Faculty Council shall be sought by the President.

(3) Administrative officers in major positions shall at the time of retirement from administrative duties be considered for emeritus appointments.

(4) Emeritus appointment shall be strictly honorary and without stipend.

(5) Each such appointment shall be subject to approval by the Board of Regents upon recommendation by the President.

M161. Upon motion made by Dr. Williams, seconded by Mr. Formby, the Board by unanimous vote approved that changes in rank from instructor to assistant professor be done administratively. (This was in lieu of approving rank changes for Dr. Marilyn G. Phelan and Dr. Charles W. Keller.)

M162. Upon motion made by Dr. Williams, seconded by Mr. Formby, the Board by unanimous vote approved a Resolution finding the services of Dr. Vincent P. Luchsinger to be of benefit to the State of Texas as Consultant to the Scientific and Management Advisory Committee of the Department of the Army Computer Systems Command. The Resolution is attached and made a part of the Minutes; Attachment No. 2.

M163. Upon motion made by Dr. Williams, seconded by Mr. Campbell, the Board by unanimous vote approved the reorganization of the College of Business Administration with the elimination of academic departments, effective at once. Dr. Murray commented that this action would be submitted to the Coordinating Board for approval.

M164. Upon motion made by Dr. Williams, seconded by Dr. Hinchey, the Board by unanimous vote approved that Dr. Warren S. Walker, Professor of English, be designated a Horn Professor effective August 20, 1971. Dr. Williams stated that Dr. Walker is a distinguished scholar with highly diversified academic interests. He has achieved distinction as a foremost authority on the works of James Fenimore Cooper. He has achieved equal distinction in the area of folklore, particularly that of Turkey. His bibliographical activities in the area of the short story are widely known and used. His contributions to his students have been widely recognized and eminently successful. His sound judgment in the area of academic development and administration has made him a valuable professional colleague.

M165. Upon motion made by Dr. Williams, seconded by Mr. Formby, the Board by unanimous vote approved the designation of the following units under its jurisdiction to be known as: (1) Texas Tech University. (2) Texas Tech University Center at Amarillo. (This title is a change in the designation of what was known variously as Pantech, Pantex, Texas Tech Research Center, etc.) (3) Texas Tech University Center at Junction. (This title is a designation of the facilities to be acquired on September 1, 1971, in Junction.)

M166. Mr. Collins gave the report of the Finance Committee. The next four items (M167 through M170) are a record of the official action on the committee recommendations.

M167. Upon motion made by Mr. Collins, seconded by Dr. Williams, the Board by unanimous vote approved the Financial Plan of the University as duly submitted with such approval subject to rules and regulations duly determined to be applicable to State Agencies.

M168. Upon motion made by Mr. Collins, seconded by Dr. Hinchey, the Board by unanimous vote approved that the administration be and is hereby authorized to request bids for the depository of funds of the University for the biennium beginning September 1, 1971, and ending August 31, 1973, from qualified banks in Lubbock.

Further resolved that such requests for bids shall specify a response in terms of a fixed rate of the biennium as well as a rate varying with the most recent average return to investors on the weekly auction of 26-week and 13-week U. S. Treasury Bills. All bids shall be subject to final approval and acceptance by the Board of Regents of the University.

M169. Upon motion made by Mr. Collins, seconded by Mr. Formby, the Board by unanimous vote approved that the University be authorized to extend its present depository agreement from its present expiration date of August 31, 1971, until approval of an agreement for the biennium beginning September 1, 1971.

M170. Upon motion made by Mr. Collins, seconded by Dr. Hinchey, the Board by unanimous vote approved that the Chairman of the Board of Regents be hereby authorized to sign and execute an interagency contract with Texas Tech University School of Medicine concerning the provision of support in planning, construction, and operation of the Medical School for submission to the Board of Control of the State of Texas for approval.

M171. Mr. Scovell reported for the Athletic Affairs Committee. Upon motion made by Mr. Scovell, seconded by Mr. Collins, the Board by unanimous vote adopted the following resolution:

RESOLVED that the Jones Stadium Athletic Complex is owned and maintained by Texas Tech University for the primary use and benefit of the intercollegiate and intramural athletic program of the University, allied non-University athletic activities consistent with such programs and official academic events of the University. The use of such stadium facilities shall be limited to the above mentioned athletic activities and events consistent with the University's programs and official academic events of the University. The use of such facilities for other non-athletic activities and non-University events is considered inconsistent with its purpose and intended use and will not be permitted by the University.

M172. Mr. Campbell gave the report of the Campus and Building Committee. Upon motion made by Mr. Campbell, seconded by Dr. Hinchey, the Board by unanimous vote approved that June 30, 1971, be recorded as the acceptance date for the remodeling of Bledsoe Hall. Mr. Junell asked Dr. Barnett about dormitory reservations for the fall, and Dr. Barnett responded that we are essentially full. He further commented that renovation of some of the older residence halls is being planned, and that one wing of Gaston will probably be made into a semiapartment style living complex; also, that we are looking toward full occupancy of the residence halls this year, and next year.

M173. Mr. Junell called upon Dr. Murray for his report, and it is recorded below:

"Last year we appointed a Mass Communications Advisory Committee composed of outstanding men in the news media through the state and nation. They visited this campus on three occasions and have made a very fine analysis of the situation on this campus involving Channel 5, our television station, and KTXT-FM. Each of you has received a copy, and we should be moving forward to implement some of their recommendations in the near future. I wanted to commend publicly the actions of the subcommittee on telecommunications and the part Mr. Formby has played in this.

"You would also like to know of the creation of a Textile Research Advisory Council. Formal appointment of these individuals will include outstanding individuals in the field of cotton and cotton fibers, also the other natural fibers, wool and mohair. They will assist in developing new uses of textiles, natural fibers, formulation of policy in regard to textile research activities.

"In the event you did not read the morning paper, I have the misfortune of reporting to you the death of Commissioner of Agriculture John C. White's son in an automobile accident on his returning to school yesterday. Since he's a graduate of this institution, I thought the individual Board members would like to know of this.

"Dr. W. W. Frye, who has been serving as a special consultant to the School of Medicine, was hospitalized two weeks ago with a minor heart involvement and some other complications. He is doing extremely well and is to return to his own apartment sometime today. When I spoke to him day before yesterday, he was to be back to work within the next two weeks.

"Commencement is set for 7:15 p.m. tomorrow night. Those of you who can attend, we would appreciate it. Dr. Jack Williams, President of Texas A & M University, will be our speaker.

"The last item is to call your attention to the retirement this month of a dean who currently has the longest service at this institution, Dr. Willa Vaughn Tinsley. I would like to express my own appreciation of the service she has

given to this institution. I am sorry she is not here to hear these words. I have told her personally, and I think words from you gentlemen would be appreciated."

Upon the request of Dr. Hinchey, Dr. Murray read the last paragraph of the report submitted by Wendell Mayes, Jr., Chairman of the Mass Communications Advisory Committee, for the Telecommunications Subcommittee as follows:

"In a world torn apart by misunderstandings, militant minorities, generation gaps, and all of the other divisive elements of our society, the solution to so many of our problems must lie within the field of mass communications. Telecommunications occupies a more important place in the field of mass communications every year, and there is no evidence that this trend will be reversed. There exists in the Southwest a strong need for a university to take the leadership toward establishing a truly excellent telecommunications program to educate and train young people so that they can meet the problems and cope with the responsibilities they will face in this important calling. No university in the Southwest offers this type program at this time. The committee feels this presents a challenge to Texas Tech, a challenge which the University should accept."

Mr. Junell requested that an appropriate message be worded to Commissioner White on behalf of the Board of Regents, and that members of the Textile Research Advisory Council who are to be appointed be advised of our intense delight in their acceptance of this assignment and our interest in working with them. Also, that an appropriate resolution commending Dean Tinsley be prepared for formal adoption at the next meeting of the Board.

M174. Upon motion made by Dr. Williams, with Mr. Formby acting as Chairman, the Board elected by acclamation Mr. Frank Junell, Chairman of the Board, Mr. Bill Collins, Vice Chairman of the Board, and Mrs. Freda Pierce, Secretary of the Board, for the coming year, September 1, 1971, through August 31, 1972.

M175. Mr. Junell called attention to official recognition of the honor that came to our Ex-Students Association in Washington. He asked Dr. Barnett and Wayne James, Executive Director of the Ex-Students Association, to give a report. Dr. Barnett commented that it was most significant that among all the honors given to university-size alumni associations, they were selected for the over-all program. He lauded the Executive Director as he was singled out in the awards presentation, and gave a little presentation of how you get it done. Mr. James said that it has involved many thousands of loyal members of the faculty, staff, ex-students, and the student body. He expressed his appreciation to all.

M176. There being no further business, the meeting adjourned.

TRAVEL REGULATIONS AND ABSENCE REPORTS

Under the provisions of the present law institutions of higher education are required to develop report techniques for recording authorized and unauthorized absence of faculty.

All requests from faculty for permission to be absent from the campus, primarily for official travel, are channeled through the office of the dean of the instructional school or college in which the faculty member holds his academic rank. The dean is to maintain a record of all requests for absences on the part of those faculty and staff for whom he has responsibilities. The record is to be in the form of log books in which the time, purpose and funding, if any, are to be noted.

Prior approval of travel requests is prerequisite to the submission of claims for reimbursement.

Under the authority granted by the Board of Regents, the dean of the college or school is authorized to approve for the President travel requests in the following categories:

- 1. Travel within the state with reimbursement from state-appropriated funds.
- Travel within the state with reimbursement from non-appropriated funds.
- 3. Travel within the state without reimbursement.
- 4. Travel within the contiguous United States with reimbursement from state-appropriated funds.
- 5. Travel within the contiguous United States with reimbursement from non-appropriated funds.
- 6. Travel within the contiguous United States without reimbursement.

The approval of the President or his authorized representative is required for travel outside the contiguous United States, but including Hawaii, Alaska, U. S. possessions, Canada or Mexico.

Travel to regions of the world other than indicated above is approved specifically only under a process outlined in the following statute:

Art. 6823a. Travel Regulations Act of 1959

Advanced approval of governor; travel outside United States

Sec. 5. Any travel connected with official business of the state for which reimbursement for travel expenses incurred is claimed, with the exception of travel to, in, and from the several states, United States possessions, Mexico, and Canada, must have the advance written approval of the Governor. Blanket authority by the Governor may be given the Department of Public Safety to law enforcement personnel. Sec. 5 amended by Acts 1967, 60th Leg., p. 1111, ch. 492, para. 1, eff. Aug. 28, 1967.

- 2. The service of Dr. Vincent P. Luchsinger as Consultant to the Scientific and Management Advisory Committee does not conflict with his position of employment at Texas Tech University.
- 3. He shall serve with pay at the Civil Service rate of GS-18 and receive remuneration at the rate of \$138.49 a day, plus a per diem of \$25.00 a day with travel reimbursement.

MEMORANDUM OF AGREEMENT

THIS AGREEMENT, made and entered into by and between Coca-Cola Bottling Company and B & M Vending Company, hereinafter referred to as the "Vendor", and Texas Tech University, located at Lubbock, Texas, hereinafter called the "University".

WHEREAS, the University is desirous of making available and the Vendor is desirous of supplying requirement of soft drinks, candy, peanuts, cookies, chips, chewing gum, etc., for the purpose of sale on the premises of the University located at Lubbock, Texas;

NOW, THEREFORE, in consideration of the premises and promises herein contained, the parties agree that:

- 1. The Vendor will install, operate and service on the premises of the University a minimum of one hundred fifty (150) dry bottle soft drink vending machines and a minimum of fifteen (15) nine-ounce cup and ice machines for Coca-Cola and Dr. Pepper. All machines must be adequate in size and must be new or a relatively recent model so as to compare favorably in appearance and performance with the best machines available. Dry bottle machines must be equipped with wire racks for empty bottles if requested by the University. The University will require some machines to match those for other products.
- 2. The Vendor agrees to sell the ten-ounce drink in the residence halls. The six-ounce drink will be sold by the Vendor at all other locations. The nine-ounce cup and ice drink will be sold in the Wiggins Complex, Administration Building, Business Administration Building, Architecture-Art Buildings and at other locations on campus designated by the University.
- 3. The Vendor will install on the premises of the University at locations specified by the University a minimum of one hundred (100) candy, peanut, cookies, chips and chewing gum vending machines. All machines installed must be of the nickel (5¢) and ten cent (10¢) variety, adequate in size, and must be new or a relatively recent model so as to compare favorably in appearance and performance with the best machines available. The University will require some machines to match those for other

products. All items sold must be approved by the University in advance of sale. By mutual consent, additional machines over and above the minimum specified may be installed.

- 4. Subject to the conditions outlined in Paragraph 12 hereof, title to the vending machines shall remain the property of the Vendor. The Vendor shall install the machines in conformity with all federal, state and local building, health and other applicable laws. All electrical outlets required shall be installed by the University, and the installation charges shall be paid for at cost by the Vendor. Upon the completion of the installation of these services, the title and responsibility for proper operation of these services shall rest with the University. The University will furnish to the Vendor, without cost, electrical energy and water.
- 5. The Vendor shall have the right to enter upon the premises of the University at all reasonable times for the purpose of servicing and inspecting said machines and for removal of such machines upon the termination of this agreement. The Vendor shall service the machines as many times per day as necessary to keep the vending machines properly supplied with soft drinks and in good working order. The Vendor shall be required to keep the vending machines and the areas adjacent thereto in neat and sanitary condition at all times. The Vendor is to service the machines with the least amount of noise feasible and to protect University property during such service. Determination of "the least amount of noise feasible" shall be at the discretion of the University.

The machines in the women's residence halls will be serviced from 10 a.m. to 4 p.m. or at other times acceptable to the University.

- 6. All soft drinks and other items supplied by the Vendor shall conform in all respects to all state and national laws relating to the adulteration of food and drink and, in all respects, shall be suitable for human consumption; and the Vendor will indemnify the University for all or any damage suffered by it for breach suffered by such warranty.
- 7. The Vendor will indemnify the University against any damages or claims arising from the negligence of the Vendor, its agents and employees. In addition, the Vendor will be required to carry property damage and public liability insurance in appropriate amounts as agreed with the University.
 - 8. The University will promptly notify the Vendor in writing of any claims made against it arising out of a breach of said warranty, and such claim shall be handled by the Vendor. In the event of a suit on a claim, the University shall promptly forward to the Vendor every summons or other process. The Vendor shall have a right to defend, adjust or settle any such claims. No expense shall be incurred and no settlement shall be attempted without the Vendor's written consent.

- 9. The University reserves the right to have installed other vending machines such as coffee, soup, and sandwich, anywhere on the campus it so desires, including educational buildings.
- 10. The vending concession herein granted to the Vendor shall be exclusive on the campus of Texas Tech University at Lubbock, Texas, except Article 9 above and with the following exceptions, which are locations in which the concession herein granted shall not apply: University Center, Stadium Game Sales and Bookstore. During organized events, clubs, with advance approval from the University administration, may empty (buy out) the machines and sell the products for ten cents (10¢) or fifteen cents (15¢) each. The Vendor will stock the machines in the usual manner only. The Vendor may not allow credit for the return of more bottles than the club buys. This is the only known way to protect the contract and still allow the clubs to have some income during the show or event. The clubs may not turn the machines to the walls or block them off without first emptying them. Any violations may cause the termination of the privilege for the clubs.
- 11. All soft drinks shall be sold for ten cents (10¢) each. The University reserves the right to install vending machines at any location where the Vendor will not agree to place a vending machine. In view of the considerations herein contained, the University will receive 31% of gross sales of bottle machines, less two cents (2¢) for each bottle missing or broken and fifteen cents (15¢) for each shell missing or broken. The University will receive 40% of the gross sales of the cup and ice machines. Also, the University will receive fifteen percent (15%) of the gross receipts of candy, peanuts, cookies, chips, chewing gum, etc. The Vendor will guarantee \$112,915.75 to the University from the vending machines for the period September 1, 1971 to August 31, 1972 and \$124,801.61 for the period September 1, 1972 to August 25, 1973.
- 12. Settlement shall be made to the University on a monthly basis. The Vendor agrees to submit monthly statements showing proper accounting details in accordance with this Agreement within ten (10) days after the end of the month. Simultaneously with the submission of a sworn statement, the Vendor will make payment to the University. The Vendor shall render such reports in a manner acceptable to the University and shall further permit the University to make any reasonable auditing check which it desires of the operation. The amount of the minimum annual guarantee shall accrue and be payable one-twelfth each month, with excess payments in any month over and above the minimum guarantee to be credited against the accumulated minimum guarantee. The University shall retain a lien on the machines, pending payment of the guarantee or any balance due under this Agreement.

The vending concession herein granted to the Vendor shall be exclusive for the Residence Halls on the campus of Texas Tech University at Lubbock, Texas, except for the washers and dryers installed in the women's residence halls. The University reserves the right to operate the finished laundry and dry cleaning services now established in the men's residence halls.
- 8. The price to be charged on the washers will be as follows: 25¢ per 12 pound load. The price for dryers will be 10¢ per 12 pound load per 30 minutes. The University reserves the right to install washers and dryers at any location where the Vendor will not agree to place machines. In view of the consideration herein contained for the period of September 1, 1971 through August 31, 1972, the Vendor will pay the University 40 percent of the gross sales or an annual guarantee of \$9,000.00, whichever is greater, on an estimated gross sales volume of \$22,500.00. Should the gross sales exceed the Vendor's estimate shown on his bid, the Vendor will pay the University 40 percent of the guaranteed amount. In view of the considerations herein contained for the period of september 1, 1972 through August 25, 1973, the Vendor will pay to the

University 40 percent of the gross sales or an annual guarantee of \$9,000.00, whichever is greater, on an estimated gross sales volume of \$22,500.00. Should the gross sales exceed the Vendor's estimate shown on his bid, the Vendor will pay the University 40 percent of the excess in addition to the guaranteed amount.

AGREEMENT

This Agreement, made and entered into this ______ day of _____, 1971, by and between LUBBOCK TRANSIT CORP., (hereinafter referred to as the "Company"), and THE BOARD OF REGENTS OF TEXAS TECH UNIVERSITY at Lubbock, Texas (hereinafter referred to as the "University"):

WITNESSETH:

WHEREAS, the parties hereto are aware of the traffic and parking problems on the campus of the University as it relates to the expanding campus and the increasing number of students, staff, and faculty of the University; and

WHEREAS, the above-named parties are desirous of relieving some of the traffic congestion and expediting transit between areas in and immediately adjacent to said University campus; and

WHEREAS, this Agreement embodies the intention and resolution of the above-named parties;

NOW, THEREFORE, WITNESSETH THIS AGREEMENT:

I.

Term

It is agreed and understood by and between the parties hereto that a University bus service utilizing eight (8) buses will be provided by Company during a period beginning with August 23, 1971, and terminating on August 19, 1972, provided, however, that either Company or University may terminate said bus service upon Thirty (30) days' written notice delivered to the other by registered mail.

II.

Bus Operations

With respect to bus operations, Company and University agree that the following conditions shall apply:

A. Company will furnish buses having a seating capacity (Manufacture rated) of not less than 33 with driver operated front and side doors. It is agreed that certain seats may be removed from said buses to facilitate the on and off necessary to accommodate the high volume of passenger turn over; except that all buses will provide seats for not less than 26 passengers. The Company will provide the necessary personnel to service the route or routes

designated by the University during the period specified in the preceding Paragraph I of this Agreement. The number of buses and the operating periods will be subject to continuous review, and the University will advise Company with regard to its needs and with respect to any changes in the number of buses and/or operating periods; subject to equipment availability, said changes shall be instituted by Company within five (5) days after receipt of written notice from University. Initial service commencing on <u>August 25</u>, 1971, shall be as indicated on Exhibit "A", attached hereto and made a part hereof.

- B. In the event that it develops during any portion of the period first specified in Paragraph I hereinabove, that a change in or extension of a route, or a new route, is necessary or desirable, Company shall make such change or extensions of a route or routes, or add a new route, upon University's request. The charges to be made by Company therefor shall be upon the basis, and shall be subject to the conditions and limitations, as are set forth in Subparagraph E of this Paragraph hereinbelow. Also in the event it develops during said period that an additional bus or buses are required in order to meet the demand for said bus service during any operating period or periods, Company, if it is able to provide same, at the University's written request, shall provide such additional bus or buses for said service during said operating period or periods upon the same basis, as is set forth hereinabove. University shall have the right to terminate any such changes, extensions, or new routes upon five (5) days' written notice to the Company.
- C. Buses shall stop to receive or discharge the passengers entitled to use, and using, bus service at such points as shall be agreed upon from time to time during said period, between Company and University, and University will identify the points at which stops will be made by said buses. Acceptable markers will be provided by the Company.
- D. Company will exercise due diligence to adhere to the time schedules hereinabove referred to, but minor deviations therefrom due to variations in traffic, weather or load conditions shall not be deemed to be a default hereunder.
- E. Company shall not collect fares from its passengers, but shall charge University for providing said bus service the sum of <u>six dollars and seventy-five cents (§6.75)</u> per hour for each bus used in said service. Company shall submit an invoice at the end of each month showing the amount due for service provided. Contemporaneously therewith, Company will present University with a billing at the close of operations on the last day of each month, such bills to be paid as promptly as possible in the usual course of University business. The Company will provide income and expense statement at the end of contract period.

Supplemental Bus Service

In addition to the scheduled bus service over specified routes as provided for in Paragraph II hereinabove, Company shall furnish such other supplemental service, if equipment is available, for the transportation of special groups as may be designated by University. Such supplemental service shall be furnished by Company at any time during the hours from 7:00 a.m. to 11:30 p.m., upon receipt of three (3) days' written notice from University. Company will charge University for providing said supplemental service the sum of <u>six dollars and seventy-five cents (\$6.75)</u> per hour, for a minimum of three hours, for each bus used in said service. Billing periods and reports of operation shall be submitted in accordance with the provisions of Subparagraph E of Paragraph II hereinabove, and subject to Paragraph II, Subparagraphs A and B.

IV.

Publicity

University will undertake and conduct a program designed to publicize the existence of said bus service and to acquaint its staff members and students with the availability of the same during the period in which it is provided in accordance with and under this Agreement. The Company will provide appropriate time tables for convenience of students.

۷.

Service Provided

A. Company will provide and use at all times buses that are in good and safe mechanical condition, and are also in reasonable clean condition, and will also provide competent and duly licensed drivers by whom said buses shall be driven, and Company will assume full and complete responsibility for the condition of said buses and the qualifications and competence of their drivers, at all times, and University assumes no obligations whatsoever for either of the same.

B. Said bus service to be provided hereunder during said period shall not be open to use, or to be used, by the general public, but the use thereof shall be limited exclusively to University staff members, students, and such persons as may be designated by University as "Authorized Passengers"; provided, however, that nothing herein shall be construed to prohibit the use by the Company of such buses for purposes other than as set forth herein, when such buses are not needed by Company to carry out the terms hereof.

VI.

Independent Contractor Relationship

In providing and furnishing said bus service during the term hereof, Company shall act solely in the capacity of and as an independent contractor, and not as agent or employee of University, and University shall have no control

over Company's operations in connection with providing said service except as hereinabove provided, and University shall have no control or supervision whatever over the drivers of the buses used in said service who shall be employed by Company. Said drivers shall constitute Company's employees only, shall not constitute agents or employees of University, and shall be subject solely to Company's supervision and control.

VII.

Insurance and Risk

A. At all times during which Company shall provide the above mentioned bus service upon the above and foregoing terms and conditions, Company shall carry and keep in force, at Company's expense, an insurance policy insuring both Company and University against liability for personal injuries or property damages arising out of the operation of said bus service, and covering each and all of the buses used by Company in that service, to the extent of at least \$100,000.00 for personal injury to any one person, \$300,000.00 for each occurrence, and \$50,000.00 for property damages sustained in any accident or occurrence arising out of the operation of such bus service. In that connection, Company shall furnish University a certificate of Company's insurer showing coverage to be at least in the sums just stated. Said insurance policy shall name and include "The Board of Regents of Texas Tech University" as named insured. Said policy or policies shall, upon request, be subject to the examination and approval of University.

B. Company assumes the risk of, and University shall not be liable for, damage to any and all buses or other Company property, used in the bus service operation, regardless of the cause thereof. The University shall be reimbursed by the Company for any damage or injury to University property arising out of or resulting from the said bus service operation, except that no such reimbursement shall be made for (1) damage to pavement by normal operations of buses, or (2) any damage or injury caused by acts or omissions over which Company, its employees, or agents had no control.

VIII.

Maintenance

Company agrees to maintain and operate said bus service and the buses used in providing the same in a safe, efficient and lawful manner and, in so doing, shall fully comply with all applicable statutes, municipal ordinances, and traffic rules and regulations promulgated by the University.

IX.

Miscellaneous

A. It is further agreed that this Agreement is made solely for the benefit of University and Company, that it is not made for the benefit of any third person, whether a staff member or student of University, or otherwise, and that no action or defense may be founded upon this Agreement except by the parties signatory hereto.

B. In no event shall the Company be deemed to be in default of any provision of this Agreement for failure to perform where such failure is due solely to strikes, walkouts, civil insurrections or disorders, acts of God, or for any other cause or causes wholly beyond the control of the Company. In such eventuality the University shall have the right to procure appropriate transportation service from others during the period. If, for any reason beyond the control of the University, including but not limited to epidemics, student strikes or disorders, or severe weather conditions, the University should deem it necessary or expedient to suspend classes, the University may, upon twelve (12) hours notice to the Company, request the temporary suspension of bus service until the resumption of normal class schedules, in which event the Company will not furnish buses or be paid for services until the resumption of service. The University shall, in such cases, notify the Company twelve (12) hours in advance of the time service is to be resumed.

Board Minutes

CONTRACT

THIS AGREEMENT made this 1st day of September, 1971, by and between LUBBOCK-AMARILLO ARMORED SERVICE, INC., having its principal place of business at Lubbock, Texas, (hereinafter called the "Carrier"), Party of the First Part, and TEXAS TECH UNIVERSITY, a university qualified to do business in Lubbock, Texas, (hereinafter called "Texas Tech"), Party of the Second Part.

WITNESSETH:

That, whereas Texas Tech University operates at West Broadway in the City of Lubbock, State of Texas;

NOW, THEREFORE, in consideration of the agreement hereinafter contained, the parties mutually agree each one with the other as follows:

<u>FIRST</u>: Carrier will call at Texas Tech University (University premises are defined to include all University buildings and the municipal Auditorium-Coliseum) each banking day to deliver change picked up from the bank and pick up deposits at five (5) locations from said University. Carrier will promptly and safely transport and deliver to such bank in said City as Texas Tech may designate in writing, such shipments of monies and securities as may be handed to Carrier for that purpose.

Carrier agrees not to accept for transportation and delivery hereunder any shipment of monies or securities which is not in its opinion properly and adequately sealed. The Director of Accounting and Finance of said Texas Tech University is hereby authorized (and may in writing authorize others) to receipt for shipments delivered hereunder by Carrier; but any such authorization may be revoked by Texas Tech by written notice to Carrier. Carrier shall receipt to Texas Tech or to the bank as the case may be, for monies and securities which are received by the Carrier from Texas Tech for transportation and delivery to said bank. All calls of Carrier at Texas Tech for the purpose of receiving or delivering monies and securities as herein provided, shall be made at mutually convenient times arranged for in advance; the term monies as herein called, includes and shall mean Federal Reserve Notes, uncancelled United

States postage and revenue stamps, and "securities" as herein called shall include checks, drafts, bills of exchange, warrants, postal or express money orders, pensions and bank money orders, credit memorandum, bonds, debentures, script certificates, bills of lading, warehouse receipts, notes, coupons, trade acceptances, certificates of deposit, certificates of stock, negotiable and non-negotiable securities and all other securities of any kind.

<u>SECOND</u>: The monies and securities received by Carrier for transportation and delivery hereunder will be transported in armored cars, under the control of a competent driver and accompanied by one or more armed guards. Carrier guarantees prompt and efficient service by its agents and employees, to the satisfaction of Texas Tech. Carrier shall not, however, be liable for delays in performance caused by strikes, riots, war, insurrection, Act of God, or the public enemy, but Carrier shall be liable as hereinafter provided for the safety of all monies and securities delivered to it hereunder.

THIRD: Carrier guarantees safe transportation and actual delivery to said Bank in said City, or to said Texas Tech University in said City as the case may be, of all monies and securities placed in its possession under the provisions hereof, and expressly assumes all risks and agrees to promptly reimburse Texas Tech for loss of any such monies, and loss on any one trip (includes five locations mentioned in FIRST paragraph) shall not exceed \$150,000.00 EXCEPT during registration dates, when such coverage will be increased to \$400,000.00; further, Carrier does not insure against or assume liability for rebellion or insurrection, not against seizure, destruction or confiscation by order of any Government or Public Authority. It is understood that Carrier's total liability for any one loss is \$400,000.00. The Carrier will furnish Texas Tech a copy of a bond or an insurance certificate showing the Carrier can meet the amount of losses described above. The bond or insurance shall be with a company satisfactory to Texas Tech University and the company will furnish a statement to the effect that said bond or policy will not be cancelled without ten (10) days prior notice being given to Texas Tech.

FOURTH: As full compensation to Carrier hereunder, Texas Tech University agrees to pay the Carrier within ten (10) days after the end of each month during the continuance of this contract, the sum of \$175.00 per month, plus \$4.00 for any extra stops or extra trips requested by the University. It is understood that there will not be any other additional charge.

FIFTH: This contract shall become effective on the 1st day of September, 1971, and shall continue in effect until the 31st day of August, 1972. Either party shall have the right to cancel this contract any time by giving to the other party at least ten (10) days written notice of such cancellation.

The cancellation or termination of this contract in any manner shall not release or affect any liability of Carrier or any liability of Texas Tech University under the all-risk policy for any loss suffered prior to such cancellation or termination.
