CONSTITUTIONAL CONVENTION RESOLUTION 19

By Delegates Caldwell, Daniel, Aikin and Blanchard:

To Committee on Administration.

C.C.R. 19, WHEREAS, the Constitutional Convention of 1875 failed in its duty to provide a written and visual record of its historic activities; and

WHEREAS, future generations of Texans should not be left without a visual record of the Texas Constitutional Convention of 1974; and

WHEREAS, the Public Information Committee of the Convention has recommended that the Convention prepare an educational and informational documentary film on the once-in-a-century work of the Convention; and

WHEREAS, this film would be a factual accounting of the major events of the Convention and will bring the story of the Convention to millions of Texans who in 1974 cannot travel to Austin to personally experience the events of the Convention; and

WHEREAS, the production of the documentary will also generate hundreds of feet of additional film for the State Archives as a permanent record of the work of the Convention; now, therefore, be it

RESOLVED, that the Constitutional Convention of 1974 amend C.C.R. No. 16 by budgeting for the purpose of a documentary film the \$79,724.00 now included in the Convention budget as an available unexpended balance and conforming all budget totals, subtotals, and detail accordingly.

C.C.R. 10, BE IT RESOLVED by the Constitutional Convention of Texas, That Rule XV, Section 2, of the Rules of Procedure is amended to read as follows:

Section 2. Five copies of each amendment, identical in text, shall be filed with the President. When the amendment is read, all copies filed with the President shall go to the Secretary. No amendment offered from the floor shall be in order unless and until the sponsoring Delegate has complied with the provisions of this section with respect to copies of such amendment. If the amendment exceeds one page in length, the sponsoring Delegate must provide to the Secretary a minimum of fifteen copies to be available for distribution to Delegates requesting copies of such amendment. If the amendment is only one page in length or less, the Secretary will immediately proceed to have additional copies made and available for those Delegates requesting copies of such amendment. The provisions of this section with respect to extra copies shall not apply to committee reports or to amendments which do nothing more than delete material from the proposal or resolution.

C.C.R. 18, BE IT RESOLVED by the Constitutional Convention of Texas, That Section 19 of Rule VI, Rules of Procedure of the Constitutional Convention of Texas, be and is hereby amended to read as follows:

"Section 19. No minority report shall be recognized unless it has been signed by not less than six Delegates of a Committee of 21 or more members, four Delegates of a Committee of more than 10 but less than 21 members and two Delegates of a Committee of less than 10 members. Delegates signing the minority report must be members of the Committee making the majority report. Only members who were present when the vote was taken on the proposal or other matter, and who voted on the losing side, may sign a minority report."
