I joined the Army at Hopkinsville Kentucky Oct 8. 1861 Captain Ned Warrinethen was my Captain until killed. at Seacrest we then elected our first Lieutenant, Joe B Williams Captain. I was in the fight at Seacrest and also at Fort Donelson. I got sick & was at Decatur. Ala. went back to Ky and was captured by Federal and imprisoned at Louisville Ky we joined as one year men and while in prison our time expired and the company was mustered out at Clinton Tennessee I did not get my discharge as I was in prison I give as References Mr L Dabbins and Rev A L Johnson of this City.
