THE ENCLOSED CERTIFICATE IS VALUELESS TO OTHER THAN THE OWNER. IF LOST, THE FINDER SHOULD DROP IT IN THE POST OFFICE OR LETTER BOX AND THE POST-MASTER WILL RETURN IT TO THE OWNER, NO POSTAGE IS NECESSARY.

INSTRUCTIONS.

Buy stamps only from a post office, bank, or other authorized agent. Every agent will have official authority to sell War-Savings Stamps.

Affix stamps to the certificate as soon as purchased. When the owner of a certificate determines to register it, any stamps added to the certificate after registration must also be registered at the same post office.

The inclosed certificate with one or more stamps affixed represents a five-year loan to the United States Government. If the necessities of the owner are such as to require the repayment of the amount invested, the certificate is made payable at the option of the owner named thereon at any time prior to maturity, and in case of such payment such owner shall be entitled to receive the amount set forth in the table printed on the certificate for each War-Savings Certificate Stamp then affixed.

INFORMATION.

There are two kinds of stamps, War-Savings Stamps and Thrift Stamps. The War-Savings Stamps vary in price from \$4.12 to \$4.23, according to the month in which purchased. They increase in value every month, and if held until maturity, January 1, 1923, they earn 4 per cent interest compounded quarterly.


Spaces are provided on the War-Savings Certificate for 20 War-Savings Stamps. For each of these stamps affixed to the certificate the United States Government will pay you \$5.00 on January 1, 1923. If you fill all the spaces by affixing 20 stamps, it will

pay you \$100.00 January 1, 1923.

The 25-cent Thrift Stamps do not earn interest. When 16 of them are affixed to the Thrift Card the holder may surrender the card and upon paying 12 to 23 cents receive a War-Savings Certificate Stamp, which earns interest.

NOTICE TO POSTMASTER.

When a lost War-Savings Certificate reaches you, by hand or through the mails, you will take prompt steps to deliver it to its owner, whose name and address appear upon the certificate. If the owner can not be reached you will, by builetin or advertisement to the public, endeavor to find the owner. If, after thirty days, you are unable to find the owner you will forward the certificate to the Postmaster General, Washington, D. C.



UNITED STATES GOVERNMENT THRIFT CARD

Take good care of your Thrift Card. If your Thrift Card is lost the money paid for stamps can not be recovered.

Thrift Stamps are on sale at post offices, banks, trust companies, and other authorized agencies.




