

EMERGENCY!

EMERGENCY!

The Board of the LWV-Houston declares that a state of emergency exists. It further declares that this emergency relates to program, and that the most immediately effective way of coping with this emergency is the adoption, by the Council of the LWV-US, of an EMERGENCY PROGRAM ITEM. What is the nature of the emergency? EMERGY!

News reports of the past several months have indicated that a serious problem exists in the area of energy supply and demand in the United States. There is no doubt that governmental action of some sort will occur in order to prevent further emergency shortages. (President Nixon is to present an energy message to Congress in February, and bills are now pending relating to oil import controls.) It is crucial that citizens groups be in a position to speak to this problem, and we in Houston urge that the LWV lead the way!

What are the pertirent issues and why should the LWV be involved? The issues are incredibly complex, but a partial listing would include:

- 1. Should all import controls on petroleum-related products be removed?
- 2. If import restrictions are removed, how can we offset resulting trade deficits?
- 3. How dependent do we want to be on foreign energy sources?
- 4. Should price controls on petroleum-related products be removed?
- 5. Should greater economic incentives be given to domestic energy producers?
- 6. Should federal funding toward the development of new energy sources (i.e., nuclear, solar, geothermal) be greatly increased?
- 7. Should the depletion allowance for oil and gas companies be modified?
- 8. What role did the petroleum industry play in the current energy "crisis":
- 9. How can an environmental backlash to the current energy shortages be
- 10. What procedures should be developed for siting problems (i.e., for power plants, refineries, etc.)?
- 11. What restrictions should be placed on offshore drilling?
- 12. What environmentally safe controls can be developed for coal mining?
- 13. How can energy conservation be encouraged? By citizens? By industry?
- 14. What elements should an energy policy for the United States contain?
- 15. How can an adequate supply of energy be assured for the long and short term?

As is obvious, this topic goes to the very heart of our IR and EQ items--it is for this reason, plus the obvious fuel shortages, that make this a "natural" League topic. After all, what will happen to our balance of trade and how can we keep hard-won environmental gains and still solve this problem? Or is the problem an artificial one, as suggested by S. David Freeman, Director of

Ford Foundation's Energy Policy Project? (U.S. News & World Report, Feb. 5, 1973.) Also, how valid are the recommendations of industry, as reflected by the Shell Oil Company position paper "The National Energy Problem, Implications of Forecast Demands and Supply: Oil & Gas, May, 1972:

"Uninterrupted energy supplies are vital to U.S. economic health, security of employment, and national independence.

Forecast demand and supply figures spell out the logic of increased efforts to expand domestic production. Development will not happen unless there is a climate encouraging risk investment. This would need to include import controls, economic incentives, more effective land use, and a satisfactory resolution of the environmental problem."

The solutions found to this most complex problem will affect our lives for years to come--many consider this our most urgent national problem. The question is, can the LWV speak to an urgent and immediate problem in a timely way? We feel that it must.

With regard to wording, we are certainly flexible, but suggest the following for your consideration:

ENERGY: Evaluation of alternatives necessary to provide adequate energy supplies while maintaining strong environmental safeguards.

Obviously, this could be studied under the EQ "umbrella"--or we could have a separate item. The LWV-Houston has no preference in this regard.

If you agree that this item must be studied by the League, will you please communicate your thoughts immediately to the National Board (specifically Mrs. Benson or Mrs. Clusen). According to LWV-US Bylaws, an emergency item must be sent to the presidents of local and state Leagues at least two months in advance of the meeting of Council. Council has been scheduled for May, therefore you must communicate your wishes to the LWV-US before the end of February.

Dear President:

The proposal regarding the establishment of a unicameral Legislature for Texas is expected to be presented to the Constitutional Revision Commission and consequently to the Constitutional Convention for consideration. Modernization of State Government is one of the items recommended by the LWV State Board and, if adopted, a study of the unicameral form of legislature should be made. Many League members know little about it and they should be given the opportunity to become well informed in regard to it and to determine whether or not they will support having one for Texas--ignorance on the subject would be quite embarrassing.

Mr. John Bebout, an active member of the Board of Directors of Citizens for Texas, said: "....the case for a unicameral legislature should be given cogent presentation both to the Constitutional Revision Commission....and to the Convention next year....a unicameral suggestion is likely to have rough sledding, but even if it is not accepted, discussion of it helps to focus attention on basic issues respecting the legislative institution and may have beneficial side effects at least." There has been expression of interest in obtaining a unicameral form of legislature by other influential persons in organizations devoted to working for better government.

The Baytown League wishes to urge the local Leagues throughout the State to support a study of the unicameral form of legislature and the advisability of having one for Texas, as part of the LWV State Board's recommended item entitled "Modernization of State Government". This phase of the study can be accomplished in one unit meeting and should be done this year.

The Victoria League is again attempting to line up support for a study of the Role of the Ombadsman in State Government. This year we are recommending that it be done under the Modernizing State Government item.

The idea of having a complaint department at the state level to which the average citizen may turn with grievances against a state agency is a growing concept in the U.S. today. Four states now have Ombudsmen and 26 other states had legislation introduced last year for such an office. Texas has had a bill calling for the establishing of an Ombudsman in both the 61st and 62nd sessions of the Legislature. As we have seen this past year, Texas government is made-to-order for special interest groups. But what about the lowly masses who have neither the financial means nor political clout to make the existing structure responsive to their needs? Although no one claims that an Ombudsman is a magic panacea for all of our problems, the establishing of such an office could go a long way in restoring the citizens' raith in the democratic system. To quote from H.B. 641 of the last session, "the purpose...is for the humanizing of government."

Perhaps such an office could make other studies frequently proposed unnecessary; i.e. consumer protection, administration of justice, control of utilities, etc. We in Victoria think the League of Women Voters of Texas can best spend its time in the next biennium on this study. It would not be a long, complicated study. There are sufficient resources available to provide background to enable us to reach consensus in a 2-year period. With the likelihood that our effort will be needed on Constitutional Revision, this item should not cause a drain on our woman-power and at the same time provide an intriguing, timely subject for study to hold member interest.

An article in the National Civic Review, May, 1972, states,"...the Ombudsmen must of necessity be on the agenda of rederal, state, and local governments for serious consideration. It is one of the remedies which guarantee those rights which are essential to a society in which rundamental rights and human dignity are respected." Doesn't that sound like something basic to League thinking?

Won't you join us in promoting this study? Help us restore the "avant garde" spirit to the LWV of Texas. We think the League can best serve the citizens of Texas by leading the way in understanding the possibilities, limitations, strengths, and weaknesses of the office of Ombudsman.

The Leagues in Dallas County adopted a study of the Administration of Justice in Dallas County at their annual meetings this year. This study has not yet been presented to our units, but has created considerable interest. The committee has broken the study into three parts concerning the adult criminal, the first of which covers apprehension,

Please read the following suggestion to your members at your

arrest, detention, and pre-trial.

We have interviewed between thirty and forty people (lawyers, judges, professors, ex-convicts, legal services people, city and county officials, police officers, sheriffs, social workers, etc.). In every case the League study has been encouraged. Many of these people feel League could have significant impact toward change. All see the need for change - we are sure you will also.

As most change must occur in the legislature and on a state level, we would like to recommend a study of the Administration of Justice in Texas for your consideration, for any change in penal institutions and the rehabilitation of prisoners, or in parole, or in correcting the inequalities of sentencing for similar crimes, needs study and action from the State level of League.

If we are to have a lower crime rate, there are faults in our criminal justice system that must be corrected, All the people we have talked with seem to feel that the League of Women Voters, with its thorough study and careful action, can be a driving force for the necessary change.

Please give this suggestion your consideration. We feel that you will find this a most enlightening and interesting study, and that a study of the Administration of Justice in Texas could contribute much to the future of Texas.

The District delegates to the Annual Convention in Atlanta were enormously heartened by your warm and enthusiastic support of an action program to achieve self-determination for this city. We strongly believe that this is a very critical period in the movement toward that goal.

Since we returned from Atlanta, we have conferred with some of the Board and staff members of the National League. They feel that the plan we distributed to the delegates is too ambitious to undertake within the present resources of the League and that the date of July 4, 1972 as the start of an action program is too early for the National staff to meet. Our opposition to the by-law amendment is based on the following statements:

- 1. LWV is a grass roots, member oriented organization. While local Leagues must support the operation of state and national League levels, the local Leagues must retain the right to set the rate of annual dues for their own members.
- 2. LWV is based on membership involvement, democratic procedures, and considered time for thoughtful discussion and action. Any proposal as far reaching as uniform dues must be in the hands of the local Leagues at least one year in advance of a National Convention.
- 3. The quota system of financial support should be abandoned. Per member contribution for the support of state and national Leagues should not be in excess of \$10. Retroactive collection of dues will not be supported.

members, feels that we have barely scratched the surface of this item. This study is basic and should always be a top priority item for the National LWV. WHY? Without an effective and responsive Congress, the rest of our LWV program suffers at all levels: national, state and <u>local</u>. In cities far removed from the District of Columbia newspapers fail to cover adequately the actions or inactions of Congress. Through their silence, they condone actions by Congress which may or may not be favorable to all of us. As long as this attitude is accepted by the public, less and less concern will be shown and we will have acquiesced. Nothing in our program is more suitable to the principles and purpose of the League of Women Voters:

At the 1970 National Convention, held in Washington, the delegates adopted the U.S. Congress item over the recommendations of the National Board because they felt personally involved over our invasion of Cambodia and upon a mass exodus to the "Hill" were told by their Senators and Representatives that Congress needed change before they could expect the kinds of results they wanted. The delegates returned to the Convention and voted in a non-recommended item!:

We know the difficulties that LWV's across the country must have experienced with

We know the difficulties that LWV's across the country must have experienced with this study as those of us in the National Capital Area were constantly calling the "Hill" for information -- we experienced great difficulties in searching out the "how's and why's" ourselves. However, we are fully prepared, with the aid of National, to assist LWV's in other parts of the country in the continuation of this study.

Not only do we feel that this subject is far more difficult and complex than most of us realized but now know an intensive drive for "public education" is a definite MUST for all LWV members. However, before we begin our "education campaign," let us build a better foundation for our own "positions." Our U.S. Congress committee believes that on the basis of our present research we could not adequately and with confidence lobby for change in Congress. Every LWV in the country handled this study differently and as a consequence we question the validity of a meaningful national consensus on this item. We would like to propose that we choose an area of concentration for the next two years for purposes of reaching meaningful consensus. Although "campaign spending" will undoubtedly be included, LETS NOT FORGET TO FINISH WHAT WE STARTED.

If you are interested in fighting to keep this study in the forefront of our National program, please contact Freddie Hodges at the above address. We are looking forward to seeing all of you at a U.S. Congress caucus during National Convention week.

Dear Mrs. Bensen:

The League of Women Voters of Arizona joins the five local Leagues in the state to voice our opposition to the proposed bylaw amendment to set dues at the natio wal level of no less than \$15 per year.

We do believe that this proposal changes the grassroots concept of the League of Women Voters, a concept built into the very beginnings of the organization. Also, with a projected drop in membership of from one-fourth to one-third if the dues plan is adopted, the very nature of League membership will subtlely change from a broad-based group of women representative of their communities to a selective group of those "not dependent on the vagaries of the economy, less prone to yearly ups and downs of income."

For Arizona this new dues may mean not only fewer members, but fewer local leagues. We feel that dues of \$15 will prevent many new members from joining, will prehibit them from finding out the real value of the League of Women Voters. It will make our efforts to expand Member-at-Large Units almost impossible.

Finally, we also feel that the announcement of this proposed change did not arrive in time for local and state budget-waking. At least one local League's proposed budget was published in a VCTER within days of the receipt of the December NATIONAL BOARD REPORT. We do feel the uncertainties of this proposal are such that budget committees can not adequately project the results.

Although the League in Arizona does oppose this bylaw amenement, we do wish to express our concern for adequate financing for the national League as well as state and local leagues. We hope an alternate plan can be developed and presented for consideration at the 1972 convention. If not, then perhaps some "belt-tightening" is in order while the problem is given more thought.

In 1970-71 our League studied election laws and voting procedures as they applied to Brazos County. Our consensus included opposition to the requirement of signing the numbered ballot stubs. As far as we can determine other states do not require such a signature which, in effect, could identify how one voted.

It does not appear that this will be an issue taken up by Texas state League. We need to have the reaction of your League as to possible legal action on the Brazos County League's part since any action might affect every paper ballot in Texas.

At this time it appears our action will be to file an amicus curiae brief in conjunction with litigation by the Brazos County Civil Liberties Union.

We need to hear from you by May 1. If we do not hear from you by that date, we will assume you approve of our contemplated action.

Please send copies of your correspondence with us to the state office, Lois Braunagel, Betty Anderson, and Peg Lampton, as they need to follow developments.

RE: NATIONAL/STATE DUES PROPOSAL

The League of Women Voters of Houston has, as yet, taken no formal action on the National/State Dues proposed as outlined in the National Board Report and as discussed in the Jan./Feb. NATIONAL VOTER. There has been some discussion at our February Board meeting and we are now in the process of informing our members and eliciting their reactions before the Board formulates a recommendation.

The enclosed memo-and-postcard has gone out to our entire membership, and we are already beginning to receive replies. We are further planning a Special Membership Meeting on March 27th to give members another opportunity to express themselves on this matter.

The preliminary tally of replies is <u>against</u> the \$15 amount, <u>against</u> National Convention establishing the amount of dues on a local level, and <u>against</u> a pledge system in addition to assessed dues.

We are taking this opportunity to inform you of what we are doing, hoping that whatever thoughts you have in this regard you will share with us and also with the idea in mind that you might wish to inform your membership in a like manner. There is ample time to get a good feed-back from all League members and to formulate an effective strategy to deal with this matter at National Convention in May. There does not appear, however, to be the necessary time or approved procedures available to us to offer a substitute proposal or to amend the National Board's recommended By-laws change, in order that we might find some other way to extricate LWV-US from its financial dilemma.

If you have any suggestions regarding ANY aspect of this matter, please forward them to us at your earliest convenience.

P. S. If you are not, as yet, planning to send a delegate to National Convention, PLEASE reconsider. The money your League and/or delegate would spend will be well worth it—and we need all the support that can be mustered. Let's not have "taxation without representation".

TO: THE MEMBERSHIP, LEAGUE OF WOMEN VOTERS OF HOUSTON

RE: PROPOSED NATIONAL AND STATE DUES

The National Board of the LWV-US has adopted a proposal to recommend to the coming National Convention a National By-Laws change which would establish League dues at no less than \$15 per year and further to recommend that this sum be presently allocated \$7 to local Leagues, \$4 to State Leagues, and \$4 to National League. The proposed change in financial support for the League is based on a two-fold idea:

(1) equal support for equal services (member dues support of the League at all

three levels -- local, state and national)

(2) ability to pay (pledges fought from local and state Leagues based upon size and economic yardstick of communities from which fund-raising is sought)

A four-page dissertation by Lucy Benson, the national president, on the necessities and decisions surrounding this proposal appear in the Jan./Feb. NATIONAL VOTER, under the title, "New Directions." We strongly urge all concerned Leaguers to read this article.

It is important that our local Board have some member input before taking any action and that our National Convention delegates be able to vote at convention consonant with member attitudes. Therefore, we are presenting some of the salient pros and cons on this subject and request that, after thinking about these proposals, you mail back the enclosed card, expressing your sentiments. If you do not have enough space on the card, please write a letter or feel free to telephone Jeannette Naman or Janet Puestow () to express your opinion further. You will have an additional opportunity to discuss this matter and ask questions of our more knowledgeable Board members at the March 27th meeting—be sure to come!

PROS: The proposed new structure is considered necessary by the National Board and its Long-Range Planning Committee because-

(1) Integrated finance, i.e., money raised locally and pledged to State and then to National, is no longer adequate to support the programs and actions demanded by the membership.

(2) Financing by corporations and foundations is too often funneled into taxdeductible channels and therefore limited to purely educational programs and restricted from use by action campaigns and administrative purposes.

(3) Grants and contributions are not readily predicatable from year to year, fluctuating according to the economy and the vagaries of the donors.

(4) Individual members should carry more of the financial responsibility for providing funds for League as a whole because members care about the League and value its unique role in their lives and the life of the country and are ready to pay directly a larger part of the bill for carrying out that role.

(5) \$15 dues would provide an assured annual source of funds to State and National to cover operating expenses, increasing the financial stability of total League programs and reducing the uncertainty of year-to-year planning.

(6) If National and State do not have stable income from member dues, the alternatives are a sharp rise in local League voluntary pledges or a drastic cut in National and State services.

(7) Only minimum dues would be determined by National Convention; local Leagues could still increase local dues if necessary to cover their local operating expenses.

(8) Many members belong to other national organizations whose dues are at least \$15.

CONS: Those who challenge this proposal present the following salient points-

LWV-H, Memor on National Dues, cont'd., page 2

(1) \$15 is too great a burden for many current and potential League members, particularly minority and youth members whom we are trying to attract.

2) Houston League Board recently rejected the suggestion to raise dues to \$12.50 because it felt such an increase would not be supported by the major-

ity of our membership.

(3) Most active local League members are already supporting League beyond their present dues and contributions, in the form of miscellaneous expenses, babysitting, travel, etc.; inactive Leaguers will probably not wish to make any larger "contributions."

(4) While a per-capita commitment to State and National (of a lower amount, perhaps) may be justified, the National Convention should NOT set local League dues; these should continue to be decided by local Leagues, in order to pre-

serve our grass-roots autonomy.

(5) In many cases (e.g. Houston), the proposed local dues of \$7 is below the current dues level; member support of local programs and action might have

to be reduced under the new proposal.

(6) Local Leagues would have to conduct more extensive finance drives to raise additional funds from the community to cover local budgets, as larger amounts of local funds would be channeled to State and National and smaller amount of local dues would be received.

(7) \$15 dues will probably severely cut into member contributions, which we are

working diligently to increase.

(8) We already make a voluntary pledge to State and National at the rate of almst

\$9 per member.

(9) In addition to the \$8 proposed to go to State and National, we would still be expected to make a pledge to State and National of an amount supposedly based on our ability to raise outside, non-member contributions from the community; however, this isspresently proposed (by new State budget proposals) on a per-capita basis in reality.

(10) The comparison with other \$15-dues collecting organizations lacks validity because every national organization has a different membership composition

and a different purpose

(11) Even greater economy may be needed at the National level as there still may be too many frills and too many high-priced staff people in the national office. In contrast, local Leagues, where program and action emphasis lies, often subsist on shoe-string operations and predominantly volunteer help.

To Local League Boards of LWV of Texas:

On April 27, 1971, the Texas Legislature passed the Equal Legal Rights Amendment to the Constitution of Texas which guarantees that equality under the law shall not be denied or abridged because of sex, race, creed, color or national origin. On Tuesday, November 7, 1972, the people of Texas will be given the opportunity of approving this amendment and it is important that every citizen work to see that the guarantees of the Equal Legal Rights Amendment be enacted into our State Constitution.

With the Constitutional guarantee of full, legal equality for citizens, it would not be easy to pass a law discriminating against any citizen, as it requires a two-thirds of the legislature to repeal a constitutional amendment. Without the amendment, an oppressive law can be passed by simple majority vote, so that one of the very important functions of the Equal Legal Rights LAmendment is to prevent the passage of discriminatory laws in the future.

The Board of the Tarrant County sague of Women Voters is writing all the Leagues in Texas to inform them of our recent action concerning the Equal Legal Rights Amendment to the Texas Constitution. In August our Board voted to urge the State Board to announce League support for the Equal Legal Rights Amendment. At their September meeting the State Board read a statement prepared by the Tarrant County League, showing the State Board that we, the League of Women Voters, can and should actively support the amendment. Because of a shortage of time at their September meeting, the State Board deferred a decision on the matter until their January meeting. During the intervening time the State Human Resources Chairman was to look more closely at the amendment and prepare a report for the January Board meeting.

The State Board has not heard from any local Boards except Tarrant County and would like to know how the other Leagues feel on this matter. We urgs you now to discuss this at your December Board meetings and to write either Mrs. fritz, the State Human Resources Chairman, or Mrs. Winick, the State League President, adding your support for an affirmative decision at the State level. The president of League support for this human rights amendment to the Texas Constitution will facilitate its passage in November, 1972.

In answer to your letter of June 25 in which you ask about the Lubbock Human Relations Commission, I must say that we can be of little help because we do not have such a commission functioning in Lubback.

At one point in Lubbock's history (2 to 4 years ago) the City Council did appoint a Human Relations Committee. At the time we studied the Human Relations Commission on the State level we did briefly investigate the status of the Lubbock Committee. As of last Fall it was essentially defunct and our DHR chairman says that little seems to have been accomplished by the group. They did draw up bylaws which included listing a purpose of dispelling "malicious rumors." The committee was given few powers, primarily given the responsibility to report to the Council. There was "token" representation of vaious racial groups. Whatever the intended purposes of the group, it has been completely ineffectual.

In recent weeks, there has been a great deal of controversy centered on discrimination and other charges in regard to our police department. The City Council has appointed a "90-day Grievance Committee" to investigate the complaints. At the time it was formed, the mayor suggested that it might evolve into a Human Relations Commission, but the apparent lack of success of the Grievance Committee would lead us to believe that it will die a quick death as soon as the 90 days are up.. (So far, there have been several resignations from the committee and people have been "afraid" to make statements for fear of job reprisals.)

I recently visited the Midland League and did find out that Midland has a very successful Human Relations Commission. I might suggest that you write to their president, Mrs. Ken Carpenter, and hopefully she can be more helpful in answering your questions than I have been.

Good luck in your endeavor. Perhaps your success will give us some insight on how we can establish an "effective" Commission in Lubbook.



Hope all is well with you and yours



Dear Mrs. Know:

We began our study on the possible need for a juvenile detention facility in Lubbock two years ago. Our youth are currently being held in the County jail. I am enclosing some reproductions of our program sheets which appeared in the Lubbock VOTER at the beginning of our study. We reached consensus on the need for such a facility and have spent the last year and one half working toward the implementation of our consensus.

Our Juvenile Problems chairman understood that your city already has such a facility, so I am not sending the information we have produced aimed at the establishment of such a building. However, she did suggest that the National Council on Crime and Delinquency (NCCD) representative for Arizona would probably be a good person to talk with, if you have not already done so. The representative from Texas, John Cocorus, came free of charge and spoke to our League. His office has since been hired to prepare a study of our local needs. The finished report is now being used as a potential guide by our Juvenile Court to work toward establishing such a facility. We still have to find a way to finance the building and have a few knotty problems to work out (such as getting it through the Commissioner's Court and seeing a bond issue passed.)

The NCCD publication "Standards and Guides for the Datention of Children and Youth" (referred to in our program sheets) would probably be most helpful to you if you are trying to evaluate the effectiveness of your present facilities and program. The NCCD is supported by Local United Funds and you should be able to learn through your local agency how to get in touch with your NCCD representative.

I hope this information will be of some help to you in the gourse of your study.





Dear Mrs. Jordan:

The League of Women Voters of Texas, at its Board meeting in January 1970, voted to support National Library Week, April 12-18, 1970. This Week is an annual observance instituted in 1957 for the purpose of asking Americans to look closely at the nation's reading and the library resources to which they have access. Examination over a thirteen-year period has resulted in increased Federal aid, from two million to almost 500 million dollars, and a rise in state and local appropriations for support of libraries.

National Library Week provides a framework for citizen-action in raising the standards of literacy and increasing the reading resources of the community. Sponsored by the National Book Committee and the American Library Association, National Library Week has attracted a number of participating organizations American Association for the Advancement of such as: Science; American Association of University Women; American Newspaper Publishers Association; Association of Junior Leagues of America; Boy Scouts of America; General Federation of Women's Clubs; Girl Scouts of the U.S.A.; National Congress of Parents and Teachers; Super Market Institute, Inc.; and many others.

Texas Library Trustee Association The importance of reading to the cultural, economic, social and intellectual climate of our nation cannot be over-emphasized. James E. Allen, Jr., Assistant Secretary for Education and U.S. Commissioner of Education, describes the right to read as the "target for the 70's" and calls upon citizens to "take upon yourselves the obligation of assuring that every child in your State will learn to read ... when together we set in motion that nationwide effort that will erase this intolerable deficit in American education ..."

National Library Week needs to concentrate on the local and state level if we are to become aware of the library as a democratic institution providing free access to adequate information for all. Citizens need an awareness throughout this year of the importance of reading to cope with technological advances, the knowledge explosion, social changes, and to assist in the alleviation of poverty and racial tensions.

This year in Texas the objective of National Library Week is to "cooperate with the Texas State Library in its efforts to implement the Library Systems Act." On March 20, 1969, a bill was approved "relating to the establishment, operation, and financing of a state library system consisting of a network of interrelated cooperating library systems designed to provide adequate library facilities and services to the public ... " This "Library Systems Act" provides the foundation for bringing adequate library service to all Texans and access to the total resources of Texas libraries. Before March, 1969, Texas had not had a legal instrument through which it could provide State funds for library development. Since March, 1969, the instrumentality exists, but except for a small appropriation for basic personnel to lay the necessary groundwork, no funds are available to implement the provisions of the Act.

If Texas is to provide the proper climate for developing lifetime reading habits among her citizens, and if the State is to realize the economic, cultural and social benefits which accrue to an enlightened society, the Sixty-second Legislature meeting in Austin in 1971 must include significant funds in its appropriation bill for implementation of the Library Systems Act. Otherwise, the legislation becomes a splendid but empty gesture.

Those Leagues which have a consensus on libraries which would allow them to work for adequate funding of this Act will be especially interested in the flyers which will be available at State Convention. A sample is enclosed. The other Leagues may wish to distribute the flyers as a voters service project with appropriate publicity.

We just got an assignment from State which says it is the Lubbock League's responsibility to contact him this year. There are two TWA flights leaving at 9:15 from Amarillo. One goes through Chicago to Laguardia and arrives at 4:30 p.m. The other Lands in Newark at 3:58 after three stops. However, there is no way for me to get to Amarillo by that time unless I come up on Friday. The other options seem much preferable, because these flights don't give us much advantage on arrival time in N.Y.

My preference would be to take Braniff all the way - so we wouldn't have to switch airlines -- there seems to be no way of avoiding switching planes. If we go that way, you could either take Braniff 165 and we could ride to Dallas together, or you could take Braniff 275 while I took 165 and we could meet in Dallas. Let me know your thinking on this.

If you decide to come home by way of Dallas, there is no alternative than to come through Lubback.

There are some other alternatives for you:

Leave National at 5:00 p.m., TWA 407 to Kansas City, arrive KC at 7:40 Leave Kansas City at 8:00 p.m., DWA 437 to Amarillo, Arrive 10:25

or Leave National at 2:40 p.m., American 611 to 0 Hare, Chicago Arrive Chig. 3:35 Leave Chicago at 4:35 p.m., TWA 339 to Amarillo, Arrive 7:36

If you test the one that Leave National at 5:00, I would probably take the Battafal flight that leaves at 5:25 from National and bets in here at 11:10.

If you want to take the American 611 flight, I can take it too and stay on the plane. It goes on to Dallas and makes connections with the Braniff flight that comes in to Lubbock at 7:56.

It tooks like we have several options on the retump. In the workbook, on page 4 it indicates travel time to National ($\frac{1}{2}$ hour), Dulles ($\frac{1}{2}$ hrs.) and Baltimore (45 minutes). It is a little unclear if they mean from the hotel on the first two, but the last one is definitely from a downtown terminal. Duane thinks we will have to go by cab to some downtown terminal for all of them.

If we decide to try to make the Braniff 168 flight that leaves Dallas at \$200. We have a choice between the flight from Dulles at 3:10 or from Baltimore at 4:30. Leaving at 3:10 from Dulles might mean that we wouldn't be able to stay until the end of the friday sessions at 1:00. Another one of those close cutting situations. If we leave from Baltimore at 4:30, we would have to switch airlines.

If we decide to take the Braniff 178 flight, that leaves Dallas at 1815; we have a choice between the flight from National at 15:25 or the one from Dallas, at 7:20. The one from National would take less time from hotel to airport and might possibly make it possible to go on the afternoon tours. We would have an hour and a half wait in Dallas. If we go from Dullas, we would have the longer drive, but certainly enoughttime for the afternoon tours, and we would only have to wait in Dallas for 50 minutes.

If you decide to take the TWA flight that issues National at 5:00, you would get home an la earlier than by coming through Dallas on Braniff. It would also allow you a literary "get-away" but not enought time for afternoon tours.

The American flight that leaves National at 2:40 would be a little cosier to work out in terms of time after the 1:00 p.m. edjournment time.

From here, it look like our best choices would be either that American flight that would make it relatively easy to get to the airport and would get us back home at a good hour, or the flight from Dulles at 7:20 on Braniff that would make it possible for us to go on the tours and cut down on the waiting time in Dallas. It does get us in rather late on Friday. Let me know your thinking on this.

The information on hotels arrived yesterday from New York. Duene looked in his AAA travel guide and nixed two of those listed. They may be recommended by teague, but not the AAA. In addition, the prices look better or at least as good for a room with two beds for two in the AAA hotels than the others. At this point it leaves the Hotel Biltmore and the Hotel Roosevelt. There are some other AAA hotels in the same area - some a little closer to the aifaons terminal on the East Side. Duane wants to check the subway map tomorrow, which may give an advantage to the Biltmore or the Roosevelt ever those closer to the air line terminal. All are within a few blocks of the UN building. If you have no objections, I will just go shead and make reservations - by phone thanks to the PO department)- at the place that seems best to us. My preference is for one on the list, just because there might be a chance that more League people will be staying there.

After teading this over. I have the sinking feeling that the airlines might change flights on us -- and there goes all my efforts as annovice travel agent. If the Texas mail people go on strike, I guest we will have to resort to the phone.

Until then, lets hope for the best -- and a little less snow -- thre times in a week is a little much for March.

PSS. Duane has just looked this over, and realized for the first time that the Chicago stop is part of that American flight. Something he hadn't spotted in his go-through of the schedule. Boy, do I feel smug. Anyway, he says we should try to avoid Chicago, so that puts a different light on that flight.

He discouraged me from taking that Braniff Flight 178 that gets in so late, because it is often cancelled! So that puts us back to the 3:10 flight from Dulles or the 4:30 flight from Baltimore. He says the drive on the bus out to Dulles is worth missing a few minutes of the last session. I have no way of judging on that. The transfer from American to Braniff (if we go the Baltimore toute) could be a bit tense, so at this point it looks like the Braniff 15 and Braniff 168 flights are the ones I will want to these. Guess we better take a decision on this fairly seon, so that we can get our reservations made for the tours.

A quick note before another action-packed week gets underway!

I think that I'm cross with Senator Blanchard!! Our paper up here carried an excellent story about the public hearing on environmental control held in Lubbock March 5th.

Our paper's reporter also mentioned your statement and it sounded as if it was intelligently prepared and well presented (natch!). But he also mentioned what sounded to me like a "put-down" response from the Senator...something about League members starting to help by not throwing gum wrappers out car windows! If that's what happened, it certainly lowers my opinion of Senator Blanchard!

I've thought quite a bit about our telephone conversation that got into discussion about the State Board slate for this year. Mostly, I appreciate your faith in me...along with so many others. Without doubt, this is the strangest situation I have ever been in. I suppose the thing that really could upset me is the fact that I held my tongue, cultivated an unusual amount of patience, and attempted to keep a lid on the personal animosity of a couple of people here in Amarillo....poor Cleo Elkins, the President, was a pawn.

It's seldom mentioned here anymore, but local Board members are still furious with the few State Board members who actually helped build the situation. As one of them said to Ruth Joor, "We didn't know we had a problem until the State Board told us we did". Actually, the local Board did have aproblem, but didn't know it and I wasn't about to tell them since it was directed at me, and I'd decided I'd just grow a thick skin and ignore it. Interestingly enough, as time has gone by, we've found that Polly Moss' niece here had a great deal to do with the smear campaign. Oh, well....the only people who don't attract some kind of response are the ones who just stay home all the time and scrub floors!!

There's been some concern about Ruth Martin serving on the SB again. I turn the comments aside as gently as possible...but she has no contact with this League and hasn't had for a long time. Think she's been to 2 meetings during the past year. That's sad for her service at the state level means nothing one way or the other to the membership. Nova Foote said when she first joined the League here, she wondered who Ruth Martin was for a long time before she finally met her. Well...an experienced Program VP is a tremendous asset to a new President, so it's good that she was asked to continue. But her membership in a local League is a mighty slim thread.

Enough of that...once in awhile I could get a little bitter about walking so innocently into a mess like this was up here.... but most of the time I remember it was "just one of those things" and involved people who lack in maturity. And $99\frac{1}{2}$ % of League members are still great people!

Saw the notice of your annual meeting in last Sunday's (week-before-last, I guess) paper. How intelligent the planning that brought Arch Lamb to discuss voting machines!! The punch card/computer

system seems to be working very well in Randall County. There have been some "bugs" towork out, but they've been mostly in the area of the human factor. Potter County continues to use the lever machines.

Don't know whether this information is in Lubbock's files anywhere ... but the salesman for the lever machines told me at the time the issue was on the ballot in Lubbock (same fall it was voted on in these two counties up here)....that the only things that allowed passage in Potter and Randall counties was the fact that the bonding company that was going to supply the money for the purchases (if it carried) insisted that the voting for the machines, and the voting for the warehouse to store them, be carried as separate issues.

The vote for the machines carried (though not overwhelmingly) and the issue for funding a warehouse lost. After the election was over, one of the Commissioners in the 2 counties said that they really didn't need the warehouse anyhow, but thought they might as well put that amount in while the issue was being voted on!

They probably wouldn't have done it if they'd known the issue was going to be split into the 2 different expenses.

This could be something to watch for if there's any discussion in Lubbock County about including the cost of storage space for the machines. People up here now vote as if they've always had the machines rather than paper hallots, and seem to have forgotten it was "controversial" some 8 years ago.

As of now ... I plan to go to Convention in Houston. My mother is coming to visit us soon ... it will soon be a year since my father died and she wants to be away from Greeley. I've written her that I'll need to be gone a few days in April, and I think she'll understand. She and Bob have always enjoyed each other's company...but if a choice has to be made, I wouldn't hesitate to choose family instead of LWV.

We're past the half-way mark in our Finance Drive ... and thank goodness, we have a Finance Chairman for next year. I've never served as Chairman of a Finance Committee before ... ver-r-r-y interesting! Every League should have a Tila Bowers!

I do hope that you will be able to go to Washington in May. "ational Conventions are simply tremendous - Texas has a good State Convention, but the dimensions can't be the same, of course. Tell Duane we'll take good care of you.... I'm pretty cautious about my own safety even in Amarillo!

I've been trying to get down to Lubbock for weeks...seems like a long time since I've done any visiting down there. Am also involved up here with an ad hoc committee of our church studying current literature at all levels in the SS classes.

We're fine. and hope that you and your family are, too. Hope to talk with you again beofre State Convention time. I've written Betty to wish her well in the School Board election. Hope she's elected! She'd be a top-notch School Board member.

You couldn't possibly have time to read another page...so I'll quit! As ever, Seuloh

Dear Mrs. Stephese:

Your letter of January 30 regarding transportation was discussed at our recent Board meeting. In enswer to your specific questions:

- 1. Yes, we do feel there is a transportation problem in our city.
- 2. No, we do not feel that our present mass transit system is adquate. In fact, our present system consists of busses which are run by a private firm. In a recent statement to the City Council, they indicated that they would not be able to continue to run the company under present conditions. They have suggested that the City buy the equipment and their company would in turn run the service. Even so, there is great difficulty for a person to use this only form of public transportation to get from one part of town to another. A great deal of improvement in service is needed. At this time, the City is taking the bus company's suggestion under advisement.
- 3. No, our League has not done nor is it doing any study on mass transit or transportation.
- 4. There was some interest in possibly studying mass transit or at least transportation. However, it appears to be more of a local than a state item to us at this time. We do think that this is a potential study area, and possibly in the future we would be willing to support it as an item -- but not this year. We wondered if it could not be considered as one aspect of Environmental Quality somewhere down the line when we finish the areas of water, land use, and air quality.

We hope this information will be helpful to you in your considerations.

This item has been with us longer than most of our state program items, and since there has been no new study for quite a while, there is no current material. I am sonding a resume of legislation and and League action in this field. Also I am including the body of a speech giver pefore the House Mection Laws Study Committee in Catober 1968. I gleaned the information for it from various older statements and a recont National League publication, Get Ready to Vote! when the League first arrived at positions following its study of Voter Registration, we said that we flevored "permanent" registration. Use of this word proved to be a mistake because there is strong feeling against permanent registration in Texas. Many people who mixunderstand its meaning seem to imagine that we could vote everyone in the graveyard with this system. Also there are those who oppose making voting easy and convenient. Realizing its mistake, the Learne Cropped the use of the word "permanent". We have supported "re-registration by voting and "beennial registration" for the last two legislative sessions, and I think we should continue to use these terms. Recently there has been a great deal of discussion of the driver's license system. We can use this analogy when explaining our position as this is something everyone knows about and can understand. We have appreciated your letters in regard to State Program Making and the Permanent State Office.

At our most recent rounds of Unit Meetings our members discussed both and I thought you would be interested in the outcome.

In regard to the Permanent State Office, our League took a position two years ago in support of such an office, preferably in Austin, and to be set up as soon as financially feasible. We felt it should perform its present functions and it should be in a place where it could have the PR value of being where the public and legislators could find it easily, i.e. Austin. In our most recent discussions, our members reaffirmed their position.

We too are in agreement that we should not overload ourselves with new program items in this coming year. The League of Women Voters of Baytown believes that while a permanent state office is a necessary and desirable objective, we cannot afford it at this time; we further believe that when a permanent state office is established, it should be located in Austin.

We hope your League agrees with us and will support our move at Convention this spring. We plan the following:

- I. A request for sufficient time on the agenda for debate on this important matter.
- II. A request to Joan Ramey, Chairman of the PSO Board committee, to include in her cost comparison report (due in November) a cost estimate on a legislative office in Austin, which would be necessary if the state office were in Dallas.

In support of our stand we offer the following arguments:

- 1. We cannot afford the big additional expense of a permanent state office at a time when we are skimping on other things.
- 2. The P ublic relations value of a PSO cannot be overlooked. In fact this is a prime reason for esta blishing a PSO. The League is an organization concerned with government and should be visible in the state capitol, thus making us accessible to legislators and other governmental officials, and vice-versa.
- 3. Location in A ustin would eliminate the need for a separate legislative office.
- 4. While Austin is not the center of League population, it does have a sufficient number of members to draw upon within reasonable travelling distance for staffing the office and Board.
- 5. Texas is a large state which cannot be reasonably compared with any other state. Distances from state capitals to center of League population are much smaller in other states. Austin is roughly the geographical center of the state, located approximately midway between the three largest cities in Texas.

- The Houston-Gulf Coast area has the largest League population and convenience to these Leagues should not be overlooked in selecting a PSO site. A ustin is 160 miles from Houston, Dallas is 240 miles.
- The dangers of an office suployee running the organization have been exaggerated. Areas of responsibility can be clearly defined. Hired personnel can be fired.

Please let us know if you agree with us. A my suggestions or criticisms will be welcomed.

In Garland there are two sources of electric power, a municipally owned company and Texas Power and Light Company. You may have read in the past year or so that some of the Garland city ordinances governing the power companies were declared unconstitutional. Negotiations between the two companies have been going on, but as yet no agreement has been publicized. We are hoping that you have some information that will help to give us a more objective view of this sort of situation, as we have been informed that your city also has two sources of power and that there seems to be no problem there. This is still a very controversial situation here, and in order to neither gloss over the whole thing nor to find ourselves in the middle of the conflict, we would like to know more of how other cities are operating. If you do not have information already available, we are not asking you to add more work to what we know is already a crowded schedule, but we surely would appreciate whatever light you might shed on our problem. Dear Mrs. Heaberlin:

I am enclosing a recent clipping to illustrate that Lubbock does have a problem with our two power companies. The difficulty lies in the fact that expansion of the public facilities depends on approval of bond issues. Bond issues have been defeated twice within the last year and a half. Current proposals include the suggestion that the public power company "divorce itself" from politics and be run by a public utilities commission. So you can see, from the standpoint of a trouble-free situation, we in Lubbock have no room to talk.

However, from our handbook on local government, the following excerpt might be of help to you in serving as a guide as you write your Know Your Town Survey.

"The Lubbock Power and Light Company is administered by the Public Utilities Division of the city of Lubbock. ... The Lubbock Power and Light and Water Company is financed by the sale of electricity and water. The revenues are used for debt retirement, for operating the utilities, and for the general fund. Of the total city general revenue funds, 17.4% comes from electric revenues and 18.2% comes from water revenues... The State of Texas does not regulate municipal utilities; this is left to the discretion of the city. The City Council determines utility rates for water and electricity... A comprehensive plan, projected for 15 years, has been drawn for the city's utility needs. This plan is updated every five years. A feasibility study to determine future needs and timing for additional electric generation facilities is to be completed soon... The water collection and the electric collection offices were combined in 1964 to eliminate duplication of purchasing and accounting procedures. The department services bills for 60,905 electric and water meters monthly...

"ELECTRIC DEPARTMENT: Electricity is generated within the city at three municipal power plants. Five steam-turbo generating units supply approximately 64% of the total generation. The Holly Avenue Station (completed in 1965, has both a steam-turbo generator and a gas-turbo generator), supplies approximately 35% of the total power required by Lubbock Power and Light customers. The diesel department is used for standaby purposes to provide peaking end/or emergency power. An auxiliary function of the diesel department is to staff and maintain a machine shop

which serves all city departments requiring metal or machine work.

"Electric revenues total approximately \$4,780,000 or 29.4% of the total 1965-66 budget. Of the electric revenues: 15.6% goes to electric debt services, 26.9% to general fund, and 57.5% to electrical operations. The appropriations for electric promotion was increased approximately 22% over the past year. The electric promotion budget of \$143,166.00 for 1965-66 is designed to provide a more aggressive promotion and advertising program for Lubbock Power and Light Company.

"The Electric Addility Board consults on policies, practices, rates, services, and future planning for expansion of service of Lubbock Power and Light system.

"The Texas Utilities Company began electric service in Lubbock in 1915. This company served Palinview, Lubbock and Lockney. The Southwestern Public Service Company was the first independent operating company to come out of the Holding Company Act in 1942. The Lubbock Municipal Power and Light System began service in January, 1916. Diesel engines and generators produced the necessary kilowatts until 1949 when the first steam-turbo generators were installed.

"The Lubbock Power and Light Company has approximately 1,120 miles of distribution circuits, 16 substations, and 26 miles of transmission line."

It has occured to me, while typing the above, that this article which appeared on May 21, more fully explains the problems as they exist now in Lubbock. I would appreciate it if you would return this clipping, because I will need it in my files to answer questions when this thing comes up again for discussion or a possible vote.

Keep in mind that our Local Handbook came out in the Fall of 1966, so it is already out of date, in some respects.

I wish you wall in your efforts to write your survey and become a League in full standing. Let me know if I can be of further help to you.
