## Minutes

Board of Regents Special Meeting April 24, 1976

M187. The Board of Regents of Texas Tech University met in special session on April 24, 1976 at 10:40 a.m. in the Board of Regents Suite in the Administration Building. M188. Mr. Bucy gave the report for the Finance Committee and explained that Dr. Murray had made a comprehensive presentation and explanation of the proposed budget, and the Board had fully discussed it. Upon motion made by Mr. Bucy, seconded by Mr. Collins, the Board by unanimous vote approved the following

Resolution: BE IT RESOLVED, that the Board of Regents of Texas Tech University approves the FY 1977 budget for Texas Tech University and Texas Tech University Museum as presented. Mr. Formby stated that he thought it would be good to have special sessions for discussion of the budgets, and Mr. Bucy suggested that it would also be helpful to consider special sessions on the Legislative Budget requests.

M189. Mr. Formby announced that the Board had been invited to attend a luncheon with the Ex-Students Association at 12:15 in the University Center.

M190. Mr. Formby then made the following statement: "The Board of Regents now having been duly convened in open session, and statutory notice of this meeting of the Board of Regents having been duly given to the Secretary of State, I, as Chairman of the Board of Regents, hereby publicly announce an Executive Session of the Board to be held in compliance with Article 6252-17 Texas Civil Statutes, and this Executive Session is specifically authorized by Section 2 - Paragraphs E, F, and G, of the Statute." The Board did not reconvene in open meeeting following the Executive Session.
