

HOW TO ORDER PUBLICATIONS FROM

THE LEAGUE OF WOMEN VOTERS OF TEXAS 612 North 18th Street, Waco, Texas, 76707

IF YOU ARE NOT A LEAGUE MEMBER:

Orders must be prepaid unless credit has been established. Enclose your check or money order for the correct amount. Give quantity, description and name and address of person or organization to receive the shipment. Major postage costs will be billed. Freight will be shipped collect.

IF YOU ARE A LEAGUE MEMBER:

It is recommended that League publications be ordered through your Publications Chairman on order blanks furnished free, and that your orders be made up in quadruplicate, one for your Publications Chairman, one for your Treasurer and two to State Office. Please include name of League, name of person ordering, name and address of person to receive the shipment, and give any special shipping instructions. Otherwise all shipments will go by the least expensive means.

ON ALL ORDERS:

No material may be returned for credit unless an error has been made in filling your order. Shortages in shipments must be reported immediately-otherwise no adjustments can be made.

DUPLICATE PRESIDENTS' MAILING:

Copies of all mailings sent to the local League president, unless otherwise specified on her copy, will be sent to the vice-presidents and publications chairmen automatically. Since the price will vary with the amount of material included, consult the local treasurer regarding cost.

STANDING ORDERS:

Sent to local Boards approximately four (4) times a year. Check with your local League Treasurer for costs. Number sent changes only when a local Board notifies State Office of such change. Every local Board member should receive a Standing Order. These are sent in a package to one local Board person, usually the Publications Chairman, to be distributed as soon as possible by mail or in person to the other Board members.





Since Field Service to the local Leagues is such an important tatal Board responsibility, I felt that each of you should see what is being sent to the Consultants at the beginning of the 1967-1968 League year.

So this is just a * for your information" memo.....and enclosure.

TO: Field Service Personnel - Consultants for Local Leagues

FROM: Casperson

RE: Field Service business for immediate attention

Welcome to the 1967 - 1968 Consultant Roster. There are 15 of us this year which will mean that the 37 local Leagues, the one Provisional and the one Regional Leagues can look forward to receiving unusually fine Consultant service. We have the challenge and opportunity of combining the very important Board Training and the year 'round consulting as needed, with the warm and perhaps even more important area of establishing personal relationships and communication between Field Service, State Board, local League Boards and the membership of the LWV of Texas.

Enclosed are pertinent LL Annual Report Sheets on Local, State and National Program for each Consultant. Not all reports were complete for last year. You are receiving what we have. After Board Training times with your League(s), return the Local Program sheets to me and the State and National report sheets to Ruth Martin.

THESE ARE THE MATTERS WE ALL NEED TO EXPEDITE JUST AS SOON AS POSSIBLE

- 1) Attached is a list of recommended materials for Field Service Consultants to take with them for Board Training. You may wish to expand this or you may wish to take a bit less. Do check the list and if you do not have copies in your files, notify State Office immediately so that they may be sent to you...or ordered or prepared for you if not in stock.
- 2) Send on any Local League files from last year that go to another Consultant for this year. Please notify me when these are transmitted with a cc to SO. The complete Consultant's file for each League is to be turned into SO (or where directed) at the end of the year this includes the provided materials.
- 3) If you have not yet heard from your assigned Local League(s), do get in touch with them right away to start making arrangements for dates for Board Training. These spring weeks go by quickly and new Presidents are inundated with "what to do next", so this will help them if they aren't sure how to go about setting it up. Ask them for a first and second choice for the 2 day training period.
- 4) Several Leagues have already verified their Board Training dates. As you make final arrangements, let me know where you will be going and on what dates. (Please send carbon copies to SO and FSSS Braunagel). This will allow for a Field Service Board Training Master Calendar to be charted. If emergencies arise that you need help with in connection with meeting planned schedules...again, let me know.
- 5) As required by State Board Policy, all Consultants do receive training before working with the Local League Boards. These training sessions have either been held or are arranged for, and we hope that all goes as scheduled in connection with this important requirement.
- 6) The five off-Board Consultants will receive the National Duplicate President's Mailing. You will also receive all State Board mailings which are pertinent (this will obviously exclude SB "housekeeping details").

7) All consultants will be: a) furnished materials b) reimbursed for total hotel or motel bills (Commercial rates are sometimes available and it's recommended that you ask about these rates) c) reimbursed for meals at the rate of \$1 for breakfast, \$1.50 for lunch and \$2.50 for dinner d) reimbursed for travel expenses. That we travel at the most reasonable rate we can manage hardly needs to be mentioned! Travel allowance is 8¢ per mile when using your car. Send your expense voucher to the State Treasurer with cc to me and to SO.

REPORTING BACK THROUGHOUT THE YEAR

- 1) The outline form for reporting Local League Board Training is on page 4 of your Handbook for FS Consultants. Use underlined headings for each area listed. It will make your work easier and be of greatest benefit to State Board members. Remember "warm" notes are the easiest ones to write up! All FS Reports are sent to SO....double-spaced, please.
- 2) State Board decision was to follow the directive at the bottom of page 4 and to not include names in the reports. This means that each of us will need to keep the lists of local Board members at hand to make identification with individuals as the reports are read. An exception will be an added area for reporting: DEVELOPING LEADERSHIP. This will necessarily be a name, background, present responsibility, etc. report, and in past years proved most helpful to the Nominating Committee and the State Board.
 - 3) During Presidents' Workshop at Council, LL Presidents were asked to write in <u>UNITS</u> above Membership on Page 15 of the President's Handbook (suggested schedule for 2 day Board Training). Add this to your copy also. Some Leagues combine the two portfolios, but most of them do not and time should be allotted separately for the two items.
 - 4) You will be sent instructions concerning the specific areas we will want reports about before each State Board meeting. The 2 day Training Reports will, of course, be all that is needed before the June Board meeting. Because of the statewide membership drive and contest, this will be an area you will want to closely in your Leagues. Correspondence, Voters, and Minutes give you the background for the Field Service reports during the balance of the year.
 - 5) State Board Policy Sheet states that a carbon copy of all correspondence with a local League will also be sent to State Board member(s) living in that town or city as well as to SO and to me. In most instances, you will want to make the first mentioned a blind copy.
 - 6) Each Consultant please check to see that no local League is carrying portfolio chairmen with a State CA or CR designation. The Board lists they were filled out were in error in listing them at all. With our State Program Single List, they should have chairmen for Item I Legislature; II TCR; etc. etc. Please see they correct this in their own files so that when Program Making time comes we will not have confusion about the status of State Program items.
 - 7) There is a possibility that the Consultant's Handbook will be updated before next year. After using it this spring, please send me any suggestions concerning what you would like to see retained, included, changed, etc.

I can't attend a June 6-8 Board meeting as we'll be in Cambridge for Tom's graduation from M.I.T. at that time.

As far as I'm concerned the trouble with this date is not because of my duties as secretary, for I assume you can get someone to be secretary pro tem, but rather with my assignment as Area Conference chairman. The June Board meeting was to be the one at which the Board decisions were made about the conference so that we could avoid the pitfalls regarding arrangements, material, assignments, etc., which experience has shown are inevitable when major planning for the conference is left until the September Board meeting.

Since I can't attend a June 6-8 Board meeting and since major planning for the conference should be done there, it might be better, Ruth, to replace me as conference chairman with a Board member who will attend the June 6-8 meeting. I'd like to try my hand at the chairmanship, but if in view of the circumstances you decide to replace me I'll certainly understand.

Satting the date for the June Board meeting was a very difficult decision to make at the post Council Board meeting, but the date we came up with—June 27-29—was the one that accommodated the most people. My idea would be, therefore, to keep that time but change the place. It's the time that determines who can come to Board meeting, not the place where it is held, so if a change has to be made I think it should be in the place not the time. In the Houston metropolitan area there must be many locations where we could meet June 27-29 that would involve about the same amount of mileage for Board members as would the Continental.

Austin and Waco could also be considered as meeting places. A thought occurs to me-if Mrs. McKinley will have to come from Odessa for a June 6-8 meeting but would have moved to Killeen by the June 27-29 date we'd save \$60 on her transportation (Katie's fare from Midland to Austin for Education Fund Trustees meetings was \$65)....And last Nevember I had a perfectly comfortable single room at the Driskill for \$5.00:

It looks as if this is one of those times when we're between the rock and the hard place, but having the Board meeting at a time that is accommodating to the most members, even though it might cost a little more, does seem to me to be the best solution possible.

Dear Mrs. Luker:

The name of the book on special districts that I told you of on Monday is: Special Districts and Authorities in Texas, by Woodworth G. Thrombley, published in 1959 by the Institute of Public Affairs, University of Texas. It is a paperback with 123 pages of text, plus appendices and bibliography.

Appendix B lists water districts in Texas as of February 1959, as nearly as could be determined, and shows Brazos County Water Control and Improvement District #2 and Brazos County Water Control and Improvement District #5. Brazos County is also within the jurisdiction of the Brazos River Authority, which is a regional type of special district. Page 634 of the 1966-67 Texas Almanac lists the 21 directors of the Authority, and one is Travis T. Bryan Jr. of Bryan. The general manager is shown as Col. Walter J. Wells, who would probably be a source of brochures, etc. about the Authority.

Mr. Thrombley speaks of the impossibility of knowing how many and what water districts are in existence at any particular time, and it may well be that the two Brazos County WCID's are no longer extant. On the other hand, new ones may have been formed. Also it's quite possible that none of these districts includes territory within the boundaries of Bryan and College Station.

Bryan and College Station are almost certainly in a soil conservation district, of which there are 183 in Texas, covering about 99% of the state (Texas Almanac 1966-67). And people at A & M would be a prime source of information.

Other types of special districts Thrombley considers in his book, besides soil conservation districts and the many types of water districts, are: hospital districts, public housing and urban renewal districts, and some minor districts. He does not include school districts in his book.

I enjoyed very much meeting you, and I do hope the Know Your Town survey proceeds smoothly.



One was to reproduce 5000 copies of the LWV of Topeka flyer for the area conferences with the details being left to the committee. Another was to price this flyer as close as possible to what it costs us. The third was that Membership be the main committee to be dealing with members-at-large. The Board agreed also, (but without a motion) that the Membership Committee could have, as part of the "take home" kit for the area conferences a 6-page tool on "You-the Member", "You-the Discussion Leader", "You-the Recorder", and two report forms. The Board agreed, also, that Helen could contact the dropped members-at-large and invite them to the area conferences.

Neither Membership nor Publications recommended that membersat-large receive FOREIGN AID AT THE CROSSROADS. Publications recommended, and the Board agreed, that each member-at-large receive BLUEPRINT FOR PLANNING, TEXAS CONSTITUTIONAL REVIEW, national publications catalog, new state publications catalog, local publications catalog when it is published, 25 of the November 8th VOTERS GUIDES, state program flipchart, and other state program material as it comes out.

To hear once a week about what is going on in the state office would not only give me information but would also increase rapport and understanding. And the same sort of report once a month to local League presidents—a report that tells them what's going on and only in exceptional cases requests anything of them—would increase their understanding of what the state League does and why and show them that we're all working on the same jobs they and their Leagues are doing, only on a different scale.

I feel also that the appearance of much that has gone out from the state office does not do us credit nor give the impression that we are careful or imaginative workmen. For example, in the 17 pages of the Jume post-Board report I noticed 19 errors, all of which would be apparent to a good many of our readers and some, at least, to all of them. (And I was just reading, I wasn't proof-reading.) Eleven of these were misspellings, letters omitted, and extra letters put in. Three were wrong words: "Dallon" and "McClendon" counties for Dallam and McLennan, and "State Convention" for Presidents' Council on the Treasurer's Quarterly Report. Five were words left out, including the line for Total Income in the Treasurer's Quarterly Report; a missing word (probably "have") in "Hints from Helen"; and the price on the order blank for the November Voters Guides. And there is the big "boo-boo" in the August duplicate Presidents' mailing where the Miscellaneous Fact Sheet starts on page 1 and continues on page 3 instead of page 2, with page 2 being used for a separate article.

Reader appeal is also a matter of layout, and there, too, it seems to me that we're not putting our best foot forward. Generally, we appear to be crowding too much onto a page, I'd say, by using too little margin at the bottom of the page and, in the

post-Board report, too few spaces between the sections to set them off from each other and enhance their effectiveness. Side margins of 7/8" or 1" on both sides of a sheet look well and give room for 3-hole punching. Contrast the appearance, so far as side margins are concerned, between the first page and the second page (on the reverse of page 1) of your memo of July 1966 to local League presidents and representatives re Meeting on Inter-League Councils. The position of the heading (Standing Order, post-Board Report, etc.) in the upper right corner is another part of layout that could be improved, I think, by setting it closer to the top of the page than the page number and title. (In the tabulation on State and National Support that came with the post-Board report, the heading looked as if it were the heading for the Balance column!)

I do hope we can have colored paper again, each color associated with certain portfolios, and a supply of paper in each color that has the stenciled heading of our name and address. Both of these add greatly to the attractiveness of our material and differentiate it from material of other Leagues. I know this would cost additional money, and that it would have cost money to scrap the botched Miscellaneous Fact Sheets of the August mailing and rerun them in proper sequence. But shouldn't decisions like this be based primarily on PR value? And if we keep good communication and good public relations uppermost in our contacts with the local Leagues, are not they more likely to understand and support an increased budget for the state League?

One more matter has been bothering me—the billing to local Leagues for the returned TEXAS VOTERS of their members. This seems to me to be very bad public relations and productive of so little money (\$1.40 from 12 Leagues for returned May VOTERS, if I remember correctly) that it is negligible as an economy measure. (National, I understand, sends a notice of wrong addresses to the local Leagues, but does not bill them, considering instead that the return postage cost is a part of National's expense of doing business.) My third, and most basic, objection to charging the local Leagues is that this is a matter of policy which should be decided by the Board.

On the general subject of rubs and misunderstandings among the Board it seems to me that there are bound to be some, and I'd suggest, therefore, that there be a half hour or an hour, say, at the start of each Board meeting for an unofficial, informal session at which things could be talked over.

As I'm sure you've guessed by now, my suggestion for our training by National Board members Mrs. Law and Mrs. Morgan is the whole broad field of communications and public relations as related to the state Board and the local Leagues.

August 27, 1966 Mrs. William E. Joor. Dear Ruth: I'm so glad you sent your memo of August 10th, "A Plan and a Pledge". Your courage, perceptiveness and candor in writing it sets a good example for all of us. It seems to me that our troubles result chiefly from a lack of communication. I'm using the word "communication" in a very broad sense -- to mean not only what we write and say and how clearly and tactfully we write and say it, but also how often we communicate and the appearance of our communications. In a state the size of Texas we have to rely mostly upon the written word for communication with local Leagues and among state Board members also. For informal communication between Board members we needn't be too particular about some of the criteria I'm about to mention, but otherwise, it seems to me, we do need to practice what I'd call good communication. To my mind, good communication entails very thoughtful consideration of what is to be written, particularly from the standpoint of the recipientwill she take it as we mean it? do we show that we are thinking from her viewpoint as well as our own? do we communicate often enough so that she feels she is kept in touch, or does she feel that she hears from us only when we want her to do something? are our communications so attractive looking and neatly turned out that she wants to read them? Communications which I consider to be too infrequent are the "S O S" (State Office Story) and the Letter to Local League Presidents. To hear once a week about what is going on in the state office would not only give me information but would also increase rapport and understanding. And the same sort of report once a month to local League presidents -- a report that tells them what's going on and only in exceptional cases requests anything of them-would increase their understanding of what the state League does and why and show them that we're all working on the same jobs they and their Leagues are doing, only on a different scale. I feel also that the appearance of much that has gone out from the state office does not do us credit nor give the impression that we are careful or imaginative workers. For example, in the 17 pages of the June post-Board report I noticed 19 errors, all of which would be apparent to a good many of our readers and some, at least, to all of them. (And I was just reading, I wasn't proof-reading.) Eleven of these were misspellings, letters omitted, and extra letters put in. Three were wrong words: "Dallen" and "McClendon" counties for Dallam and McLennan, and "State Convention" for Presidents' Council on the Treasurer's Quarterly Report. Five were words left out, including the line for Total Income in the Treasurer's Quarterly Report; a missing word (probably "have") in "Hints from Melen"; and the price on the order blank for the November Voters Guides. And there is the big "boo-boo" in the August duplicate Presidents' smiling where the Miscellaneous Fact Sheet starts on page 1 and continues on page 3 instead of page 2, with page 2 being used for a separate article. Reader appeal is also a matter of layout, and there, too, it seems to me that we're not putting our best foot forward. Generally, we appear to be crowding too much onto a page, I'd say, by using too little margin at the bottom of the page and, in the

post-Beard report, too few spaces between the sections to set them off from each other and enhance their effectiveness. Side margins of 7/8" or 1" on both sides of a sheet look well and give room for 3-hole punching. Contrast the appearance, so far as side margins are concerned, between the first page and the second page (on the reverse of page 1) of your memo of July 1966 to local League presidents and representatives re Meeting on Inter-League Councils. The position of the heading (Standing Order, post-Board Report, etc.) in the upper right corner is another part of layout that could be improved, I think, by setting it closer to the top of the page than the page number and title. (In the tabulation on State and National Support that came with the post-Board report, the heading looked as if it were the heading for the Balance column:)

I do have strong feelings about problems, however, and hope I can express my point of view without being accused of partisanship toward one person or another. I do not expect to be "rum" by anyone, and any point of view I take will be strictly my own. If I do not agree, I will say so, and vice versa. What I wish to avoid like the plague are cliques or schisms on the Board.

So if you have problems, please talk them over with me. Let me know what is troubling you and let us see if it can be straightened out quickly before any festering wound results. I do not wish to live in an ivory tower believing everything is sweetness and light -- if it is not.

I am proud of the state Board of 1966-68. Let us make the coming years stimulating, enjoyable and rewarding ones, with a minimum of friction.

RE: Board Orientation - Thursday night, March 19,1964. From 8:45-9:30 P.M.

It's a funny thing - there seems to be a first time for everything - even when you've been in League work as long as I have been. When I realized that I had been given 45 minutes to help orient the new members in the way of the State Board and to recall with the others some things that may have slipped their minds, I felt like a novice - and I still do!

In Field Service we keep telling the LL Boards that if each member would read and know what is in the LL Handbook there would be little need for FS to do anything. This 45 minutes couldn't possibly take the place of reading the State Handbook - the counterpart of the LL Handbook - but because you just may not get around to reading it from cover to cover, mind you before your first official Board meeting tomorrow morning, let's see if we can talk about some things that will help you get started.

There are similarities between local and state Board service - for instance: 1) your first responsibility is to the total planning for the work to be done. To make this easier and to give you experience, each of you will be assigned to several committees this year - and to different ones next year and soon you will have a much wider knowledge of most of the portfolios. Serving on a committee will indoctrinate you thoroughly in what is called "the onion skin routine" which substitutes really for not being able to pick up the telephone to do committee business nor to be able to have committee meetings often. You write your message - or comments - and send onion skin carbons to each committee member and the President.

2) You make regular written reports to each Board meeting - these written reports are to be in SO for mimeographing at least ten days before the Board meeting - then all the reports are sent to you - along with the agenda about a week before the Board meets. It is your individual responsibility to tell the President - well in advance - that you want and need Board time. Always bring these reports and the minutes with you to Board meeting. One of the most valuable contributions you can make to the quality of Board discussion is to have read each Board report before you come to the meeting.

YOU'll need at least - one big fat notebook - a punch - and stapler (this to me has been business's greatest contribution to League Board life.!)

- 3) You maintain the non-partisan policy of the LWV with complete sincerity.
- 4) You recognize that the important things that go on in Board meeting are confidential (this still leaves you some things to talk about outside the meeting!)
- 5) You don't criticize the League to outsiders:

There are also some dissimilarities from local Board service:

- 1) You are not on this Board to represent YOUR League as tempting and as worthy a crusade as this may be you represent THE LEAGUE local, state and national. If you feel you're losing your identity you are somewhat but much of it gets restored during the social hours and when you are with your roommate!
- 2) Some of you will be doing Field Service and this is a VERY interesting assignment and it is surely the best way to learn about other Leagues (the better to plan

for them). For those of you who don't do FS, the reports will be prepared for each League for each Board meeting and these, plus the fact that each of you will get the Voters from every League will help every Board member to know the Leagues better - and remember your responsibility to develop and maintain effective Leagues.

3) Local League Board members are encouraged by FS to write their counterpart on the State Board for assistance. Such letters are to be answered within ten days - with copies sent to SO and the Area FS chairman. This is part of the whole area of interboard communication - -or between Board meetings - and this is a most important matteryou'll probably deside how you want to do it at an early meeting. Each Board member's business should be a matter of common knowledge to the entire Board (page 10-SHB).

As soon as you can, look in the note book passed on to you to see if there are copies of these things in it:

- 1. State Handbook, Local League Handbook and Organizing Leagues.
- 2. State and National BYLAWS
- 3. Policy Guide for Members of the State Board
- 4. Tips for New State Board Members
 - a. You will attend 4 Board meetings a year and before you leave here you will know when and where they will be.
- 5. State and National Publications Catalogues
- 6. Important Dates with Your Postman and the year's Calendar
- 7. You will receive a Special National Subscription Service
- 8. You will receive the State SO that goes to the LLs and the State Board reports.
- 9 Each week you will get a copy of "Collection Basket" new and happy feature of Mrs. Brown's administration it's a sort of summary of the week's events in State Office (a counterpart to the currently popular TV show "That was the Week the Was")

By the June Board meeting you will know what your notebook lacks - assuming, of course, that there is agreement on what should be in them. LL Presidents have a list of what should be in their notebooks - maybe there is need for something like this for State Board members.

Oftentimes the most useful part of any orientation results from discussing questions that may have occurred to you, so I'll close this part now by quoting directly from the SHB:

"The description of a Good Board member in the LLH applies to State as well as Local Boards. State Boards are information-giving idea people, ready with plenty of practical advice on how-to, and sometimes on how-not-to. In essence their achievement is a product of experience - well laced with imagination and served with a generous portion of encouragement. One gentle reminder - The LWV is composed of members joined together in voluntary association."

Those attending the meeting were: Dallas - Mrs. Sam R. Faris, President, Mrs. Ralph I. Bubis, Vice-President, and Mrs. Henry Lanz, Vice-President; Denton- Mrs. Alton C. Donsbach, President, Mrs. Richard Hampleman, Vice President, and Mrs. H. R. Dalrymple, Vice-President; Irving - Mrs. Raymond J. Belken, President, Mrs. Douglas Hilchie, Vice-President, Mrs. Carl Schwind, Vice-President, and Mrs. J. T. Vaughan, Mr., Finance Chairman; Richardson - Mrs. Chas. Connors, President, and Mrs. Carl Aichholtz, Vice-President; State Board - Mrs. Raymond Freedman, Mrs. E. R. Brownscombe and Mrs. S. E. Ziegler, chairman of the meeting. Fort Worth was unable to send representatives.

Introduction -

At Presidents' Council after the Voters Service "Little Meetings", the presidents of the Richardson and Irving Leagues suggested that they meet together with Dallas to exchange ideas and discuss possible cooperation in various areas of League work. The idea grew to include Denton and Fort Worth, notable cooperators with the other three Leagues. At the invitation of Mrs. Ziegler the group met for a 10:00 A.M. - 2:00 P.M. meeting, with lunch, on May 17th, at her home. Fort Worth was unable to attend, to the regret of all.

Mrs. Ziegler opened the meeting by complimenting the Leagues on their past and current cooperation. She mentioned that in keeping with general League policy the decisions made at this meeting would not be binding on future Boards.

It was decided to discuss cooperation in the following areas: Tegislative activities; local, state and national program; finance (including public relations as related to finance); and unit leader training.

Legislative Activities -

The desire to cooperate in legislative activities was expressed by all three Dallas County Leagues. Almost all of the discussion was on state legislative work, but the possibility of joint interviewing of the Dallas County congressman and the congressmanat-large was also mentioned. Two plans of operation were discussed: (1) a group composed of a representative from each League initiating and maintaining contact with each of the legislators, or (2), as suggested by Irving, each League concentrating on different legislators, interviewing them, contacting them about legislation, etc. The advantage of the first plan is that all three Leagues would have contacts with all legislators from the county, and that making their calls as a delegation of three would save legislators' time (as contrasted with three individual calls) and would demonstrate the collective strength of the Leagues of Dallas County. The advantage of the second plan is that by concentrating on a few legislators, each League would be better acquainted with those men and, presumably, be in a more influential position with them. It was agreed that with legislators varying as they do, both plans might advantageously be followed, one with some legislators, the other with others. Dallas has tried this year within its own League a plan similar to Irving's suggestion. Each unit group has "adopted" a legislator. The legislative chairman telephones each unit leader to ask her to write and ask her group to write to "their" man or men when legislative action is called for. It is not known how successful this is in getting letters written to legislators.

Richardson initiated discussion of legislative activity when the legislative chairman is off Board. Dallas' chairman was on Board last year through most of the current legislative session, but because of personal circumstances the same legislative chairman if off Board this year. Dallas felt this was working satisfactorily because the chairman both years is the same person and had been on the Board during most of the session. The comment was made that an on Board legislative chairman is better able to get her fellow Board members to write to legislators than is, usually, an off Board chairman who probably would not have as close personal association with the Board. It was pointed out, however, that this situation would be less the case in a smaller League where the whole group of active members, Board and non-Board, would probably be well acquainted with each other.

In discussing how Dallas, Irving and Richardson might work together in legislative matters, all three Leagues stressed the value of keeping in touch with each other. It was agreed that communications should go through the League presidents, with they, in turn, passing them on to their legislative chairmen.

Dallas feels that they have done quite well with the new legislators--those who are presently serving their first term--but that they have worked less well with the "old" ones. Dallas asked for ideas on working with the latter. It was suggested that it might help to have the three Leagues join forces in contacting these men.

In a general discussion of legislative effectiveness, Denton pointed out the value of League members writing as individuals or as members of a group other than the League. The president of the League writes for the League, and the legislator, who has a good idea of the League's membership, figures that number of voters are watching him on the issue. If a League member then writes and says she is a member of the League, she does not add to this total, but if she writes as an individual she does add to it, and if it is legitimate for her to write and mention another organization she may add more to the total in the legislator's calculation.

There was general praise for the communications from the legislative chairman of the State Board. Particularly praised was her evaluation of the factors affecting legislators' actions regarding poll tax repeal and annual voter registration. Greatly appreciated, too, was her careful analysis of the points to be considered in determining League support of non-support of the poll tax repeal amendment. There were several comments to the effect that she had made a complex subject understandable and had appreciably enlarged our legislative education.

In discussing the question of how soon should we contact our newly elected legislators, Denton commented that they should be contacted right after they are elected, for the purpose of getting acquainted and leaving literature, as that is when they have the most time for reading. Once the session starts there is little time to read, even the bills. Mrs. Hampleman cited a couple of instances where one of their legislators supported a bill because of material he'd been given soon after he was elected.

Dallas didn't know how successful, legislatively speaking, had been the dinner last November, in a private home, for the legislators and their wives and an equal number of League members and their husbands. It had presented many difficulties in planning in addition to the usual one of how many legislators will actually attend. Several League members and their husbands had to hold themselves available to attend at last minute notice, and League members expecting to attend understood that they might not do so if the number of legislators coming decreased. All League members concerned were carefully briefed on our legislative program, and there was discussion, also, of conversational tactics, etc.

Fort Worth meets with their legislators after the end of the session to express appreciation of their support of League measures and to hear about the session from the legislators themselves. A similar meeting with the three Dallas County Leagues as hostesses was discussed.

Since there are many fields in which the Leagues can cooperate, Dallas suggested an area committee of the five Leagues to oversee all types of cooperation. Mrs. Ziegler felt that this would be a little too formal, rather similar to a County Council, and would have the disadvantage of adding another layer of League "government." Other forms for cooperating were explored--notices in VOTERs, letters between presidents, a separate joint committee for each occasion of cooperation, etc.

The upshot of the discussion was that there will be a meeting in June of the legislative chairmen and presidents of the three Dallas County Leagues (Dallas, Irving and Richardson) to explore further and perhaps plan a meeting with Dallas County legislators after the end of the session. Mrs. Schwind will call the meeting.

Program - Local, State and National -

It was agreed that the president or program vice-president of each of the Dallas County Leagues will let the other League presidents know of any county items that will be, or are likely to be, proposed for local program.

Dallas foresaw that situations could arise in which one League might be unhappy over the program choice of another. What would be the responsibilities of the two Leagues in such a case? Could one League, to put it bluntly, exercise a veto over another's choice of program? The trend of the discussion indicated that such a situation is unlikely to develop, but that if it were to, the chance for settlement agreeable to both Leagues would be increased by letting Leagues know as soon as possible of any prospective county item (the county being the local program area in which the three Leagues have a joint concern).

Discussed also was the situation in which two Leagues might have studied the same county item and come up with opposed consensus. Denton pointed out that if two Leagues study the same situation at the same time and arrive at conflicting consensus positions, then the material used by both Leagues should be re-examined:

The Leagues will make a special effort to keep each other informed of their meetings, especially on state-local relations and the national items. Dallas invited the other Leagues to send representatives to resource committee meetings, briefing sessions, etc. (Both Irving and Richardson representatives attended State-Local Relations resource committee meetings last year and were thought of as members of the committee, receiving notices of meetings, committee-prepared material, agendas, etc.) Denton would not be able to regularly attend, because of distance, but last year had attended some of Dallas' Human Resources and East-West Trade resource committee meetings. Dallas mentioned that the calendar for the month, in a box on the first page of each issue of the VOTER, carried a notice of all meetings.

Dallas spoke of the proposed go-see tour of the new Dallas County courthouse, scheduled for January 19, 1966, and invited the attendance of Richardson and Irving.

As cooperation progresses, it was felt that there may develop joint preparation of resource or every-member material or of plans for unit meetings on state and national program items. The problems of meshing the program calendars of the three Leagues were briefly mentioned. Mrs. Ziegler mentioned that there could be cooperation in doing the local survey for the National Human Resources item, to save duplication of interviewing.

Finance -

Among problems discussed were:

- 1. When to contact business contributors so as to get on their budgets. Irving mentioned that the time is now for some contributors, and that a League can frequently find what the proper time is by asking the public relations department of the company concerned. Irving said that Wyatt Food Stores asks for a letter in November to submit to their Board in order to get a donation during the first quarter of the year.
- 2. What companies allow their branches to donate, and for what companies is it necessary to apply to headquarters? No answers were forthcoming at the meeting, but it was agreed that answers should be sought by the local Leagues.
- 3. Overlapping between Leagues in regard to contributors. This is an increasing problem in a metropolitan area. Two examples were given: Sanger-Harris with several department stores in Dallas and one in Irving; and Bell Helicopter, in Hurst between Dallas and Fort Worth. It was agreed that each League should try to get contributions from companies that have branches in their areas and that there should be prior consultation on all such cases, among the interested Leagues.

There was agreement on the close relationship between public relations and finance. Irving, recognizing this, is going to have a combined meeting of its PR and finance people this summer. Denton has run commendations of the League from various Dentonites as paid ads in the town newspaper. Reprints were in the finance workers' kits. Irving Finance people called on Irving business men for advice on contacting contributors. All of these business men increased their own contributions!

More coordination between the finance drives of the three Dallas County Leagues was discussed, and having all the drives begin on the same day was talked of. It was felt, however, that to have them all in the same month (February) as is presently done, was as close timing as is feasible.

There will be further discussion of finance at a meeting to which the presidents and finance chairmen of the Dallas, Irving and Richardson Leagues will be invited. Mrs. J. T. Vaughan, Jr., of Irving, will call the meeting, which will be for the purpose of going over finance lists, exchanging information, etc.

Unit Leader Training -

Dallas is doing unit leader training on September 24th, <u>after</u> the first unit meetings. It was felt that the leaders would then have more practical experience of the problems they will meet than would be the case with training before units have had meetings. The training session will be in the home of the unit organization director. Unit secretaries and the Board will not be present. Dallas talent will be used for the training.

Mrs. Ziegler reported that the Fort Worth League would like a meeting this summer on discussion training. Irving and Richardson will bring the matter to their Boards and send their Board recommendations to the State League.

Conclusion -

The participants appreciated and enjoyed the meeting. It was agreed that a meeting of this kind should be held once a year, after the new Boards come into office.
