MINUTES OF BOARD OF DIRECTORS MEETING DECEMBER 7, 1963

- 184. The Board of Directors of Texas Technological College met in regular session in the Office of the President on Saturday, December 7, 1963, at 9:30 a.m. The following directors were present: Chairman DeBusk, Vice Chairman Smith, Mr. Allison, Mr. Armstrong, Mr. Furr, Mr. Hinn, Mr. Mathews, and Mr. McLaughlin. In addition, President Goodwin, Vice President for Academic Affairs Pearce, Vice President for Business Affairs Pennington, and Secretary Wells were present.
- 185. Upon motion made by Mr. Mathews, seconded by Mr. McLaughlin, the Board by a unanimous vote approved the Minutes of the November 1, 1963, Board meeting.
- 186. Upon motion by Mr. Allison, seconded by Mr. Smith, the Board by a unanimous vote approved the agenda under the date of November 26, 1963. A copy of the approved agenda is attached and made a part of the Minutes. (Items No. 134 through No. 183, Attachment No. 1; and Items No. 2840 through No. 3012, Attachment No. 1A.)
- 187. Mr. McLaughlin, Chairman of the Academic Programs Committee, gave a report of the committee's meeting of December 6. He stated that each Board member would receive a copy of the minutes of all future meetings of the Council of Deans and that this would keep the Board informed concerning the addition and deletion of courses.

The committee and the Board concurred in a recommendation made by Dr. William M. Pearce, Vice President for Academic Affairs, that the annual catalog contain the courses to be offered during the academic year following the publication of the catalog, the courses required on student degree plans for the second academic year following the publication of the catalog, and all courses necessary to meet the minimum accreditation requirements of the various accreditation and professional groups. A complete listing of all approved courses will be kept up to date in the Office of the Registrar.

188. Dr. William M. Pearce, Vice President for Academic Affairs, made the following statement concerning the annual meeting of the Southern Association of Colleges and Schools:

"At its annual meeting in Memphis, Tennessee, December 1-5, 1963, the Southern Association of Colleges and Schools approved the Institutional Self-Study completed at Texas Technological College in November 1962. Satisfactory completion of this program is a requirement for continuing accreditation by the Association."

189. Dr. William M. Pearce, Vice President for Academic Affairs, made the following statement concerning the visitation from the National Council for Accreditation of Teacher Education:

"During the period November 11-13, 1963, an evaluation team representing the National Council for Accreditation of Teacher Education visited Texas Technological College for the purpose of examining the institution's teacher education program. The findings of this nine-member team will be reported to the National Council and will constitute the basis for the Council's decision on the accreditation of Texas Tech's teacher education program.

"Concurrent with the NCATE team's visit was a revisitation by four representatives of the Texas Education Agency; this group examined the teacher certification programs of the institution.

"The written reports of neither group have been received by the College."

190. The Campus and Building Committee of the Board met on Friday morning, December 6, 1963, at 11:00 a.m. in the Office of the President to consider recommendations from the Campus Planning Committee and to formulate recommendations to be made to the Board on Saturday morning, December 7, 1963. The next six (6) items, No. 191 through No. 196, will record the official action of the Board following the recommendations of the Campus and Building Committee.

- 191. Upon motion made by Mr. Smith, seconded by Mr. Furr, the Board by a unanimous vote approved the extension of the opening of bids for the Consolidated Food Service Units and the Central Food Facilities, designated as HHFA Project No. CH-Tex-180(S), until December 11, 1963, and instructed the Campus Planning Committee to mail to each Board member the tabulation of bids and recommendations of the Campus Planning Committee; to call each Board member for his vote on the contract award; and to recess the Board meeting at the close of business until after the award of a contract and/or contracts on the above designated project.
- 192. Following the request of the Board, the bids for the Consolidated Food Service Units and the Central Food Facilities, designated as HHFA Project No. CH-Tex-180(S), were mailed to each Board member along with the recommendation of the Campus Planning Committee that a contract be awarded to J. R. Francis, General Contractor, Inc., El Paso, Texas, the low bidder, in the amount of \$1,477,866.05 which included the acceptance of the alternates to delete the covered walkways and the paved courtyards. On December 20 and 21, 1963, Mr. M. L. Pennington, Vice President for Business Affairs, called each Board member by telephone for a vote on the recommendation for a contract award.

The Board by a majority vote awarded a contract to J. R. Francis, General Contractor, Inc., El Paso, Texas, in the amount of \$1,477,866.05. A copy of a memorandum from Mr. M. L. Pennington, Vice President for Business Affairs, recording the vote of each Board member is attached and made a part of the Minutes. Attachment No. 29. A copy of the tabulation of bids for general construction is attached and made a part of the Minutes. Attachment No. 22. A copy of the tabulation of bids for the mechanical and electrical construction is attached and made a part of the Minutes. Attachment No. 23. A copy of the tabulation of bids for the kitchen equipment is attached and made a part of the Minutes. Attachment No. 24. A copy of the tabulation of bids for the bakery equipment and material handling equipment is attached and made a part of the Minutes. Attachment No. 25. A summary copy of the tabulation of the low bids for the kitchen equipment, the bakery equipment, and the materials handling equipment is attached and made a part of the Minutes. Attachment No. 26. summary copy of tabulation of bids for the two low bidders is attached and made a part of the Minutes. Attachment No. 27. A detail analysis sheet showing a comparison of the bids of the two low bidders is attached and made a part of the Minutes. Attachment No. 28.

- 193. Upon motion made by Mr. Smith, seconded by Mr. Armstrong, the Board by a unanimous vote approved the sale of the frame building used for the nursery school to H. A. Padgett, Lubbock, Texas, contractor for the Texas Tech College Bookstore addition, for the sum of \$1,000.00, with the understanding that he will remove the building from the campus.
- 194. Upon motion made by Mr. Smith, seconded by Mr. Hinn, the Board by a unanimous vote approved a contract with the Texas Highway Department, whereby the highway department will create five pits in the existing plaza lake at the northwest corner of the College farm and authorized the Chairman to sign the agreement for the College. The material from the pits, which are to be dug according to specifications, will be used as fill on the adjacent highway. The highway department will pay the College three cents (3ϕ) per cubic yard for the material. A copy of the agreement is on file in the Office of the Secretary of the Board.
- 195. Upon motion made by Mr. Smith, seconded by Mr. Hinn, the Board by a unanimous vote approved the purchase of chairs for the Speech Auditorium from the American Seating Company. The chair selected was subject to the final approval of Mr. Armstrong and his committee.

In keeping with the final approval by Mr. Armstrong and his committee, the American Seating Company was awarded the order for 308 22" chairs and 84 21" chairs, making a total of 329 fixed chairs at a total cost of \$12,963.44. In addition to the fixed chairs, 75 folding chairs will be purchased from Abel Stationers for a total cost of \$1,800.00. A copy of the tabulation of bids (original submission) is attached and made a part of the Minutes. Attachment No. 20.

196. The Board by a unanimous vote by a telephone poll on December 20-21, 1963, awarded a contract to the Texas Scenic Company, San Antonio, Texas, for the stage rigging for the auditorium in the new Speech Building for an approximate cost of \$26,133.00, the final amount to be determined by the final

- 197. Upon motion made by Mr. Smith, seconded by Mr. Allison, the Board by a unanimous vote designated land not to exceed fifteen acres located south of Fourth Street and on Indiana extended for a future site for the Texas Technological College Museum. It was understood that the metes and bounds would be determined at a later date but this action would reserve the site for future development.
- 198. Upon motion made by Mr. Hinn, seconded by Mr. Mathews, the Board by a unanimous vote requested the College administration to make a study to determine the possibility of entering into one contract with the City of Lubbock to cover both water and electricity.
- 199. Upon motion made by Mr. Hinn, seconded by Mr. Smith, the Board by a unanimous vote adopted a resolution in memory of Mr. Seth Thomas Cummings, Purchasing Agent, Emeritus. A copy of the resolution is attached and made a part of the Minutes. Attachment No. 14.
- 200. Upon motion made by Mr. Smith, seconded by Mr. Furr, the Board by a unanimous vote approved a contract with Sharpe's Sandwiches, Lubbock, Texas, for sandwich concession in the Texas Technological College residence halls for the period November 17, 1963, through August 31, 1965. A copy of the contract is attached and made a part of the Minutes. Attachment No. 18. This is in keeping with Item No. 112, Board Minutes of November 1, 1963.
- 201. Upon motion made by Mr. Allison, seconded by Mr. Hinn, the Board by a unanimous vote authorized the College to enter into a contract with the Department of Health, Education and Welfare, Office of Education, Washington, D. C., under the provisions of Title VI, Part B, Section 611, of the National Defense Education Act for the support of a modern foreign language institute during the summer of 1964, under the direction of Mr. Alfred B. Strehli, and authorized the President and/or the Vice President for Business Affairs to sign any and all papers for the College. The institute will be for secondary school teachers of Spanish and will be conducted at Tucuman, Argentina. A letter from Dr. Kenneth W. Mildenberger, Office of Education, Washington, D. C., is attached and made a part of the Minutes. Attachment No. 19.
- 202. Upon motion made by Mr. Mathews, seconded by Mr. Allison, the Board by a unanimous vote accepted a grant in the amount of \$30,000.00 from The Robert A. Welch Foundation, Houston 2, Texas, for the support of the Organized Research Project "Cyanoethylation and Related Reactions" for the period May 1, 1964, through April 30, 1966. This is a renewal of Grant No. D-070 to support the research of Dr. Joe A. Adamcik, Associate Professor of Chemistry. (Account No. 391-3591; first year, \$15,000.00; second year, \$15,000.00.)
- 203. Upon motion made by Mr. Mathews, seconded by Mr. Allison, the Board by a unanimous vote accepted a grant in the amount of \$30,000.00 from The Robert A. Welch Foundation, Houston 2, Texas, for the support of the Organized Research Project "Synthesis of Complex Compounds of Rhenium" for the period May 1, 1964, through April 30, 1966. This is a renewal of Grant No. D-097 to support the research of Dr. Richard J. Thompson, Assistant Professor of Chemistry. (Account No. 391-3611; first year, \$15,000.00; second year, \$15,000.00.)
- 204. Upon motion made by Mr. Mathews, seconded by Mr. Allison, the Board by a unanimous vote accepted a grant in the amount of \$15,000.00 from The Robert A. Welch Foundation, Houston 2, Texas, for the support of the Organized Research Project "A Thermochemical Study of Some Acids and Bases in Fused Onium Salts" for the period May 1, 1964, through April 30, 1965. This is a renewal of Grant No. D-075 to support the research of Dr. Wesley W. Wendlandt, Professor of Chemistry. (Account No. 391-3621.)
- 205. Upon motion made by Mr. Mathews, seconded by Mr. Allison, the Board by a unanimous vote accepted a grant in the amount of \$45,000.00 from The Robert A. Welch Foundation, Houston 2, Texas, for the support of the

- 206. Upon motion made by Mr. Mathews, seconded by Mr. McLaughlin, the Board by a unanimous vote approved integration of athletics at Texas Technological College.
- 207. Mr. Armstrong gave an informational report on the work of the Committee of Governing Boards.
- 208. Mr. W. H. Butterfield, Vice President for Development, gave a brief report on the work of his office.
- 209. The meeting recessed at 11:08 a.m. with the understanding that the meeting would be officially adjourned following a telephone poll concerning the award of a contract for the Consolidated Food Service Units and the Central Food Facilities. This poll was completed on December 21, 1963, at which time the meeting officially adjourned until the next meeting on February 15, 1964, in the Office of the President, Texas Technological College, Lubbock, Texas.

Dear Dr. Goodwin:

An unusual opportunity for strengthening the administration of agricultural research and education programs at Texas Tech has been presented to me by the Cooperative State Experiment Station Division of USDA. This is a request to serve as Consultant for "Intensive Reviews of Agricultural Research" in several states and in Washington, D. C.

The period of requested services would be February 10 to August 31, 1964. The states visited (approximately 10) would be selected by me. The time spent in Washington, D. C. would be concerned with review and evaluation of research reports on studies conducted in the Nations Agricultural Experiment Stations, primarily in the Range, Forage and Livestock Field.

During the period of this temporary assignment, if approved, I would develop a Texas Tech Research Project to study:

- 1) The relationship of research and resident instruction in the states visited.
- 2) The administration of agricultural research and education programs.
- 3) Opportunities for new research or improvement of procedures as applicable to Texas Tech's School of Agriculture.

The U. S. Department of Agriculture would pay my salary up to the equivalent annual rate of \$15,655, which is their maximum for such a temporary assignment. This would mean a salary loss to me of approximately \$600 which I would hope to obtain from Tech in support of the research proposal mentioned above. All travel expenses would be borne by USDA. Many indirect benefits to Texas Tech could result from this assignment with the contacts made in Washington and the states visited.

Since this proposal offered such an excellent opportunity I have checked into the required adjustments here on our staff during the Spring Semester and Summer period:

Page 2, Dr. R. C. Goodwin, November 14, 1963

- 1. Dr. Bennett would take charge as Associate Dean.
- 2. Dr. Elle would move back into the office as Assistant Dean.
- 3. Mr. Urbanovsky believes he can hire temporary help to replace Dr. Elle during the Spring Semester.

I have discussed this proposal with Dr. Pearce and will welcome the opportunity to meet with you at your convenience. Because of the late date an early decision will be required.

WHEREAS, the College is desirous of making available and the Vendor is desirous of supplying requirements of sandwiches for the purpose of sale on the premises of the College located at Lubbock, Texas;

NOW, THEREFORE, in consideration of the premises and promises herein contained, the parties agree that:

- 1. The Vendor will install on the premises of the College, at locations specified by the College, a minimum of one (1) manually-operated sandwich-vending machine in each residence hall on the campus. All machines installed must be adequate in size and must be new or a relatively recent model so as to compare favorably in appearance and performance with the best machines available.
- 2. By mutual consent, additional machines over and above the minimum specified may be installed.
- 3. Subject to the conditions outlined in Paragraph 10 hereof, title to the vending machines shall remain the property of the Vendor. The Vendor shall install the machines in conformity with all Federal, State and local building and other applicable laws.
- 4. The Vendor shall have the right to enter upon the premises of the College at all reasonable times for the purpose of servicing and inspecting said machines and for removal of such machines upon the termination of this contract. The Vendor shall service the machines as many times per day as necessary to keep the vending machines properly supplied with sandwiches and in good working order. It is understood that the machines in the women's residence halls will be serviced from 11 a.m. to 3 p.m. or at other times acceptable to the College. The Vendor shall be required to keep the vending machines and the areas adjacent thereto in neat and sanitary condition at all times. The Vendor shall protect college property during the servicing of machines.
- 5. All sandwiches supplied by the Vendor shall conform in all respects to all State and Federal laws relating to the adulteration of food and drink and, in all respects, shall be suitable for human consumption; and the Vendor will indemnify the College for all or any damage suffered by it for breach of said warranty.
- 6. The Vendor will indemnify the College against any damages or claims arising from the negligence of the Vendor, its agents and employees. In addition, the Vendor will be required to carry property damage and public liability insurance in appropriate amounts as agreed with the College.
- 7. The College will promptly notify the Vendor in writing of any claims made against it arising out of a breach of said warranty, and such claims shall be handled by the Vendor. In the event of a suit on a claim, the College shall promptly forward to the Vendor every summons or other process. The Vendor shall have a right to defend, adjust or settle any such claims. No expense shall be incurred and no settlement shall be attempted without the Vendor's written consent.
- 8. The College reserves the right to install other vending machines such as milk, ice cream and soft drink, anywhere on the campus it so desires, including educational buildings.

- 9. All sandwiches shall be sold for thirty-five cents (35¢) each. The College reserves the right to install vending machines at any location where the Vendor will not agree to place a vending machine. The College will receive 15 percent (15%) of gross sales, and the Vendor guarantees \$2,756.25 annually for the period of this contract.
- Vendor agrees to submit monthly sworn statements showing proper accounting details in accordance with this contract within ten (10) days after the end of each month. Simultaneously with the submission of a sworn statement, the Vendor shall make payment to the College. The Vendor shall render such reports in a manner acceptable to the College and shall further permit the College to make any reasonable auditing check which it desires of the operation. The amount of the minimum annual guarantee shall accrue and be payable one-twelfth (1/12) each month, with excess payments in any month over and above the minimum guarantee to be credited against the accumulated minimum guarantee. The College shall retain a lien on the machines pending payment of the guarantee or any balance due under this contract.
- 11. This contract shall become effective November 17, 1963, and shall expire on August 31, 1965. This contract may be extended from year to year thereafter, upon the agreement of both parties.
- 12. The College reserves the right to cancel this contract on ten (10) days written notice if the Vendor fails to comply with any of the foregoing stipulations.
- 13. This contract is not transferable or assignable except upon written approval of the College.

I am pleased to inform you of our intent to enter into a contract with Texas Technological College under the provisions of Title VI, Part B, Section 611 of the National Defense Education Act for the conduct of a Modern Foreign Language Institute during the summer of 1964, under the direction of Professor Alfred B. Strehli, in accordance with your attached proposal. You are authorized to begin the preliminary preparation of the institute effective December 4, 1963, and to spend up to but not exceeding \$3,000 for the cost of travel and per diem for the Director to attend conferences called for by this Office, procurement of office supplies, publicity, salaries and related benefits for the Director, and secretarial assistance.

Dr. D. Lee Hamilton, Director, Language Development Branch, through Mr. F. H. Hundemer, Jr., Program Officer, and Dr. James M. Spillane, Chief, Language Institute Section will work with you and your staff to complete the negotiations of a mutually acceptable Plan of Operation. Upon completion of the negotiations a formal cost reimbursement contract will then be sent to your institution for signature. The contract period will be from December 4, 1963, through October 31, 1964.

After the date of this letter contract and until a definitive contract is negotiated, the parties shall be governed by the terms and conditions as set forth in the attached instrument. This instrument includes several of the clauses which appear in the standard definitive contract used by the Office of Education in contracting for Language Institutes.

In the event that this letter contract is not superseded by a definitive contract, the contractor shall be compensated in accordance with Article 9 of the attached instrument, but not to exceed the amount reflected in paragraph one above.

This letter contract shall expire on February 15, 1964, unless superseded by a definitive contract prior to such date.

We appreciate your cooperation and willingness to make the resources of Texas Technological College available for furthering the Language Development Program. If you agree to proceed with the institute on December 4, 1963, within the limitation of the amount specified and the terms of this letter, it is requested that you sign the enclosed copy on the line designated and return it no later than December 2, 1963.

At the meeting of the Campus Planning Committee on December 19, 1963, the members voted to recommend the acceptance of the alternates to delete the paved courtyards and the covered walks, which would make J. R. Francis, General Contractor, Inc., of El Paso, the low bidder, in the amount of \$1,477,866.05.

In keeping with the arrangements made at the last meeting of the Board of Directors, the members of the Board were polled by phone on the recommendation of the Campus Planning Committee, and the voting was as follows:

(All members voted for the project, and the "No" votes are for the covered walkways only. The covered walkways determined the low bidder.)
