October 26, 1951

The Board of Directors of Texas Technological College met in regular session in the Office of the President, Texas Technological College, Lubbock, Texas, at 9:30 A.M. Saturday, October 27, 1951. The following were present: Directors Thompson, Chairman, Weymouth, Benson, Pfluger, Wooldridge, McLaughlin, Abbott and Price, President Wiggins, Vice President Jones, Comptroller Pennington, Secretary Gaston, and Assistant Secretary Wells.

- 355. President Wiggins presented the agenda under the date of October 12, 1951, and recommended its approval. Upon motion made by Mr. Price, seconded by Mr. Weymouth, the Board approved the first nine pages of the agenda (Items 231 to 354, inclusive). A copy of the agenda is attached and made a part of these minutes. Attachment No. 1.
- 356. Upon motion made by Mr. Weymouth, seconded by Mr. Ince, the Board ratified the AGREEMENT BETWEEN TEXAS TECHNOLOGICAL COLLEGE AND THE UNITED STATES OF AMERICA FOR USE OF PORTIONS OF PANTEX ORDNANCE PLANT DURING OCCUPANCY UNDER RIGHT OF POSSESSION BY THE UNITED STATES GOVERNMENT. A copy of the Agreement is attached. Attachment No. 2.
- 357. Upon motion made by Mr. Ince, seconded by Mr. Abbott, the Board approved the purchase, by the Library, of three copies of THE INTER-NATIONAL LIVESTOCK YEARBOOK from Mr. Ray C. Mowery, Professor of Animal Husbandry, at a cost of \$2.00 per copy.
- 358. Upon motion made by Mr. Ince, seconded by Mr. Abbott, the Board approved an additional expenditure for the necessary materials to complete the electrical system in the Greenhouses in the amount of \$103.40 and approved an appropriation from the Texas Technological College Building Fund of \$103.40 to cover the cost. The items are listed on Attachment No. 3.
 - 359. Upon motion made by Mr. Price, seconded by Mr. Abbott, the Board approved an addition to the contract of The Empire Electric Company, for electrical work, on the addition to the Administration Building, in the amount of \$60.18. The breakdown of the items is given on Attachment No. 4.
 - 360. Upon motion made by Mr. Weymouth, seconded by Mr. Pfluger, the Board approved an appropriation from the Unappropriated Balance of \$237.34 to pay Mr. David C. Pfeiffer, Dallas, Texas, for work on the gas distribution system (September 1951) as authorized by the Board on August 11, 1951. (Item 1373, 8-11-51).
 - 361. Upon motion made by Mr. McLaughlin, seconded by Mr. Weymouth, the Board approved an extra to the New Engineering Building in the amount of \$339.60 to Anthony Company, Lubbock, Texas, for connecting water lines to the New Engineering Building. This will not be an addition to R. F. Ball's contract on the building, nor will it be included in the amount used to determine the architects' fees.
 - 362. Upon motion made by Mr. Weymouth, seconded by Mr. Price, the Board gave President Wiggins and Dean Holcomb permission to dispose of a 2-C Sykes Gear Cutting Machine, which is no longer suitable for classroom use, provided it is possible to do so under the terms of the acquisition agreement.
- 363. Upon motion made by Mr. Weymouth, seconded by Mr. Pfluger, the Board gave Comptroller Pennington permission to get the necessary work done on the electrical relays in the powerhouse and charge the cost of the work to the Power Plant Maintenance Account. The Maintenance Account is to be reimbursed from the Unappropriated Surplus after all work has been completed a Count of the Count of th

364. Upon motion made by Mr. McLaughlin, seconded by Mr. Benson, the Board adopted a Resolution certifying to the State Comptroller of Texas the Compliance, on the part of Texas Technological College, with the provisions of Article IV, Section 20 of House Bill Number 426. A copy of the Resolution is attached. Attachment No. 5.

- 365. Chairman Thompson appointed Dr. Wiggins, Mr. Benson and Mr. Pennington, members of a special committee, to discuss with the proper officials of the City of Lubbock the question of paving certain streets adjacent to Texas Technological College property. This committee was requested to make a report at the next Board meeting.
- 366. Upon motion made by Mr. Abbott, seconded by Mr. Benson, the Board approved an Out-of-State leave for Dr. Carl C. Rister, Distinguished Professor of History, to represent Texas Technological College and to participate in the annual meeting of the American Historical Association and Mississippi Valley Historical Association, meeting jointly in New York City, New York, December 26-30, 1951; and appropriated from the Unappropriated Balance \$325.00 to the Department of History Maintenance Account to cover the expenses of the trip.
- 367. President Wiggins presented Dr. Carl Coke Rister, Distinguished Professor of History, to the members of the Board. President Wiggins stated that Dr. Rister had been requested to write A HISTORY OF THE INDEPENDENT OIL INDUSTRY OF THE UNITED STATES by representatives of the Independent Oil Industry. Upon motion made by Mr. Ince, seconded by Mr. McLaughlin, the Board gave Dr. Rister permission to proceed with the research project referred to above.
- 368. Upon motion made by Mr. Ince, seconded by Mr. Price, the Board awarded a contract to Mr. W. H. Abbott, Jr., Lubbock, Texas, for the Mechanical remodeling of the Old Engineering Building at a cost not to exceed \$39.697.16; a contract to American Electric Company, Lubbock, Texas, for the electrical work in the Old Engineering Building at an estimated cost of \$69,533.00 and appropriated from Texas Technological College Building Fund \$109,500.00 to cover the cost of remodeling and re-conditioning the Old Engineering Building. Dean Holcomb stated that the College hopes to receive a special grant and/or discount from the General Electric Company on some of the materials and parts used in building and assembling the switchgear equipment. The American Electric Company would, in turn, be able to cut the cost of the building and assembling the switchgear equipment below the estimate of \$26,503.00 which was used in arriving at the Electrical contract figure of \$69,533.00 and that all savings on the American Electric Company contract, effected as a result of special consideration to the College by the General Electric Company, would be credited to the College.
- 369. Chairman Thompson requested the Local Affairs Committee of the Board and President Wiggins to investigate the various possibilities of getting a new electric score board for the Athletic Field. (Local Affairs Committee: Mr. Ince, Mr. Abbott and Mr. Benson.)
- 370. Upon motion made by Mr. Ince, seconded by Mr. Benson, the Board accepted and expressed its appreciation to Mr. C. T. McLaughlin for the beautiful painting presented to Texas Technological College by the GHEN TO THE MUSEUM Diamond M. Foundation.

Adjournment - - - The Board adjourned at 11:10 A.M., Saturday, October 27, 1951, until its next meeting on Saturday, December 1, 1951, to be held at 9:30 A.M. in the Office of the President, Texas Technological College, Lubbock, Texas.

AGREEMENT FOR USE OF PORTIONS OF PANTEX ORDNANCE PLANT DURING OCCUPANCY UNDER RIGHT OF POSSESSION

THIS AGREEMENT made and entered into this 20 day of September,

A.D., 1951, by and between TEXAS TECHNOLOGICAL COLLEGE, a corporation
organized and existing under the laws of the State of Texas, with principal offices in Lubbock County, Lubbock, Texas, hereinafter sometimes
called the College, and the UNITED STATES OF AMERICA, represented by the
Contracting Officer executing this agreement, hereinafter sometimes
called the Government.

WITNESSETH:

WHEREAS, the Deed executed on 1 April, 1949, in which and whereby the Government conveyed to the Texas Technological College the hereinafter described lands, tenements, appurtenances and facilities for educational purposes, provided, among other things as a condition to its execution, that during the existence of any National Emergency the United States of America or its agencies shall have the right of repossession of said property, and the full and unrestricted use thereof, and without charge prior to expiration of 20 years from the date of said instrument; and

WHEREAS, the President of the United States, by proclamation on the 16th day of December 1950, declared the existence of a National Emergency, which National Emergency has not been, terminated; and

WHEREAS, pursuant to said proclamation and the existence of Emergency, the Secretary of the Army, by letter dated 16 February 1951, notified the President of the Texas Technological College that the Government had elected to exercise its right under the provision of said Deed, and would repossess and use the property hereinafter described.

NOW THEREFORE, pursuant to the terms and conditions of said Deed and the notice aforesaid, it is mutually agreed by and between the parties hereto as follows:

1. Beginning on the date specified in Paragraph 2 hereof, the Government shall have the full, unrestricted use, possession and control of the following described property, except as hereafter specifically provided:

Gibson 50, 51, 54, and 55; the $N_{\overline{2}}^1 N_{\overline{2}}^1 N_{\overline{2}}^2$ of Section 56, all in John H. Gibson 5urvey; also the South 437.2 acres of the M. F. Wright Survey No. 7,

and that part of the Lyman Brewer Survey No. $6\frac{1}{2}$ described as follows: Beginning at a point in the East line of said Lyman Brewer Survey No. $6\frac{1}{2}$ which point is 660 feet South of the NW corner of Section 56 of the John H. Gibson Survey; thence West to the West line of Lyman Brewer Survey; thence North along the West line of said Lyman Brewer Survey to the NW corner thereof; thence line of said Lyman Brewer Survey to the NE corner therof; East along the North line of said Survey to the NE corner therof; thence South along the East line of said Lyman Brewer Survey No. $6\frac{1}{2}$ and the West line of Sections 55 and 56 of the John H. Gibson Survey to the point of beginning. The entire area comprises survey to the point of beginning. The entire area comprises approximately 7,890 acres of land, in Carson County, Texas, being land on which is located the vital portion of the Plant;

Also,

A tract or parcel of land in Sections Nos. 56, 57, 58, and 64, in Block T. B. S. & F. Survey, Carson County, Texas, described as follows:

The East 900 feet of the $S_{\overline{2}}^{1}$ of Section 56, all of Section 57, the West 3200 feet of the South 2400 feet of Section 58, and the West 3200 feet of the North 2800 feet of Section 64, containing 1,077.1 acres, more or less, being land comprising the major portion of the Sewage Disposal Area;

Also the following described land, the interest of which consists of perpetual easements:

For Sewage Disposal

A strip of land 100 feet wide lying in Sections Nos. 68, 67, and 66, Block T. A. B.& M. Survey, Carson County, Texas, and being 50 feet on each side of the following described center line:

Beginning at a point in South boundary line of Section 68, which is 2368 feet West of Southeast corner therof; thence North 275.3 feet; thence Northeasterly along a curve the radius of which is 696.34 feet, a distance of 766.2 feet; thence North 63 degrees 06 minutes East to East line of Section 68 and continuing in the same direction through Sections Nos. 67 and 66 a total distance of 11,081.6 feet to a point in North boundary line of Section 66, which point is 1723 feet East of Northwest corner of said Section 66.

Also 15 feet on each side of the following described center line in Section 56, Block T. B. & F. Survey, Carson County, Texas;

Beginning at a point in South Boundary line of said Section 56, which point is 1677.5 feet East of Southwest corner thereof, thence North 63 degrees 06 minutes East a distance of 3083.2 feet to a point which is 900 feet West and 1394.74 feet North of Southeast corner of said Section 56.

For Drainage Ditch

Also a tract of land out of Section 68, being 20 feet on each side of the following described center line:

Beginning at a point 2550 feet West and 30 feet North of Southeast corner of Section 68, thence North 825 feet.

For Sewage Effluent

All the right, title and interest of the Grantor in and to that certain Contract dated March 18, 1943, by and between Louise A. Callaghin and husband, Asbery A. Callaghin, and the United States of America; said property covering the No Section 56, Block T. B. S. & F. Survey.

For Gas Pipe Line

Section 1 and the $S^{\frac{1}{2}}$ and $NE^{\frac{1}{4}}$ of Section 21 and the $SE^{\frac{1}{4}}$ of Section Section 1 and SE $\frac{1}{4}$ of Section 25 and the SW $\frac{1}{4}$ and NE $\frac{1}{4}$ and the SE $\frac{1}{4}$ 22, and the SE $\frac{1}{4}$ of Section 26 and all of the NW $\frac{1}{4}$ of Section 27 lying North of the Panhandle & Santa Fe Railroad Company right of way in Block 2, A. B. & M. Survey and the E_2^1 of Section 1, Block 1, B. S. & F. Survey all located in Carson or Potter counties, State of Texas, together with all the right, title and interest of the United States Government in and to an Order of the Board of County Commissioners of Potter County, Texas dated July 6, 1942, authorizing the use to cross and occupy all of the section lines, highways and other public roads granted the Cities Service Gas Company of Bartlesville, Oklahoma, and assigned by said Company to the United States of America, covering portions of roads and highways in said County as fully set forth and described in said Order, reference being hereto made to said Order as if fully set out herein and together with all of the Government's right, title and interest in and to a pipe line License dated October 5, 1949, granted to the United States Government by the Panhandle & Santa Fe Railroad Company covering the land as fully described therein, reference being hereto made to said pipe line License as if fully set out herein, subject to the approval of the Licensor, Panhandle & Santa Fe Railroad Company.

- 2. The Government shall have the use of the premises without the payment of rental beginning 16 February 1951, and continuing for so long as required by the Government during the existence of the aforesaid National Emergency, provided, however, should the Government's use of the premises under this agreement extend beyond twenty years from the date of the said Deed, the Government shall thereafter pay a fair rental established as of that date for possession and use of the property.
- 3. That all personal property and all equipment owned by the College and all facilities constructed by it without Federal aid or without the aid of Federal funds, may be removed from the premises and said College shall have a reasonable time in which to effect the removal of such property.
- 4. That the personal property listed on Exhibit "A" to the real estate transfer from the Government to the Texas Technological College does not come within the scope of this repossession of said premises and facilities. It is understood that accountability for and disposal of the personal property located upon the premises will be the responsibility of said College under agreement with Federal Security Administration.
- 5. Access to the repossessed areas by means of roads will be confined to the existing roads and ways, or such roads as may hereafter be provided by way of new construction. Access, or ingress and egress across the area retained by the College will not be required by the Government except as otherwise specifically provided herein. The Government agrees that the College will be permitted to utilize rail facilities now

in operation by the Santa Fe Railway System under agreement with the College on the area repossessed by the Government as may be necessary to serve Zone 10 until 1 April 1952. After 1 April 1952 the College agrees to provide rail access to Zone 10 by means other than through the area repossessed by the Government, unless satisfactory arrangements can be effected for such service by means of a contract for switching service over the Government operated trackage.

- 6. That the College and its lessees may harvest growing crops existing on the lands covered by this agreement, and that in the event of the necessity for the destruction of or damage to any part of such crops by the operations of the Government, compensation to the owners thereof will be made.
- 7. That continuous use of said land for agricultural and grazing purposes will be permitted on areas to be designated by the Atomic Energy Commission or its representative, which designations may change from time to time, and neither the Government nor the Atomic Energy Commission will be liable for any damages to crops, livestock, persons, or property on the land used by the College.
- 8. It is further agreed that as of the effective date of this agreement a joint inventory and report showing the physical condition of all property of any nature whatsoever, which, under the terms of this agreement, will be in the possession, control, and use of the Government, shall be made by representatives of the Corps of Engineers, U. S. Army, the Texas Technological College, and the Federal Security Administration; said report is to reflect the condition of such property at the commencement date of this agreement and to be signed on behalf of the parties hereto including the representative or representatives of the Federal Security Administration. Upon termination of this agreement, and return of premises to the College, a Joint Inventory and Condition Report reflecting the conditions of the premises at that time shall be made. At the time the property is returned to the College the Government shall not be required to restore the premises to the condition existing at the time of the repossession thereof under the terms of the Deed of 1 April 1949; and the Government shall not be required to restore any property included in either of the said Joint Inventory and Condition Reports, except as hereinafter provided for in Paragraph 11 of this agreement.

- 9. It is further understood between the parties hereto that electric and gas services on said premises will be segregated and separately metered as of 1 April 1951, with the College assuming responsibility for operation, maintenance and repair of such utility distributing systems located on the area retained by the College as of that date, except for sewage and water mains on such area comprising an integral part of the over-all distribution system; and with the Government assuming operation, maintenance and repair of such utility distributing systems located on the area to be occupied and repossessed by the Government, including also sewage and water mains located on the area retained by the College, which mains comprise an integral part of the over-all distribution system. Any electrical current or gas taken from either the Government's system by the College or from the College's system by the Government for the benefit of either party, its lessees or contractors, will be paid for by reimbursement to the respective parties by separate metering or proportionate charge if separate metering is not feasible. The right of ingress or egress to the area retained by the College is hereby granted the Government, the Atomic Energy Commission or its operating contractor, as may be necessary to inspect, operate, maintain and repair such sewage disposal and water mains.
 - 10. That the Government, the Atomic Energy Commission, or its operating contractor will provide disposal of sewage to the area retained by the College through any existing facilities for distribution as may be required; and will furnish water, through existing distributing system, to the College, to the extent of 20 per cent of the maximum output of the existing five water supply wells for so long a period of time as this amount or any part of it is not required for Government operations. For this water service or water supply and sewage disposal service, the College is to compensate the Government, the Atomic Energy Commission, or its operating contractor, its proportionate share of the cost of furnishing this service. In the event the water supply available to the College under this agreement proves inadequate, the Government agrees to permit the College to drill a well or wells at locations on the area repossessed by the Government at such points as may be designated by the Government, the Atomic Energy Commission, or its operating contractor, which well or wells will be drilled, equipped and operated without cost

to the Government; and the water so produced may be placed in the existing water distributing system, and the equivalent amount of water so placed in the system may be withdrawn by the College in addition to the water supply otherwise specified in this agreement.

- ment, make alterations, attach fixtures and erect additions, structures, or signs in or upon the premises, which fixtures, additions or structures, so placed in, upon, or attached to the premises, shall be and remain the property of the Government and may be removed or otherwise disposed of by the Government. In the event of the removal or otherwise disposal of any of said fixtures, additions, or structures, the structures remaining on the premises at the time of termination of this agreement shall be returned to the College in a reasonably sound condition, and the grounds surrounding said remaining structures left in a workmanlike condition free of debris and refuse.
- 12. The Government may terminate this agreement at any time by giving thirty days notice in writing to the College, provided, however, that the use of the property herein taken, the execution of this agreement or the termination thereof shall in no manner waive, cancel, abridge or release any of the rights reserved to the Government in the aforesaid Deed dated 1 April 1949, should it be determined necessary at any later time to exercise such rights.
- 13. Any notice under the terms of this agreement shall be in writing, signed by a duly authorized representative of the party giving such notice and if given by the Government shall be addressed to the Texas Technological College, Lubbock, Texas, and if given by the College, shall be addressed to the Contracting Officer, Corps of Engineers, United States Army, Tulsa, Oklahoma.
- employed or retained to solicit or secure this contract upon an agreement or understanding for a commission, percentage, brokerage, or contingent fee, excepting bona fide employees or bona fide established commercial or selling agencies maintained by the College for the purpose of securing business. For breach or violation of this warranty the Government shall have the right to annul this agreement without liability, or in its discretion, to deduct from the contract price or consideration the full amount of such commission, percentage, brokerage, or contingent fee.

15. No member of or delegate to Congress or Resident Commissioner shall be admitted to any share or part of this agreement, or to any benefit that may arise therefrom, but this provision shall not be construed to extend to this agreement if made with a corporation for its general benefit.

16. Upon execution by the College and the Government this agreement shall be substituted for and replace, nunc pro tune, an Agreement dated 13 April 1951 between the same parties; and said Agreement of 13 April 1951 shall then have no further force or effect between the said parties thereto.

IN WITNESS WHEREOF, the Texas Technological College has caused this agreement to be signed by Dr. D. M. Wiggins, its President, thereunto authorized by Resolution of its Board of Directors, dated March 28, 1951, and the United States of America, represented by its Contracting Officer, has executed this agreement, as of the day and year first above written.
