Until such time as the Provisional League of Women Voters of Gainesville, Texas is recognized as a local League by the board of the League of Women Voters of the United States, the following changes in the bylaws shall be in effect.

- 1. The word "Provisional" shall be inserted before the word "League" wherever the name "League of Women Voters of Gainesville " appears.
- 2. The two-year term of office as prescribed in Article IV, Sec.1 and Article V, Sec. 1 shall not take effect at the time of election of officers for the provisional period.
- 3. Article II, Sec. 2, first sentence; Article VII, Sec. 2: and Article IX shall be inoperative.
- 4. The word "observer" shall be substituted for "delegate" in Article X.Sec. 1 and 2.

Learue of Jomen Voters of Gainesville

ARTICLE I

Sec.1 Mamo The name of this organization shall be League of Women Voters of Gainesville. This local League is an integral part of the League of Women Voters of the United States and of the League of Women Voters of Gainesville,

ARTICLE II

Sec. 1. urpose The nurpose of the League of Women Voters of Gainesville shall be to promote political responsibility through informed and active participation of citizens in revergment.

Sec.2 clicy The League of Women Voters of Gainesville may take action on local governmental measures and policies in the public interest in conformity with the Trinciples of the League of Women Voters of the United States. It shall not support or oppose any political party or any candidate.

ARTICLE III

- Sec.1. Eligibility. Any person who subscribes to the purpose and policy of the League shall be eligible for membership.
- Sec. 2. Types of Jembership. The membership of the League of Women Voters of Gainesville shall be composed of voting members and associate members.
 - a. Voting members shall be women citizens at least 18 years of age b. Associate members shall be all other members.

ARTICLE IV

Sec.l wher: anner of Selection and Term of Office. The Board of Directors shall consist of the officers of the League, six elected Directors and not more than (the same) appointed Directors. (One-half of elected Directors) shall be elected by the general membership at each Annual secting and shall serve for a term of two years, or until their successors have been elected and qualified. The elected members shall appoint such additional Directors, not exceeding six, as they deem necessart to carry on the work of the League. The term of office of the appointed directors shall be one year and shall expire at the conclusion of the next Annual meeting.

Sec. 2. Qualifications To person shall be elected or appointed or shall continue to serve as an officer or director of this organization unless she is a voting member of the League of Tomen Toters of Gainesville.

Sec. 3 Vacancies Any vacancy occurring in the board of directors by reason of the resignation, death, or disqualification of an officer or elected member may be filled, until the next annual meeting, by a majority vote of the remaining mowbers of the board of directors. Three consecutive absences from a board meeting of any member without a valid reason shall be deemed a resignation.

Sec. 4. Powers and duties The board of directors shall have full charge of the property and business of the organization, with full power and authority to manage and conduct same, subject to the instructions of the general membership. It shall plan and direc the work necessary to carry out the program as adopted by the national convention, the state convention, and the annual meeting. The board shall create and designate such special committees as it may deem necessary.

Sec. 5 lectings There shall be at least nine regular meetings of the board of directors annually. The president may call special meetings of the board of director and shall call a special meeting upon the written request of five members of the board.

Sec. 6. Quorum A majority of the members of the hoard of directors shall constitute a quorum.

ARTICLE V

Sec. 1 Enumeration and Election of Officers. The officers of the League of Women Woters of Gainesville shall be a President, a first Vice resident, a second Vice resident, a Secretary, and a Treasurer who shall be elected for terms of two years by the general membership at an annual meeting and take office immediately. The president, the first vice president, and the secretary shall be elected in odd numbered years. The second vice president and the Treasurer shall be elected in even-numbered years.

Sec.2 The resident, The president shall preside at all meetings of the organization and of the board of directors. She may, in the absence or disability of the treasurer, sign or endorse checks, drafts, and notes. She shall be, ex officio, a member of all committees except the Mominating committee. She shall have such usual powers of supervision and management as may pertain to the office of the president and perform such other duties as may be designated by the board.

Sec. 3. The Vice residents. The **DEO**Vice residents, in the order of their rank, shall, in the event of absence, disability, resignation, or death of the resident, possess all the powers and perform all the duties of that office, until such time as the board of directors shall select on of its members to fill the vacancy. The Vice residents shall perform such other duties as the resident and board may designate.

Sec. The <u>Secretary</u>. The Secretary shall keep minutes of all meetings of the League and of <u>all meetings</u> of the board of directors. She shall notify all officers and directors of their election. She shall sign, with the President, all contracts and other instruments when so authorized by the board and shall perform such other functions as may be incident to her office.

Sec. 5. The Treasurer. The Treasurer shall collect and receive all moneys due. She shall be the custodian of these moneys, shall deposit them in a bank designated by the board of directors, and shall disburse the same only upon order of the board. She shall present statements to the board at their regular meetings and an annual report to the annual meeting.

ARTICLE VI Financial Administration

Sec. 1 Fiscal Year. The fiscal year of the League of Women Voters of Gainesville shall commence on the first day of June each year.

Sec. 2 Dues. * Annual dues of \$ 15 shall be payable June first. Any member who fails to pay her dues within six months after they become payable shall be dropped from the membership rolls.

Sec. 3 Budget. A budget for the ensuing year shall be submitted by the board of directors to the annual meeting for adoption. The budget shall include support for the work of the League as a whole.

Sec. 4. Budget Committee. A budget committee shall be appointed by the board of directors at least two months prior to the annual meeting to prepare a budget for the ensuing year. The proposed budget shall be sent to all members one month before the annual meeting. The treasurer shall not be eligible to serve as chairman of the budget committee.

* Alternate ARTICEL VI, SEC. 2. for Leauge choosing Anniversary Dues.

Sec. 2. Annual Dues of \$ 15.00 shall be payable on the first day of the anniversary month of the member's joining the League. Any member who fails to nav her dues within two months after they become navable shall be dropped from the membership rolls.

- Sec. 1 embership eetings. There shall be at least four meetings of the membership each year. Time and place shall be determined by the board of directors.
- Sec. 2. Annual lecting. An annual meeting shall be held between layl and lay 31, the exact date to be determined by the board of directors. The annual meeting shall
 - a) adopt a local program for the ensuing year.
 - b) elect officers and directors, members of the nominating committee.
 - c) adopt an adequate budget, and
 - d) transact such other business as may properly come before it.
- Sec. 3. Quorum. Ten members shall constitute a quorum at all business meetings of the League of Vomen Voters of Gainesville.

ARTICLE VIII

Wominations and Elections

- Sec.1. Mominating Committee. The nominating committee shall consist of five members, two of whom shall be members of the board of directors. The chairman and two members, who shall not be members of the board, shall be elected at the annual meeting. Mominating Committee. The other members shall be appointed by the current Mominating Committee. The other members shall be appointed by the board of directors immediately following the annual meeting. Any vacancy on the Mominating Committee shall be filled by the board of directors. Suggestions for nominations for officers and directors may be sent to this committee by any voting member.
- Sec. 2. Report of Mominating Committee and Mominations from the Floor. The report of the Mominating Committee of its nominations for officers, directors and the members of the succeeding nominating committee shall be sent to all members one month before the date of the annual meeting. The report of Mominating Committee shall be presented to the annual meeting. Immediately following the presentation of this report, nominations may be made from the floor by any voting member provided the consent of the nominee shall have been secured.
- Sec. 3. Elections. The election shall be by ballot, provided that when there is but one nominee for each office, the seretary may be instructed to cast the ballot for every nominee. A majority vote of those qualified to vote and voting shall constitute an election. Absentee or proxy voting shall not be permitted.

ARTICLE IX

Program

- Sec. 1. Authorization. The governmental principles adopted by the national convention, and supported by the League as a whole, constitute the authorization for the adoption of Irogram.
- Sec. 2. Frogram. The program of the League of Women Voters of Gainesville shall consist of:a) action to protect the right to vote of every citizen, and b) those local governmental issues chosen for concerted study and action.
- Sec. 3. Action by the annual meeting. The annual meeting shall act upon the program using the following procedures:
- a) The board of directors shall consider the recommendations sent in by the voting members two months prior to the annual meeting and shall formulate a proposed program.
- b) The proposed program shall be sent to all members one month before the annual meeting.
- c) A majority vote of voting members present and voting at the annual meeting shall be required for adoption of subjects in the proposed program as presented to the annual meeting by the board of directors.
- d) Recommendations for program submitted by voting members two months prior to the annual meeting but not recommended by the board of directors may be considered by the annual meeting provided that:1. the annual meeting shall order consideration by a majority vote and 2. the annual meeting shall adopt the item by a majority vote.

e) Changes in the program, in the case of altered conditions, may be made provided that: (1) information concerning the proposed changes has been sent to all members at least two weeks prior to a general membership meeting at which the change is to be discussed and (2) final action by the membership is taken at a succeeding meeting.

Sec. 4. 1 ember Action. Tembers may act in the name of the League of Women Voters

only when authorized to do so by the proper Board of Directors.

ARTICLE X

Wational Convention, State Convention, and Council

- Sec. 1 Vational Convention. The Board of Directors at a meeting before the date on which the names of delegates must be sent to the national office shall select delegates to that convention in the number allotted the League of Women Voters of Gainesville under the provisions of the bylaws of the League of Women Voters of the United States.
- Sec. 2. State Convention. The board of directors at a meeting before the date on which the names of delegates must be sent to the state office shall select delegates to that convention in the number alloted the League of Women Voters of Gainesville under the provisions of the bylaws of the League of Women Voters of Texas.
- Sec. 3. State Council. The board of directors at a meeting before the date on which the names of delegates must be sent to the state office shall select delegates to that council in the number allotted the League of Women Voters of Gainesville under the provisions of the bylaws of the League of Women Voters of Texas.

ARTICLE XI Tarliamentary Authority

Sec. 1. Parliamentary Authority. The rules contained in Robert's Rules of Order Newly Revised shall govern the organization in all cases to which they are applicable and in which they are not inconsistent with these bylaws.

ARTICLE XII

Sec. 1. Amendments. These bylaws may be amended by a two-thirds vote of the voting members present and voting at the annual meeting, provided that amendments were submitted to the membership in writing at least one month in advance of the meeting.

The Gainesville League of Women Voters shares the concern of Cooke County

Democratic Chairman Bill Sullivant as quoted in the Gainesville Daily

Register for May 2 -that he is "disappointed that the voters will not have a say in the Democratic party nominee" for State Senator from District 30.

The State Democratic Chairman has asked that the county Democratic chairmen in State Senate District 30 meet on May 14 to select a candidate whose name will appear on the November general election ballot for State Senator. Such action could effectively nullify the effect of the special election which has been called for August 13, 1988 to fill former Senator Ray Farabee's unexpired term.

If the chairman of the thirty counties making up Senate District 30 select a nominee for senator of this district for the term 1989-1992 prior to the scheduled special election of August 13, 1988 (which has been called to fill an unexpired term through December 31, 1988), they will be doing so without knowledge of the people's choice of a candidate.

A chronology of events and projected events is as follows:

December 1987 Senator Ray Farabee filed for re-election to his Senate seat.

March 1988 Senator Ray Farabee resigned from his senate seat to accept another position; this left his senate seat vacant through 12/31/88. His name, however, remains on the November

general election ballot.

April 1988 With a choice between May 7 and August 13, the Governor chose August 13 as the date for the special election. (The winner of this election will serve only until December 31, 1988; the person who serves from 1989 to 1992 must win the November general election.)

August 13, 1988 A special election is scheduled to elect Senator Ray Farabee's replacement through 12/31/88; he plans to remove his name from the November ballot the following day.

Sept. 9, 1988 The Democratic County Chairs and the Republican County Chairs must report their choices for their candidates in the November general election, including that of senator in District 30 for the period 1989-1992.

Sept. 14, 1988 If none of the three announced candidates should win a majority in the special election of Aug. 13, 1988, a run-off for the interim senate seat for the period through Dec. 31, 1988 will be held on this date.

November 8, 1988 General Election

If the county chairman of Senate District 30 do on May 14, 1988 name a candidate for the November general election ballot (an action which is not required until Sept. 9, 1988), the special election scheduled for Aug. 13, 1988 to elect a person to replace Senator Ray Farabee until Dec. 31, 1988 becomes somewhat moot. The Texas Senate is not in session between August 13 and December 31, 1988. In addition, the person who wins the special election, if different from the person selected by the county chiarmen on May 14, would have no opportunity to be considered in the general election of November 8. Finally, the person on the ballot on November 8 may not be the person whom the majority of the voters of Senate District 30 would have selected.

A May 14 decision on a Democratic candidate for the District 30 senatorial seat might be technically legal, but does it meet the "one person one vote" test? Thirty votes from thirty chairmen from counties ranging in population from 5,600 to 125,600 would provide skewed results as far as votes of individuals are concerned.

One of the criteria considered by the League of Women Voters of Texas in determining its position on voting rights is "the impartiality of treatment

for all voters." The local League of Women Voters sincerely hopes that the county chairmen of State Senate District 30 will delay until after August 13, 1988 to name a person for the senate seat on the November general election ballot, thereby respecting the individual voters' rights both technically and ethically.

Something I didn't get done before Christmas was to contact you with regard to the LWV-Gainesville, TX "horror story" about which we learned at the Dallas leadership conference. We were concerned of course, and I asked our Org. V-P Sondra Ferstl to check into it. She did, and sent me a prompt memo about it. At this point I am taking the easy way out and sending you both a copy of it rather than trying to re-explain it.

I agree with Sondra that at this point we should just let sleeping dogs lie. It would appear that there are indeed two sides to the story. Evidently there was poor communication on the part of the local League--which they are now aware of-and some misunderstanding by Mr. Brewer as a result. It was not a debate but merely a forum where several points of view were presented.

In response to your request for further information on the presentation Mel Brewer made to LWV-Gainesville, I phoned the local League president Sandra Currie on Wednesday, December 3. She was present at that particular meeting and gave me her account of the events.

Panelists for the program on liability insurance were contacted by phone. Remember that Mr. Brewer was a substitute for someone else who was to have appeared on the program; he was not contacted personally by the League. I have no way of knowing what information about the format and intent of the program was originally given to the panelists, since I have not spoken with the person responsible for making arrangements for the program. I don't know if the videotaping of the program was discussed at that time. I also did not check with Sandra about whether Brewer was introduced to her and to his "opponents" when he arrived for the program.

Sandra agreed that the format and arrangements for the program were not confirmed in writing and in retrospect it is certainly easy to see how this contributed to the difficult situation. Brewer had a slide presentation to give, and he was first on the program mainly because it was easier to have the equipment ready to go. He arrived early enough to set up his equipment and certainly saw the videocamera ready for action. Sandra does not believe that the lawyers were attacking his position. The program was not presented as a debate and the lawyers were not arguing with him; they were simply presenting other points of view.

Sandra says she sensed Brewer was miffed about something by the way he packed up his equipment at the end of the program: "I felt that he felt uncomfortable." She sensed also that Brewer had expected to give a program for little old ladies in tennis shoes, and though he didn't find that, it is interesting to note that there were only 25 people in attendance—not exactly a large turnout. I believe Sandra said that Brewer had some difficulty with his slide presentation—that he hadn't had time to do a run through on it and it showed. But such a situation may well have contributed to his sense of frustration (that plus the rainstorm that he had had to drive through to get there).

The Gainesville League usually shows the videotape of their programs twice on the local cable access channel—on Sunday evening and on Tuesdays. They had shown the tape for the first time on Sunday, and then Brewer's letter arrived on Monday, informing them that they did not have his permission to show it on any cable channel. Somewhat surprised by the letter, Sandra called the cable station manager on Tuesday morning and they agreed to pull the second viewing of the program.

My personal conclusion is that the Gainesville League may have failed to confirm the arrangements for the program in writing well in advance of the date but that it would have been difficult anyway with a substitute speaker. Still, speaker number one could have shared with speaker number two any written information he had received. Brewer appears to have overreacted and I do not believe the Gainesville League's actions were nearly as impolite as Gail Enright's memos to Marianne Pollak (of November 13 and 14) would make us think. It's unfortunate that Brewer is the president-elect of the Texas Association of Business, an organization who is the state League's opponent in a lawsuit and that he has a bad impression of the League because of this one occasion. At this point, my recommendation would be to let the national office know that there is another side to the story and to let sleeping dogs lie.

Dear Sue:

I understand that you have made inquiries regarding the possibility of state unit status for the Gainesville League. This letter is intended to explain that process in some detail.

Before a state unit can be organized, the local League must disband. A letter must go to each League member announding a meeting for the purpose of deciding whether or not to disband. The letter should request that ever member attend and must also state that failure to attend will be counted as a vote to disband. If the final vote is in favor of disbanding, there is no longer a League of Women Voters of Gainesville.

Should you then decide to become a unit of the LWVT, you will need to select a chair person, a secretary-treasurer, and other chairs as needed. The Guide to Organizing State Units that you have received contains additional information.

When a local League disbands, all local program studies and action positions are lost. A state unit is not involved in local program study; it studies state and national program and may take action on state and national positions.

I enjoyed our brief conversation in San Antonio, Sue, and I heartily commend you for hanging in. The dog days of summer are difficult times for all Leagues. It is my sincere hope that fall will bring a rejuvenated commitment by all the members of the Gainesville League.

She shows great potential for program and action.

This group has some tremendous raw talent and can really be a force in their small community. Eathy and I were discouraged at the beginning of the day-but by hard day's end felt buoyed. One day isn't going to do it-especially in program. I'll be willing, maybe with

another to go back up several times for special training. Be assured we were not demanding—in the sense that they are a small town league. We told them again and again we do not expect them to do everything. But we did lean on them to do some League procedures: This group is worth saving. It will take a lot of hard work on our part (both trainers and advisor). I personally would hate to see us approve this group if their membershap doesn't improve a bit and they can't get the elementary organizational elements together.

Dear Mrs. Sanders:

This letter is in reference to your rather disturbing telephone call this morning. I feel compabled to say that I feel that most of your hostility was unjustified. It seemed impossible to establish some understanding between us. Your attitude was totally unexpected and I was not prepared to discuss the situation with you--in fact I was quite surprised at your attitude.

There are obviously several misunderstandings about the League. These must be my fault since I am the only person you have been involved with. The thing I want to emphasize most is that all workers in the League at all levens are volunteers. We are all women with families, vacations, and personal problems which must at times come before League.

I would like to trace the choomology of the development of the Gainesville League with you as my records and memory indicate. The initial contact regarding the formation of a LWV in Gainesville was a letter from Mrs. Davenport to Mrs. Wackerbarth who was then Organization Vice President on March 31, 1472. Mrs. Wackerbarth replied on April 5, 1472 enclosing "So You'd Like to Form A League - Organizing a LWV" (a copy of which I enclose. This outlines the procedures for organizing a League. On May 11, I wrote to Mrs. Davenport volunteering to comein any time during the rest of May or the first week in June to discuss the formation of a League. No response was received until I was contacted about coming to speak to the group at the country club on Sept. 13, 1972. I was most enthusiastic following that meeting. I think I made it very clear that state board approval of the community survey was necessary prior to achieving "pre-Provisional status". In my report to the state board following that trip, I said,

"They are planning to call a meeting of the 26 the week of Sept. 18th, to elect a temporary chairman, divide the work on the community analysis, and make plans for total community recruitment. They plan to have the analysis completed by the Nov. state board meeting so they can officially become pre-Provisional, and their goal is to be recognized as Provisional at the Jan. board meeting. With this group of go-getters I wouldn't be surprised if they make it! They were concerned that 26 wasn't enough for a temporary committee."

Considerable correspondance between state board members followed my report and is in my files. The board was willing to give the "go ahead" and hoped to remove some of the "red tape" in light of my enthusiastic report. You can imagine our disappointment when we had heard nothing from you by the November meeting—nor again by the January meeting. The situation was discussed at both meetings, and since we feel it is vital that the community generate its own enthusiasm and exert independent action, we felt that we must look at the situation with more reservations than we had had in September and October, and in fact assumed that all interest had died.

I received your community survey in February and took it to the next state board meeting which was during the state convention in April. We squeezed time into a very hectic and crowded agenda to give approval at that time.

When we made plans for the May 27th meeting, I informed you of Mrs. Heaberlin's assignment as your adviser and the fact that she would be unavailable until fall. This was discussed again at that meeting along with the fact that I or someone else would work with you in the interum. All seemed very agreeable.

Again following the May meeting, I filed a very enthusiastic report to the state board and even mentioned the potential I feel for your group to Mrs. Murphree of the national board during a long distance phone conversation.

The existing problem as I see it, must result from the fact that I was unable to complete my trip on the 19th of June. Unfortunately a fuel line ruptured on my car and if I had continued my journey the car would have burned. It is also unfortunate that I was unfnformed of the meeting place and did not know where to reach you by phone. I was relieved to receive your call that morning.

If you will remember, during that conversation I volunteered to come on June 21 or 22 or the week of July 2nd, and you said that those were inconvient dates for you. Today when you phoned, I volunteered to drive down this afternoon or to cancel my trip to Houston next week (a necessary personal business trip which could prove costly to us personally) and again you said that this would be inconvenient. I feel that you have made demands which are impossible for me to fill in the short time you gave me.

You asked that I send someone at the state level who will work with you permanently in sometime after the 15th of July-that you don't want to switch advisers in the fall. There are two qualified people in the area who will be available to work with you. However, neither of them are currently state board members nor are they available until fall. All of the state board members who live in the North Central Texas area are extremely busy with state board work in their individual portfolios; are working with local board training; and are trying to squeeze in some personal vacation time. However, if you reevaluate the situation and feel that you can find a tmeporary adviser acceptable, I will circulate a memo to them to see if any are available.

Will you please select three dates which will be convenient for you indicating 1st, 2nd, and 3rd choices, and I will see who is available. If you are not willing to work with someone temporarily, the only choice seems to be to wait to proceed any futher until Mrs. Heaberlin in available in September.

Two factors regarding your call disturb me. The first is your comment that "if this is the way League operates, we don't want it", and the second is your apparant unwillingness to cooperate with me personally. League has certain procedures which have evolved from 53 years of experience, and as an elected officer of the Texas League, I am obligated to work within those procedures until the membership votes to change them. Will you please evaluate the situation and inform me of your decision by mail no later than Saturday, July 14. It will be helpful if you send a carbon of your letter to the state office—LWV of Texas, Dickinson Plaza Center, Dickinson, Texas 7753%.

I am mailing under separate cover my personal copies of suggested materials listed in "A guide to Organizing Leagues". I do not currently have all the materials in my file. The League operates on a tight budget and I am sharing some materials with a state board member who is training the Odessa LWV on July 4th. As soon as I can receive sopies, I will mail them to you.

I am truly sorry that this situation has arisen. I hope that you in Gainesville will decide that you are able to work within the established procedures and the scheduling floxibility necessary in a tolunteer organization that is very demending of its leaders time.

I am sorry that you did not feel that you could proceed with the committee work as I had suggested on the phone. Perhaps correspondance will be more efficient than phone calls in the future. I am looking forward to your reply.

Monday, August 27, Lorraine Sanders and I spoke on the phone, and everything had come to a halt because the nominating chairman had been unable to get more than 3 or 4 women to accept a nomination for a Board position! She reported that the girls who had been working were all utterly discouraged and weren't sure what, if anything, they should do next. She and I decided that we couldn't fully discuss it on the phone so she set up a meeting for today and invited some others.

Today I met with Juhree Davenport, Shirley Weems, and Lorraine at her home, and inasmuch as only one newspaper article has appeared, no personal contact has been made with community leaders, the Community Analysis was made mainly through info from the Chamber of Commerce, and only a small group of women. have been involved, we plan to do some backtracking. It seemed clear to me that they needed a broader community basis from which to start, and they were very cooperative. All three of these women have talents that will be valuable in forming a new League, and I was particularly impressed with Lorraine's ability to organize facts, take notes, and plan.

The decisions we made today follow:

- 1. By September 15 a letter will be mailed to all civic organizations, churches, elected officials, etc. announcing what in reality will be a pre-organization meeting. We may not call it that in view of the fact that they have been "organizing" for a year.
- 2. Lorraine will set up appointments and she and I and maybe someone else from Gainesville will interview community leaders during the week of Sept 16-22.
- 3. We set a tentative date of October 2 for the preorganization meeting and plan newspaper, radio, poster and telephoning publicity.
- Let Depending on the response at the October 2 meeting, we will go ahead with an organization meeting. If we do decide to organize, the date will be set at this meeting (Oct. 16 or 23) and we will ask for this meeting (Oct. 16 or 23) and we will ask for volunteers for temporary committees. Voluntary Action Center: Sent a letter and a form as they are looking for nominations for "Volunteer of the Year" award.

Election School: About 30 attended where Bill Walker of the Secetary of State"s office spoke to the group and went over election policies and new rules. One of the new rules effective January, 1986 was that each poling place must have a private booth of type that is filled in on three sides and a certain height and width.

Voter Service: B. Buttolph is complying the list of candidates and will have the list as soon as all filing dates are met. A letter will be sent to all candidates reference their being invited to attend the "Candidate's Forum Night". Discussion took place reference how to do the letters. It was decided that B. Buttolph would compose the list of names, and address and get it to G. Balsley who would do they and the envelopes on the computor. We need to develop a set of questions for each office and are asking anyone to submit suggested questions. The board is to have some input on the fina questions but that the final questions will be in the hands of only one person so that there is little chance of people knowing the questions ahead of time. Publicity: G. Balsley received the 50 booklets entitled, "Legal Choices for Bettered Women". We will have a stamp made that states, "Compliments of League of Women Voters - Gainesville. These booklets will be placed in strategic places in the city. (Emergency Room, Friends of the Family, Ministerial Alliance.

Mrs. Farabee: It was suggested, like before, the board have dinner with the speaker. Gerard Balsley will contact Mrs. Farabee's secretary for background material on her.

The velox for the primary will be in both the Register and the Cooke Ct. Leader. This was acceptable to the Register.


Membership: Susie Neil a new person to contact who has expressed interest injoining the League.

Re: Application for Recognition as a Local League

I write in support of the application for recognition of the Provisional League of Women Voters of Gainesville, Texas.

I have worked with the Gainesville Provisional LWV for the past two years as their Adviser, and have become closely acquainted with both the women who serve on the board of directors and the organization they have formed. Although the Gainesville Provisional League got off to a slow start, they have worked hard for the past year and a half, have made good progress on the road toward becoming a "real" League, and have developed very good relations with the community. Their Voters Service activities have been outstanding. When they did not publish a Voters Guide for the 1976 General Election in the local newspaper, due to lack of funds to buy political advertising space, several local citizens called to say they had looked for the information, had missed it, and wanted to know why it had not appeared. I feel that when a local program item is adopted and the League can study, reach consensus, and take action, the membership will increase and the League will thrive. Certainly the community is already aware of the League's activities and is very supportive of them.

The membership list shows 34 members, and the February VOTER shows three more have joined; but LWV/Texas policy requires a minimum of 40 members before recognition may be granted. I believe that the membership list will pass 40 before the decision must be made. It would have been easy for this group to add names to the membership list, but they have not been "tombstoning." Each month a few members join, and the number is gradually rising to the magic 40. I have encouraged them to reach for 50, since some members will drop out even as others join.

Now that the community survey is complete, the members are excitedly getting ready for Annual Meeting, when they hope to drop the "Provisional" from their name and adopt local program for the first time. I have encouraged them to believe that this will happen. They have followed the suggestions of their state board trainers and have completed the "assignments" that were made last fall. I believe they are on the right track. I hope you, and others who read this recommendation, will share my optimism. I look forward, almost as much as they do, to their recognition as a local League.

Provisional League of Women Voters Gainesville, Texas

- The date our league was recognized as a Provisional League was April, 1974.
- 2. At this time we had 45 members. We now have 34 members. The membership list is attached. The population of Gainesville, Texas is 13,830.
- 3. The Provisional League of Gainesville is a municipal league.
- 4. The regular board meetings are held each third Tuesday of the month at 10:00 A.M. in a public meeting room. We have an average attendance of ten. We have had good attendance at our noon meetings following the board meetings. These noon meetings are mixed as unit and general meetings. Our general meetings average attendance is 25. The second unit meeting of the month is held in the home of a member. Our average attendance for unit meetings is 10. We have had evening unit meetings but because of a very low attendance we no longer conduct evening unit meetings.

 - 2. Program-National
 - 3. Program- State
 - 4.Membership

- 6. A list of our board members attached.

10. Each meeting is listed in the calendar of the local newspaper and in our monthly bulletin. We have been invited by several clubs and organizations to be their speakers. We always take our publications to these meetings and try to make the public aware of what we study and to let them know these publications are available to the public.

Local Survey

Three meetings have been held for the people working on the surveys. At these meetings training was given by our local survey chairman and copies of other city surveys were distributed. Three special meetings were held in connection with our survey. One go-see tour of the city hall, jail, fire station, water plant and sewer plant. We also tourned our local museum. As a group we attended a city council meeting. We list our local city council, county commissioners and school board meeting time and date in our local bulletin.

State-

We have studied every state program item from the materials published by state. State subjects which we have studied are; Texas Water Plan, Financing State Government, TCR, Land Use, Voting Rights and The Administration of Justice.

National-

The following subjects have been studied on National program: Land Use, Federal Revenue Sharing, HUD, ERA, Presidential Powers, Financing the League, Energy, and United Nations.

After a unit meeting a report was written on the subject studied, giving the titles of the publications used and this report was published in the local paper.

- 12. Members have available copies of Facts & Issues and other publications. We do not have subscription service now but plans are to have it by next fall.

Several publications have been donated to the local public schools. We have had requests from the students at our local county college and college professors for our publications.

13. Community relations have been excellent during the provisional period. The local newspaper, radio station, and cable TV personnel have cooperated in every way. The Observer Corps was welcomed by the City Council and complimented for its interest and encouragement. Many expressions of gratitude from local residents were received after the two candidates forums. Recently one member was asked to serve on the local city charter revision committee.

11. Our voter service activites have been:

Non-election

Permission was requested and granted from the President of the Cooke County Fair Assocation to have a League of Women Voters booth at the Fair in August, 1975. The League was given space in the skating rink building for three nights. Two League members worked the booth each night from 7:00 P.M. until 10:00 P.M. League material was handed out and people were urged to register to vote and to vote.

In August of 1976 our request was granted again to have a booth at the County Fair. This time we worked four nights with two members each night, and we handed out registration forms and urged people to vote. We feel this reaches a lot of people in the city and lets them know what League is doing in Gainesville, Texas.

Election

In 1974 we distributed 3,000 state <u>Voters Guides</u>. Also in 1975 we distributed 3,000 Voters Guides.

Our first local <u>Voters Guide</u> was published in our local newspaper March 29, 1975, at our cost. There was much interest in this and we have been asked to do this again.

Our first Candidates Forums were held in March and April of 1976. We had a lot of interest and very good attendance. Mrs. Beth Brown and Mrs. Bobette Higgins were our assistants. The candidates were very cooperate, and we felt this was the most important thing we had accomplished for public relations and voters service.



1977 - 1978

ARTICLE I

Section 1. Name

The name of this organization shall be League of Women Voters of Gainesville. This local League is an integral part of the League of Women Voters of the United States and of the League of Women Voters of Texas.

ARTICLE II

Section 1. Purpose

The purpose of the League of Women Voters of Gainesville shall be to promote political responsibility through informed and active participation of citizens in government.

Section 2. Policy

The League of Women Voters of Gainesville may take action on local governmental measures and policies in the public interest in conformity with the principles of the League of Women Voters of the United States. It shall not support or oppose any political party or any candidate.

ARTICLE III

Membership

Section 1. Eligibility

Any person who subscribes to the purpose and policy of the League shall be eligible for membership.

Section 2. Types of Membership

The membership of the League of Women Voters of Gainesville shall be composed of voting members and associate members.

- a. Voting members shall be citizens at least 18 years of age.
- b. Associate members shall be all other members.

ARTICLE IV

Board of Directors

Section 1. Number, Manner of Selection, and Term of Office

The Board of Directors shall consist of the Officers of the League, six elected Directors and not more than six appointed Directors. Three elected Directors shall be elected by the general membership at each Annual Meeting and shall serve for a term of two years, or until their successors have been elected and qualified. The elected Board Members shall appoint such additional Directors, not exceeding six, as they deem necessary to carry on the work of the League. The term of office of the appointed Directors shall be one year and shall expire at the conclusion of the next Annual Meeting.

Section 2. Qualifications

No person shall be elected or appointed or shall continue to serve as an Officer or Director of this organization unless they are a voting member of the League of Women Voters of Gainesville.

Section 3. Vacancies

Any vacancy occuring in the Board of Directors by reason of the resignation, death, or disqualification of an Officer or elected Member may be filled, until the next Annual Meeting, by a majority vote of the remaining Members of the Board of Directors. Three consecutive absences from a Board meeting of any Member without a valid reason shall be deemed a resignation.

Section 4. Power and Duties

The Board of Directors shall have full charge of the property and business of the Organization, with full power and authority to manage and conduct same, subject to the instructions of the general membership. It shall plan and direct the work necessary to carry out the program as adopted by the National Convention, the State Convention, and the Annual Meeting. The Board shall create and designate such special committees as it may deem necessary.

Section 5. Meetings

There shall be at least nine regular meetings of the Board of Directors annually. The President may call special meetings of the Board of Directors upon the written request of five Members of the Board.

Section 6. Quorum

A majority of the Members of the Board of Directors shall constitute a quorum.

ARTICLE V

Officers

Section 1. Enumeration and Election of Officers

The Officers of the League of Women Voters of Gainesville shall be a President, a First Vice President, a Second Vice President, a Third Vice President, a Secretary, and a Treasurer, who shall be elected for terms of two years by the general membership at an Annual Meeting and take office immediately. The President, the First Vice President, and the Secretary shall be elected in odd numbered years. The Second and Third Vice President and the Treasurer shall be elected in even numbered years.

Section 2. The President

The President: shall preside at all meetings of the Organization and of the Board of Directors; may, in the absence or disability of the Treasurer, sign or endorse checks, drafts, and notes; shall be, exofficio, a Member of all Committees except the Nominating Committee; shall have such usual powers of supervision and management as may pertain to the Office of the President and perform such other duties as may be designated by the Board.

Section 3. The Vice Presidents

The three Vice Presidents, in the order of their rank, shall, in the event of absence, disability, resignation, or death of the President, possess all the powers and perform all the duties of that Office, until such time as the Board of Directors shall select one of its Members to fill the vacancy. The Vice Presidents shall perform such other duties as the President and Board may designate.

Section 4. The Secretary

The Secretary: shall keep minutes of all meetings of the League and of all meetings of the Board of Directors; shall notify all Officers and Directors of their election; shall sign, with the President, all contracts and other instruments when so authorized by the Board and shall perform such other functions as may be incident to her Office.

Section 5. The Treasurer

The Treasurer shall collect and receive all moneys due; shall be the custodian of these moneys; shall deposit them in a bank designated by the Board of Directors; shall disburse the same only upon order of the Board; shall present statements to the Board at their regular meetings and an annual report to the Annual Meeting.

ARTICLE VI

Financial Administration

Section 1. Fiscal Year

The fiscal year of the League of Women Voters of Gainesville shall commence on the first day of June each year.

Section 2. Dues

Annual dues of \$15.00 shall be due on the 1st day of June; any member who fails to pay dues within four months after they become payable shall be dropped from the membership rolls. Any member who joins the League or who renews a membership before June 1st will pay an additional pro rata fee based on \$1.25 per month preceding June until such renewal becomes uniform at the beginning of the fiscal year.

Section 3. Budget

A budget for the ensuing year shall be submitted by the Board of Directors to the Annual Meeting for adoption. The budget shall include support for the work of the League as a whole.

Section 4. Budget Committee

A Budget Committee shall be appointed by the Board of Directors at least two months prior to the Annual Meeting to prepare a budget for the ensuing year. The proposed budget shall be sent to all members one month before the Annual Meeting. The Treasurer shall not be eligible to serve as Chairman of the Budget Committee.

ARTICLE VII

Meetings

Section 1. Membership Meetings

There shall be at least four meetings of the membership each year. Time and place shall be determined by the Board of Directors.

Section 2. Annual Meeting

An Annual Meeting shall be held between May 1 and May 31, the exact date to be determined by the Board of Directors. The Annual Meeting shall:

- a. Adopt a local program for the ensuing year
- b. Elect Officers and Directors, Members of the Nominating Committee
- c. Adopt an adequate budget, and
- d. Transact such other business as may properly come before it.

Section 3. Quorum

Ten members shall constitute a Quorum at all business meetings of the League of Women Voters of Gainesville.

ARTICLE VIII

Nominations and Elections

Section 1. Nominating Committee

The Nominating Committee shall consist of five Members, two of whom shall be Members of the Board of Directors. The Chairman and two Members, who shall not be Members of the Board, shall be elected at the Annual Meeting. Nominations for these Offices shall be made by the current Nominating Committee. The other Members shall be appointed by the Board of Directors immediately following the Annual Meeting. Any vacancy on the Nominating Committee shall be filled by the Board of Directors. Suggestions for nominations for Officers and Directors may be sent to this Committee by any voting Member.

Section 2. Report of Nominating Committee and Nominations from the $\overline{\text{Floor}}$

The report of the Nominating Committee of its nominations for Officers, Directors and the Members of the succeeding Nominating Committee shall be sent to all Members one month before the date of the Annual Meeting. The report of Nominating Committee shall be presented to the Annual Meeting. Immediately following the presentation of this report, nominations may be made from the floor by any voting Member provided the consent of the Nominee shall have been secured.

Section 3. Elections

The election shall be by ballot, provided that when there is but one Nominee for each Office, the Secretary may be instructed to cast the ballot for every Nominee. A majority vote of those qualified to vote and voting shall constitute an election. Absentee or proxy voting shall not be permitted.

ARTICLE IX

Program

Section 1. <u>Authorization</u>

The governmental principles adopted by the National Convention, and supported by the League as a whole, constitute the authorization for the adoption of Program.

Section 2. Program

The Program of the League of Women Voters of Gainesville shall consist of:

- a. Action to protect the right to vote of every citizen, and
- b. Those local governmental issues chosen for concerted study and action.

Section 3. Action by the Annual Meeting

The Annual Meeting shall act upon the Program using the following procedures:

- a. The Board of Directors shall consider the recommendations sent in by the voting Members two months prior to the Annual Meeting and shall formulate a proposed program.
- b. The proposed program shall be sent to all members one month before the Annual Meeting.
- c. A majority vote of voting Members present and voting at the Annual Meeting shall be required for adoption of subjects in the proposed program as presented to the Annual Meeting by the Board of Directors.
- d. Recommendations for Program submitted by voting Members two months prior to the Annual Meeting but not recommended by the Board of Directors, may be considered by the Annual Meeting provided that: (1) the Annual meeting shall order consideration by a majority vote and (2) the Annual Meeting shall adopt the item by a majority vote.
- e. Changes in the Program, in the case of altered conditions, may be made provided that: (1) information concerning the proposed changes has been sent to all Members at least two weeks prior to a general membership meeting at which the change is to be discussed and (2) final action by the membership is taken at a succeeding meeting.

Section 4. Member Action

Members may act in the name of the League of Women Voters only when authorized to do so by the proper Board of Directors.

ARTICLE X

National Convention, State Convention, and Council

Section 1. National Convention

The Board of Directors at a meeting before the date on which the names of delegates must be sent to the National Office shall select delegates to that Convention in the number allotted the League of Women Voters of Gainesville under the provisions of the Bylaws of the League of Women Voters of the United States.

Section 2. State Convention

The Board of Directors at a Meeting before the date on which the names of delegates must be sent to the State Office shall select delegates to that Convention in the number allotted the League of Women Voters of Gainesville under the provisions of the Bylaws of the League of Women Voters of Texas.

Section 3. State Council

The Board of Directors at a Meeting before the date on which the names of delegates must be sent to the State Office shall select delegates to that Council in the number allotted the League of Women Voters of Gainesville under the provisions of the Bylaws of the League of Women Voters of Texas.

ARTICLE XI

Parliamentary Authority

Section 1. Parliamentary Authority

The rules contained in Robert's Rules of Order Newly Revised shall govern the Organization in all cases to which they are applicable and in which they are not inconsistent with these Bylaws.

ARTICLE XII

Amendments

Section 1. Amendments

These Bylaws may be amended by a two-thirds vote of the voting Members present and voting at the Annual Meeting, provided that amendments were submitted to the Membership in writing at least one month in advance of the meeting.

Changes to Bylaws

Article III, Section 2

Substitute as follows: The Membership of the League of Women Voters of Gainesville shall be composed of citizens at least 18 years of age (formerly women citizens).

Article IV, Section 1

POLICY GUIDE

Non-Partisanship

"The League of Women Voters shall not support or oppose any political party or any candidate." The League Board has the responsibility to be sure that the activities of their Board Members and the manner in which all League operations are carried out are such that the Community and League Members cannot infer that the League is not adhering to its non-partisanship policy.

Members

- 1. While the League of Women Voters may not support or oppose any political party or candidate, the League may take a position on local issues provided that such a position is established by a consensus after a program study has been initiated and presented.
- 2. Recognizing that the strength and effectiveness of the League rests in its unique non-partisan status, it is the responsibility of each individual League Member to guard carefully the League's reputation for non-partisanship. League Members are encouraged to work as individuals in the Party of their choice, to attend meetings of administrative and legislative bodies of governmental activities, to exercise their right to vote, and to make their opinions known to their governmental representatives. However, League leaders should not involve themselves in conspicuous activity that reflects a conflict of interest with League work or stated position. Individual situations should be discussed with the Board and decided on a case-to-case basis. If the Board feels that there is a conflict of interest, the Board may request the individual to resign her League position.
- 3. Any member who has paid dues elsewhere and wishes to transfer to the Gainesville League will be accepted without payment of dues until the next fiscal year (June 1st). Any member who joins the League or who renews a membership before June 1st will pay an additional pro rata share for months preceding June until such renewal becomes uniform at the beginning of the fiscal year.
- 4. A League Member attending a city, county, or school administrative meeting as a League Observer is there as a reporter only and in that capacity should confine activities to note-taking. Questions for clarification of statements may be asked.

5. Discussion of all candidates must be avoided at all League meetings including unit meetings, except in connection with Voters Service activities. Likewise, no partisan material may be brought to any League function except a candidates rally, where candidates may bring their own materials. Material not to be brought to meetings includes pamphlets, buttons, tickets, or anything concerning candidates or issues the League is not studying.

Roster

The Roster of the Gainesville League of Women Voters is for the use and convenience of its Members in carrying out the work of the League. Its use by other organizations or groups must have Board approval.

Publications

<u>Voter Guides</u> and other League publications designated by the Board shall contain the following: "This publication may not be reproduced in any form without the written consent of the Board of Directors of the Gainesville League of Women Voters. All statements contained herein are the statements and opinions of the Candidates and do not represent the opinion of the Gainesville League of Women Voters."

The <u>Voter</u> may carry announcements of other organizations' activities when they relate directly to League program; any other unrelated inclusions must have Board approval.

Board Members

- 1. The President may not participate in any partisan political activities. Other Board Members whose Board responsibilities are highly visable in the Community should be circumspect in their activities. If a situation seems to be in violation of the non-partisan policy of the League, the Board Member may be asked to resign her position. Individual cases should be decided on a case-to-case basis.
- 2. A Board Member must resign from the Board before announcing as a candidate for public office. A period of four months must pass before a candidate for public office may be nominated to a Board position or fill an unexpired term.
- 3. Only the President or designated representative may speak for the League. Delegated representatives of the League may not make binding commitments on major matters without the approval of the Board.
