BOARD OF DIRECTORS MEETING

October 21, 1960

- 602. The Board of Directors of Texas Technological College met in regular session in the Office of the President on Friday afternoon, October 21, 1960, at 1:15 p.m. The following Directors were present: Chairman Wall, Vice Chairman Orme, Mr. DeBusk, Mr. Haley, Mr. Hinn, Mr. Lindsey, Mr. Smith and Mr. Wooldridge. In addition, President Goodwin, Academic Vice President Pearce, Vice President and Comptroller Pennington and Secretary Wells were present.
- 603. Upon motion made by Mr. Lindsey, seconded by Mr. Wooldridge, the Board by a unanimous vote, approved the Minutes of the September 17, 1960 Board Meeting.
- 604. Upon motion made by Mr. DeBusk, seconded by Mr. Orme, the Board by a unanimous vote, approved the Agenda under the date of October 8, 1960 and the Supplementary Agenda under the date of October 14, 1960, Items No. 213 through No. 601. A copy of the approved Agenda is attached and made a part of the Minutes. Attachments No. 1 and No. 1A.
- 605. Upon motion made by Mr. Wooldridge, seconded by Mr. Orme, the Board by a unanimous vote, approved the Budget for an Organized Research Project for the School of Agriculture, in the amount of \$3,000.00, as presented by Attachment No. 2. The Summary Sheet for the project is attached and made a part of the Minutes. Attachment No. 2. The Project Budget is attached and made a part of the Minutes. Attachment No. 2(1).
- 606. Upon motion made by Mr. Haley, seconded by Mr. Wooldridge, the Board by a unanimous vote, approved the budgets for the Organized Research Projects for the School of Arts and Sciences, in the amount of \$6,750.00, as presented by Attachment No. 3. The Summary Sheet for the projects is attached and made a part of the Minutes. Attachment No. 3. The Project Budgets are attached and made a part of the Minutes. Attachment No. 3(1), No. 3(2), No. 3(3), No. 3(4), No. 3(6) and No. 3(7). The Budget for Research Project "Generalization of the Effects of a Reinforcing Cue", Account No. 1671, in the amount of \$2,000.00, was held in abeyance for future consideration. This Budget is a part of Attachment No. 3 and described as No. 3(5).
- 607. Upon motion made by Mr. Haley, seconded by Mr. Smith, the Board by a unanimous vote, approved the office furniture, equipment and millwork for the Agricultural Plant Science Building as listed below:

- 608. Upon motion made by Mr. Haley, seconded by Mr. Smith, the Board by a unanimous vote, approved the installation of a ceramic cooling tower in the Central Chilling Station to be located in the Student Union Building. The base bid provides for a ceramic tower, therefore no new funds will be needed.
- 609. Upon motion made by Mr. Haley, seconded by Mr. Smith, the Board by a majority vote, approved the solar screen sample, the white unpainted concrete columns and the substitution of agredon tread for travertine on the exterior steps of the Library Building, and deferred action on the selection of the inserts for the solar screen until a later date.
- Mr. Wooldridge requested that he be recorded as voting "no".
- 610. Upon motion made by Mr. Haley, seconded by Mr. Smith, the Board by a unanimous vote, accepted the bid of the Toledo Scale Company, Lubbock, Texas, in the amount of \$1,621.55, for the scales in the Meats Laboratory.
- 611. Upon motion made by Mr. Haley, seconded by Mr. Smith, the Board by a unanimous vote, approved an appropriation in an amount not to exceed \$900.00 for the purchase of new transite, 6" water line to reroute an existing line around the tennis courts at the Women's Gym. The installation will be made by the Department of Grounds with assistance from the Department of Building Maintenance. It is felt that at least \$250.00 can be saved by installing the line with college personnel. This is to be paid from the Constitutional Building Amendment Funds.
- 612. Upon motion made by Mr. Haley, seconded by Mr. Smith, the Board by a unanimous vote, authorized the sale of Buildings X-1, X-2, and X-5, to the highest bidder as soon as the bidding is completed at prices not lower than the following:

- 613. Upon motion made by Mr. Haley, seconded by Mr. Lindsey, the Board by a unanimous vote, approved the preliminary plans and specifications, the proposed elevations, and the floor plans for the Science Building Addition and authorized the project architects to proceed with the preparation of the final plans and specifications.
- 614. Upon motion made by Mr. Haley, seconded by Mr. Smith, the Board by a unanimous vote, approved September 27, 1960, as the final acceptance date for the Curb, Gutter and Paving at the Northeast Corner of the Women's Gymnasium.
- 615. Upon motion made by Mr. Haley, seconded by Mr. Smith, the Board by unanimous vote, awarded a contract to Mr. Elmer Calhoun of Lubbock, the low bidder, to construct the following concrete walks:

- 615. (Continued) Of the total amount, it is recommended that \$9,049.30 be charged to Constitutional Building Amendment Funds budgeted for Walks, Drives, and Parking Lots, \$1,096.00 to Knapp Hall, and \$505.20 to Drane Hall. The plans and specifications were prepared by the Office of the Landscape Architect.
- 616. Upon motion made by Mr. Haley, seconded by Mr. Smith, the Board by a unanimous vote, awarded a contract in the amount of \$950.00 to Joel Austin Dirt Contractor, Lubbock, Texas, the low bidder, to remove 2,000 square yards of paving, caliche base, and curb and gutter from the road that ran between the West and Textile Engineering Buildings and behind West Engineering Building, the amount to be paid from Constitutional Building Amendment Funds budgeted for Walks, Drives, and Parking Lots. A copy of the contract is attached and made a part of the Minutes. Attachment No. 13.
- 617. Upon motion made by Mr. Haley, seconded by Mr. Smith, the Board by a unanimous vote, awarded a contract in the amount of \$15,300.00 to Elmer Terry Construction Company, Lubbock, Texas, the low bidder, to construct four concrete tennis courts in the area of the Women's Gymnasium, in keeping with the plans and specifications prepared by the Office of the Landscape Architect, the amount to be paid from Constitutional Building Amendment Funds. A copy of the contract is attached and made a part of the Minutes. Attachment No. 14.
- 618. Upon motion made by Mr. Haley, seconded by Mr. Smith, the Board by a unanimous vote, approved October 4, 1960, as the final acceptance date for the Women's Gymnasium.
- 619. Upon motion made by Mr. Haley, seconded by Mr. Smith, the Board by a unanimous vote, approved an extension of time of seven (7) days to the Warner Construction Company contract, due to bad weather, for the completion of the Women's Gymnasium.
- 620. Upon motion made by Mr. Wooldridge, seconded by Mr. Haley, the Board by a unanimous vote, approved the budget for an Organized Research Project for the School of Arts and Sciences, in the amount of \$800.00, as presented by Attachment No. 11. The Project Budget is attached and made a part of the Minutes. Attachment No. 11.
- 621. Upon motion made by Mr. Wooldridge, seconded by Mr. Hinn, the Board by a majority vote, approved the Budget for the Organized Research Project: "Effects of Radiation on the Albino Rat", in the amount of \$24,955.00. The Board by Item No. 198, Board Minutes of September 17, 1960, approved Modification No. 6 to Contract No. AT-(40-1)-1982, to support this project. A copy of the Budget is attached and made a part of the Minutes. Attachment No. 5A.
- Mr. Haley requested that he be recorded as voting "no".
- 622. Title IV of the National Defense Education Act of 1958 authorized "such sums as may be necessary" for National Defense Fellowships. The initial appropriation was for \$800,000.00, which was allocated by the Office of Education. Additional funds may be made available by Congress for the Fellowship Program. Three (3) Fellowships in the field of English were allocated to Texas Technological College for the Academic Year, 1959-60 and six (6) for the Academic Year, 1960-61.

Upon motion made by Mr. Orme, seconded by Mr. Lindsey, the Board by a majority vote, authorized the filing of an application for nine (9) Fellowships in the field of English for the Academic Year, 1961-62; approved the acceptance of these Fellowships, if and when the funds are allocated; approved the acceptance of the Cost-of-Education Grant that goes with each Fellowship; and authorized Mr. M. L. Pennington, Vice President and Comptroller and/or Dr. W. B. Gates, Dean of the Graduate School, to sign any and all papers, contracts and documents required of institutions participating in the Program.

- Mr. Haley requested that he be recorded as voting "no".
- 623. Mr. Orme, Chairman of the Finance Committee, gave a report for the Committee which recommended the approval of the four items, No. 624 through No. 627.

624. Mr. Orme, Chairman of the Finance Committee, reported that the Committee had studied the status of the present budget and that the original Budget had been prepared in a very close and conservative manner. After considering the amount of the budget, the funds on hand, and the amount requested of the Legislature for the next biennium, the Finance Committee was of the opinion that the amounts for Teaching Salaries and Departmental Equipment, the most vital areas of need, should be increased as much as possible at this time. He further stated that the teaching salaries at Texas Tech were below the average for similar institutions and that the amount available for Departmental Equipment had been low for several years. However, the financial help which the Finance Committee is recommending and the amount in the Legislative Request, if granted, would enable Texas Tech to more adequately and efficiently discharge its instructional responsibilities.

Upon motion made by Mr. Orme, seconded by Mr. DeBusk, the Board by a majority vote, appropriated from the Unappropriated Balance, the amount of \$104,000.00 for use in supplementing Teaching Salaries for the 1960-61 Academic Year; appropriated \$150,000.00 for the purchase of Departmental Equipment; and appropriated \$50,000.00 for a Warehouse Revolving Fund to start the initial stocking of the central receiving warehouse in order to facilitate the procurement of equipment and supplies by the Departments.

The detailed recommendations on salaries will be presented to the Board in December and the recommendations for the purchase of equipment will be made through the Building Committee.

Mr. Haley requested that he be recorded as "not voting".

- 625. Upon motion made by Mr. Orme, seconded by Mr. DeBusk, the Board by a unanimous vote, approved the Budget for the Student Council, in the amount of \$15,512.40, for the period, September 1, 1960 through August 31, 1961. A copy of the Budget is attached and made a part of the Minutes. Attachment No. 6.
- 626. Upon motion made by Mr. Lindsey, seconded by Mr. Orme, the Board by a unanimous vote, approved placing \$100,000.00 insurance on the Press Box and \$50,000.00 on the Athletic Building, at a net cost of \$1,042.00 for a five-year contract. The premium is to be paid from Athletic Funds.
- (<u>Informational Note</u>: Since the Board Meeting on October 21, 1960, the Insurance Agent has advised Mr. M. L. Pennington, Vice President and Comptroller, that an error had been made in the computation of the premium. The estimated premium on the Press Box is approximately \$13,000.00. The Agent is writing a letter of explanation. This item will need to be reconsidered at the December Meeting.)
- 627. Upon motion made by Mr. Haley, seconded by Mr. Lindsey, the Board by a unanimous vote, approved the deletion of Item No. 16, page 247, in the amount of \$17,880.00, from the Request for Legislative Appropriations for the fiscal year ending, August 31, 1962. This request was made to renovate areas vacated by Chemical Engineering in the Chemistry Building to be utilized as Chemistry Laboratories. The Board by Item No. 199, Board Minutes of September 17, 1960, appropriated \$16,000.00 for this project.
- 628. Upon motion made by Mr. Hinn, seconded by Mr. Lindsey, the Board by a unanimous vote, requested the College Administration to make a survey to determine the cost of employing an outside firm to make a study of Texas Tech and to set up a job classification system for non-academic personnel; to determine the scope of the study; to determine how the res results from the study would be used; and to report back to the Board.

- 629. Upon motion made by Mr. Wooldridge, seconded by Mr. Lindsey, the Board by a unanimous vote, approved the Textile School Cotton Agreement between Texas Technological College and the United States Department of Agriculture, Commodity Credit Corporation, whereby the Commodity Credit Corporation will supply the Textile Engineering Department one (1) bale of cotton for classroom use. The Department of Agriculture has been supplying the Department of Textile Engineering with cotton for use in the training of students in the processing and manufacture of cotton into textiles for several years. A copy of the Agreement is attached and made a part of the Minutes. Attachment No. 8.
- 630. Mr. Lindsey, Chairman of the Athletic Committee, gave an informational report on the financial condition of the Stadium Expansion Program and the thinking of the Athletic Council on future housing for athletes. There was no formal action on this report.
- 631. Upon motion made by Mr. Hinn, seconded by Mr. Haley, the Board by a unanimous vote, requested the Campus Planning Committee to make a study, as rapidly as possible, on the estimated cost, the advantages, and the disadvantages of converting one of the Residence Halls now being used for men to a Residence Hall for Women. He further emphasized the necessity of making a decision concerning immediate and long-range housing plans for athletes and women students, and requested that this be included in the study to be made by the Campus Planning Committee.
- 632. Upon motion made by Mr. Haley, seconded by Mr. Lindsey, the Board by a unanimous vote, approved the following statement concerning Housing for Married Students: "That this Board go on record as not contemplating the construction of housing for married students".
- 633. Mr. Pennington gave an informational report on the plans being developed by the State Highway Department for islands at 19th Street and College Avenue.
- 634. Upon motion made by Mr. Lindsey, seconded by Mr. Haley, the Board by a majority vote, approved the use of a corner stone in the New Library Building. The Building Committee of the Board and the Campus Planning Committee were requested to make recommendations on the size, location and what is to be placed on the corner stone. The Board deferred consideration of the desirability of a formal ceremony.
- Mr. DeBusk requested that he be recorded as voting "no".
- 635. Upon motion made by Mr. Hinn, seconded by Mr. DeBusk, the Board by a unanimous vote, approved incorporating in the Board Minutes for record purposes the Enrollment Report for the 1960 Fall Semester. A copy of the Report is attached and made a part of the Minutes. Attachment No. 9.
- 636. Upon motion made by Mr. Hinn, seconded by Mr. Lindsey, the Board by a unanimous vote, approved an extra in the amount of \$55.00 to the contract with the Warner Construction Company, to install eleven (11) sets of screw driver stops (one pair at each shower) complete with trim in the Women's Gymnasium.
- 637. Upon motion made by Mr. Hinn, seconded by Mr. Lindsey, the Board by a unanimous vote, approved an extra in the amount of \$150.00 to the contract with Plains Metal Buildings, Inc., to install two standard garage type, panel doors, in lieu of the sliding doors on the metal building for the Horticulture Department.
- 638. Upon motion made by Mr. Smith, seconded by Mr. Hinn, the Board by a unanimous vote, granted permission to Mr. John H. Baumgardner, Associate Professor of Animal Husbandry, to go to Chicago, Illinois, from November 21, 1960 through November 28, 1960, to attend the annual meeting of the Society of Animal Production; to read a paper of original research "Digestion of Whole Milo Grain by Ruminants"; and to secure information for use in classroom instruction at Texas Tech; expenses are to be paid from the Department of Animal Husbandry Maintenance, Equipment and Travel Account.

639. Upon motion made by Mr. Smith, seconded by Mr. Hinn, the Board by a unanimous vote, granted permission to Dr. Faye L. Bumpass, Associate Professor of English and Foreign Languages, to go to Champaign, Illinois, from November 3, 1960 through November 6, 1960, to attend the Executive Council Meeting of the Writers' Project of the National Council of Teachers of English; at no expense to the College.

640. Upon motion made by Mr. Smith, seconded by Mr. Hinn, the Board by a unanimous vote, granted permission to Dr. Ralph M. Durham, Professor and Head, Department of Animal Husbandry, to go to Chicago, Illinois, from November 21, 1960 through December 3, 1960, to attend the annual meeting of the Society of Animal Production; to present a paper of original research "Beef Production in West Texas"; to secure information for use in developing the academic program in Animal Husbandry at Texas Tech; and to visit in the area of Ames and Des Moines, Iowa, to secure information on livestock feeding and production; expenses are to be paid from the Department of Animal Husbandry Maintenance, Equipment and Travel Account.

641. Upon motion made by Mr. DeBusk, seconded by Mr. Orme, the Board by a unanimous vote, approved the following names for four Residence Halls for Men:

Commodity Credit Corporation (hereinafter referred to as "CCC") hereby

agrees to supply to Texas Technological College, Lubbock, Texas, (hereinafter referred to as "the school") 1 bale(s) of cotton during the cotton marketing year ending July 31, 1961, that, as nearly as possible, meets the need of the school for use in training of students in the processing and manufacture of cotton into textiles. Such cotton shall be delivered by CCC, at such times as may be specified by the school, in the warehouse where stored with storage charges paid by CCC through the date of transfer of warehouse receipts to the school.

The school agrees to use such cotton solely for the purpose of training the school's students in the processing and manufacture of cotton into textiles. The school further agrees to submit a report to CCC (Director, Cotton Division, Commodity Stabilization Service) at the end of each marketing year as to the use made of the cotton. This report shall show the number of students who received training, the types of training for which such cotton was used, the quantity of cotton received, the quantity of cotton used, and the quantity of cotton on hand and available for future use.

No Member of or Delegate to Congress, or Resident Commissioner, shall be admitted to any share or part of this agreement or to any benefit that may arise therefrom, but this provision shall not be construed to extend to the agreement if made with a corporation for its general benefit, and shall not extend to any benefits that may accrue from the agreement to a Member of or Delegate to Congress or a Resident Commissioner in his capacity as a farmer.

The reporting requirement contained herein has been approved by the Bureau of the Budget in Accordance with the Federal Reports Act of 1942.

THIS RELEASE, executed the 29th day of September, 1960, by the United States of America, acting by and through the Secretary of Health, Education, and Welfare by the Regional Representative, Division of Surplus Property Utilization, Region VII, Department of Health, Education, and Welfare, under and pursuant to the powers and authority contained in the Federal Property and Administrative Services Act of 1949, Public Law 152, 81st Congress (63 Stat. 377), as amended (40 U.S.C. 471 et seq.) hereinafter referred to as the Act, and regulations and orders promulgated thereunder;

WITNESSETH:

1. WHEREAS, the United States of America, acting by and through the General Services Administrator, by Bill of Sale executed the first day of April, 1949, did sell, transfer, assign and deliver unto the Texas Technological College, an educational instrumentality organized under the laws of the State of Texas, with principal offices in Lubbock County, Lubbock, Texas, the following described chattels:

"All personal property, machinery and equipment listed in the inventory consisting of nine pages, attached hereto marked Exhibit "A" and made a part hereof as through set forth hereat in full; said chattels now being located in the buildings constituting the Pantex Ordnance Works in the Counties of Carson and Potter, State of Texas;" and

- 2. WHEREAS, the above referenced Bill of Sale was recorded in the Bill of Sale Records of the Offices of the County Clerks of Potter County, Texas on November 17, 1949, in Volume 5, commencing on page 609, and of Carson County, Texas, on November 21, 1949, in Volume 2, pages 269 to 287, which instruments are made a part hereof by reference; and
- 3. WHEREAS, said Bill of Sale provided, among other things, that the "vendee will use the said property continuously for educational purposes for a period of twenty years ... and for no other purpose in connection with the use of the real property where said chattels are now located;" and

- 4. WHEREAS, the Texas Technological College has continuously utilized said property since April 1, 1949 for education purposes in accordance with the provisions of the aforesaid Bill of Sale; and under a lease agreement in effect from June 1, 1947 to March 31, 1949; and
- 5. WHEREAS, the vendee now requests a release of the twenty year restrictions covering said property, on the grounds that because of long use much of the property is worn out or obsolete; and
- 6. WHEREAS, it has been determined that the compliance responsibilities of the United States and the utilization and accountability costs of the vendee are disproportionate to the benefits to accrue by virtue of a continuance of the restrictions for the balance of the twenty year restriction period.

NOW THEREFORE, the United States of America, acting by and through the Secretary of Health, Education, and Welfare by the Regional Representative, Division of Surplus Property Utilization, Region VII, Department of Health, Education, and Welfare, under and pursuant to the provisions of the aforesaid Act, for and in consideration of the premises, and the continued use of the above-referenced property, together with the continued use of the real property upon which it is located, for educational purposes, does hereby release the conditions subsequent and restrictions contained in the aforesaid Bill of Sale, as the same pertain solely to the property designated herein. It being understood that this release does not affect or apply to the real property upon which the above described personal property is located.
