FEBRUARY 19, 1951

The Board of Directors of Texas Technological College met in regular session in the Office of the President, Texas Technological College, Lubbock, Texas, at 10:00 A.M., Monday, February 19, 1951. The following were present: Directors Thompson, Chairman, Ince, Weymouth, Wooldridge, McLaughlin, Pfluger, Price, and Tom Abbott; President Wiggins, Vice President Jones, Secretary Gaston, Comptroller Pennington, and Assistant Secretary Wells.

- 629. President Wiggins presented the agenda under the date of January 19, 1951, and recommended its approval. Upon motion made by Mr. Weymouth, seconded by Mr. McLaughlin, the Board approved the first twelve pages of the agenda (Items 479 to 628, inclusive).
- 630. President Wiggins recommended the acceptance of the low bid of Mr. Joe Telford, Contractor, Lubbock, Texas, in the amount of \$1,987.00 to install window guards on the ground floor of the Library Building. Upon motion made by Mr. Price, seconded by Mr. Wooldridge, the Board approved the acceptance of the low bid and the available of the low bid and the low bid available of the low bid of the low bid and the awarding of a contract to Contractor Telford. The above amount to be paid from the unappropriated balance. Summary of bids attached, Item I, p. 4.
- 631. Upon motion made by Mr. Weymouth, seconded by Mr. Pfluger, the Board approved the installation and connection of a 6" water main from the steam tunnel to the Engineering Building. This installation will increase the cost of the Engineering Building Contract with the R. F. Ball Construction Company in the amount of \$693.14.
- 632. Upon motion made by Mr. Price, seconded by Mr. Weymouth, the Board approved payment of architect's fees to Wyatt C. Hedrick, Fort Worth, Texas, in the amount of \$520.92 for architect's services in connection with the installation of an elevator in the Chemistry Building. The installation contract was awarded to Hunter-Hayes Company, Dallas, Texas, on July 1, 1948. The amount of the contract was \$8,682.00 and the date of the agreement with Mr. Hedrick was May 4, 1948. The above amount to be paid from the unappropriated balance.
- 633. Upon motion made by Mr. Pfluger, and seconded by Mr. McLaughlin, the Board authorized repairs to the roof of the old Home Economics Building and the awarding of a contract in the amount of \$1,698.00.7 This amount to be paid from the unappropriated balance and the repair work to be done by the Lydick Roofing Company of Lubbock, Texas. Statement on work to be done attached, Item II, p. 4.
- 634. Upon motion made by Mr. Ince, and seconded by Mr. Price, the Board authorized changes in roof pitch on the Wings of the Administration Building in order to coincide with pitch on the present Administration Building. The change to cost \$487.98 which will be added to the original contrast of W. C. McMillan, Lubbock, Texas. An analysis of changes to be made attached, Item IV, p. 5.
- 635. Upon motion made by Mr. Weymouth, seconded by Mr. McLaughlin, the Board accepted the low bid and awarded a contract in the amount of \$2,140.55 to R. H. Elder, Lubbock, Texas, to make improvements on Building X-6 on the Poultry Farm. The above amount to be paid from the unappropriated balance. Summary of bids and work to be done attached, Etch III, p. 4.
- 636. Upon motion made by Mr. Ince, seconded by Mr. Pfluger, the Board accepted a credit on the Wings of the Administration Building Contract of \$1,800.00 from W. G. McMillan, Building Contractor, Inducek, Texas, for the omission of materproofing the inside of the outside walls above the ground on the two Wings of the Administration Building.
- 37. President Wiggins requested a correction of Item 3073 in the August 12, 1950, Board Minutes. The contract with A. M. Lockett and Company (Worthington tump and Machinery Corporation), Dallas, Texas, for the boiler feed water treating equipment in the Power House was written in the Minutes as \$4,305.00, but the correct amount is \$4,350.00. Upon motion made by Mr. McLaughlin, econded by Mr. Wooldridge, the Board approved the correction.

- 638. Upon motion made by Mr. Wooldridge, seconded by Mr. Ince, the Board authorized an appropriation from the unappropriated balance in the sum of \$1,500.00 to supplement awards to graduate students who hold scholarships, fellowships, teaching fellowships and/or part-time instructors. This amount to be used in offering aid not to exceed \$125.00 per semester or not to exceed \$100.00 for the summer session per student; this amount to be used in aiding out-of-state students during the second semester 1950-51 and summer session 1951.
- 639. Upon motion made by Mr. Price, seconded by Mr. Wooldridge, the Board approved out-of-state travel for President Wiggins to Atlanta and West Point, Georgia, on March 2, 3, and 4. Expenses to be paid from the Office of the President Maintenance Account.
- 640. It was the consensus of the members of the Board that the arrangements for securing the services of an architect for the repairs and alterations to the Chemistry and old Engineering Buildings should be left to President Wiggins. (The use of Mr. Urbanovsky was approved, provided he secures a license.)
- 641. President Wiggins read a Resolution from the City of Lubbock to the Board requesting an easement to certain land to be used in constructing a highway across the campus. A copy of the Resolution is attached, Item V, p. 6.

Upon motion made by Mr. McLaughlin, and seconded by Mr. Weymouth, the Board approved the granting of an easement, as requested in the Resolution, provided such an easement would be acceptable to the Highway Department of the State of Texas. President Wiggins was authorized to contact Mr. DeWitte Greer, Chairman, Texas Highway Department, and ascertain whether or not such an easement would be acceptable to the Highway Department. President Wiggins was authorized to take the necessary steps to secure permission from the legislature to use such land as required by the Highway Department to complete the highway referred to in the attached Resolution, in event such action is necessary.

- 642. Mr. C. E. Weymouth presented to the Board a copy of a statement of policy relative to the three major institutions of higher education in Texas: namely, The University of Texas, Agricultural and Mechanical College of Texas, and Texas Technological College. Upon motion made by Mr. Weymouth, seconded by Mr. Price, Mr. Charles C. Thompson, Chairman of the Board, was authorized to sign the statement of policy for the Board. This motion received unanimous approval. The full text of the statement of policy is attached and made a part of these Minutes, Item VI, p. 7.
- 643. Upon motion made by Mr. Pfluger, seconded by Mr. Weymouth, the Board approved the changes in utility system contracts as requested in the agenda of January 19, 1951. In summary, the changes increased the Martyn Brothers, Inc., Dallas, Texas, contract by \$7,690.88; The J. P. Ashcraft Company, Dallas, Texas, contract by \$732.98; The Empire Electric Company, Fort Worth, Texas, contract by \$911.05; The Standard Construction Company, Lubbock, Texas, contract by \$14.13; total additions to utility contracts, \$9,349.04.
- 644. J. Lee Hogue, Jr., Tulsa District Corps of Engineers, Carl E. Rantzow, Southwest District Engineers Office, Dallas, Texas, and C. J. Doering, Office, Chief of Engineers, Washington, D. C., representing The Department of Army, met with the Board. They presented a letter to President Wiggins from the Honorable Frank Pace, Jr., Secretary of the Army, relative to taking possession of a part of the PanTech farm for use during the national emergency. The group representing The Department of Army suggested that a committee from the Board be designated to meet with the representatives of the Army to work out details relative to taking possession of the property by the Government.

Chairman Thompson appointed the following committee:

Upon motion made by Mr. Abbott, seconded by Mr. Ince, the Board approved the appointment and gave the committee authority to act for the Board of Directors in working out the necessary agreement with the Department of Army.

The letter to President Wiggins and the reply from the Board is attached and made a part of these Minutes, Item VII, p. 8, and Item VIII, p. 9.

645. Upon motion made by Mr. Ince, and seconded by Mr. Abbott, the Board approved the appointment of Sammy Baugh of Sweetwater, Texas, as a member of the Board of Directors of The Texas Technological College Foundation.

646. Upon motion made by Mr. Price, and seconded by Mr. Weymouth, the Board fixed the date for the next meeting as Monday, May 21, 1951, 9:30 A.M. in the Office of the President.

647. Upon motion made by Mr. McLaughlin, seconded by Mr. Pfluger, the Board authorized the Building Committee to attempt to negotiate with the low bidder, Mr. W. G. McMillan, Building Contractor, Lubbock, Texas, in an effort to cut the bid for the proposed Student Union Building to approximately \$500,000.00, including architect fees. If the negotiated bid should be satisfactory to the Building Committee, a contract would be recommended, subject to approval by the Board of Directors. A tabulation of the bids is attached, Item IX, p. 9.

#### ITEM IV

Change in Roof Pitch, Wings of the Administration Building Letter from W. G. McMillan, dated January 5, 1951:

"Sheet S-5, lower right hand corner, shows the roof pitch for the two wings to be cut on 5 to 12 pitch. Upon making a pattern, however, for cutting our joists, we find that the existing roof is a 6 and 12 pitch. The difference in pitch adds a strip 1-1/2' wider for the length of the building to the area to be roofed.

"We can still use the 12 and 14 foot length 2 x 8's, but it will be necessary to increase the length of the 2 x 4 vertical intermediate studs, add the necessary shiplap decking and 2 x 4's under the clay tile.

"The attached itemized additional cost for the two sides amounts to \$487.98. We feel that we would be entitled to a credit in this amount."

#### RESOLUTION

WHEREAS, the Legislature is now in session and special legislation may be required to authorize use of such strip of land, and the governing body of the City of Lubbock desires to extend its cooperation to President D. M. Wiggins and other college authorities in securing the right to use such strip for highway purposes at the earliest practicable time, to take advantage of the allocations above mentioned and to avoid delay in opening this proposed highway, THEREFORE,

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LUBBOCK:

THAT, President D. M. Wiggins and other Texas Tech college authorities be, and they are hereby extended the cooperation of the City of Lubbock in securing legislation, if required, authorizing the Texas Tech Board of Directors to grant an easement for highway purposes to a strip of land abutting the Santa Fe railroad tracks on the East side, parallel thereto and traversing the campus between 19th Street and 4th Street and East along 4th Street to College Avenue.

#### Gentlemen:

The governing boards of your respective institutions respectfully request you to explore the possibilities of coordinating the present and future operations of our three institutions by defining for each the principal fields of its major activities; by making the unique features and equipment of each available to students of the others; by defining the standards of graduate work to the end that graduate degrees from all of these schools may meet the most rigorous requirements and be accorded the highest recognition; by eliminating to the greatest extent possible wasteful duplication of effort or equipment; by fixing and seeking approval for teaching salaries sufficiently large to keep all of these schools on a fully competitive basis with other leading institutions of the United States; by work in unison with the Legislative Council in furtherance of its program, so far as it is deemed sound, but with insistence that these three schools require for their very existence as institutions of the first class support and freedom of action comparable to that enjoyed by competing institutions throughout the nation; by study of any related subjects which, in your sound judgment, would tend to promote the object of our inquiry and by arranging at least once each year for a joint meeting of the three governing boards and your principal executives and advisors to the end that this may be a continuing relationship improving each year through experience and through better knowledge of the fields of service in which these schools should continue preeminent.

We appreciate that the study we ask of you will require a great amount of time and effort. We believe its importance fully justifies both. We will appreciate your findings at the earliest practicable date.

In view of the national emergency declared by the President of the United States on December 16, 1950, and the immediate necessity for the expansion of military and related facilities in order to provide for the national defense this is to advise that the United States hereby elects to exercise its rights under the above cited deed of conveyance for the exclusive use of the following described property, together with all improvements and appurtenances thereon or pertaining thereto:

It is understood there is to be a meeting of the Board of Directors of the Texas Technological College on February 19, 1951, at which time the requirements of the United States for the use of the above described property will be discussed. Every effort will be made to have representatives of the Department of the Army, and other interested Government agencies present at your meeting to work out the details relative to the taking of possession of the property by the Government with a view to minimizing the disruption of any activities in which the College is now engaged with respect to the land and facilities involved and for the making of orderly arrangements as to the provisions of utilities and other service requirements for the area to be used by the Government.

#### OTHER MATTERS FOR CONSIDERATION

I recommend the acceptance of the bid of Mr. Joe Telford, Contractor, in the amount of \$1987.00 to install window guards on the ground floor of the Library Building.

Approve the installation and connection of a 6" water main from the steam tunnel to the Engineering Building. This installation has increased the cost to the Engineering Building contract in the amount of \$693.14.

Payment of Architect's fees to Wyatt C. Hedrick in the amount of \$520.92 for architect's services in connection with the installation of an elevator in the Chemistry Building. The amount of the contract was \$8682.00 and the date of agreement with Mr. Wyatt C. Hedrick was May 4, 1948.

Repair old Home Economics Building --- Authorize the removal of all tile, gutter, and nailing strips, and the installation of new copper gutter, new conductor pipe, mop on 2-15# felts, install wood nailing strips and re-lay tile. This would put the roof gutter and conductor pipe of the original Home Economics Building in good repair at a cost of \$1698.00. (This amount to be paid from the unappropriated balance and the repair work to be done by the Lydick Roofing Company of Lubbock, Texas).

Authorize changes in roof pitch on the wings to the Administration Building in order to coincide with pitch on the present Administration Building. The cost of such change to be \$487.98.

Consideration of proposals to put in usable condition the temporary building, X-6, which was moved from the main campus to the farm.

Approve acceptance of a credit of \$1800.00 for the omission of waterproofing the inside of the outside walls above the ground on the two wings to the Administration Building.
