

#### Harper Killed in Accident At Grand Prairie

Sidney Douglas Harper, 24, of Floyday a skilled May 16th when he fell from a training plane on a routine flight. He was a cadet at the naval reserve aviation base at Grand Prairie, and the accident happened near the field.

Ensign L. C. Merchant, the instructor who was flying with Harper, landed his plane without incident.

Naval officers at the air base stated Harper fell from the plane at such low altitude that his parachute was rendered ineffective. Apparently he had not buckled the safety belt or it became accidently loosened during the maneuvers.

Harper had entered the naval school in January 1942. His death was the first student fatality since the naval reserve aviation base started its operations a year ago.

District Judge E. L. Pitts of the 99th District Court at Lubbock, has an nounced for the office of Chief Justice of the Court of Civil Appeals, 7th District to succeed Chief Justice M. J. R. Jackson, who retires voluntarily next January 1.

Judge Pitts is 53 years old, a native Texan, born in Fannin County. His parents moved to West Texas when he was a child; and he grew to manhood in Palo Pinto County, where he resided until he moved to Northwest Texas some years ago. Judge Pitts' education was received in the pubic schools, East Texas Normal College, Commerce, Texas and the University of Texas. Subsequently he taught school; and then he entered the law profession. Before his election as District Judge, he served as County Judge of Lubbock County.

Friends of Judge Pitts are convinced that his education, training, natural ability and twenty years experience as a trial judge qualify him exceptionally for the position he now seeks. They point out that in his judicial career he has had come before him almost every conceivable type of case; and that he has conducted his courts to achieve prompt, impartial, courteous and satisfactory settlments of the issues involved. Attention is also called to the much study he has given to the new rules of procedure for the Texas Judiciary, and his conviction that the proper application of them will expedite trials to the end that justice will be better served.

District Judge E. C. Nelson, of Amarillo, is a candidate for Chief Justice of the Court of Civil Appeals of the Seventh Supreme Judicial District of Texas. This is one of the highest judicial offices in the State, one that demands thorough training and wide experience.

Judge Nelson holds the B. A. and LL. B. degrees from the University of Texas. His high standard of scholarship, both in the College of Arts and in the School of Law, is attested by the fact that he was elected to Phi Beta Kappa, Chancellors, and several other honor societies. He also studied law at the University of Chicago and at the University of Montpelier, France, one of the oldest and best recognized institutions of learning in Europe. For five years he was a teacher in public schools and college before he took up the study of law.

At the beginning of the first World War, Judge Nelson volunteered as a private in the Regular Army, and he has served in every grade from private to major. Fourteen months of his two years service were spent in France.

Judge Nelson has had a well-rounded legal experience. He has been a licensed attorney for 22 years. He has practiced law in all our courts, and he has been judge of all the courts of record up to the Court of Civil Appeals. As an appellate judge, he will be able, from his own experience, to view a case from the standpoint of both the practicing attorney and the trial judge. 
Miss Wanza Townley, class of '41, was recently married to Corp. Milford Allen at Anton.
