Public Meeting in Lubbock on RCA U. S. Dept. of Agriculture Soil Conservation Service Dr. Rex Johnston:

The League of Women Voters of Lubbock welcomes this opportunity to comment on the direction future soil and water conservation programs will take. For many years, the League has supported wise management and conservation of water resources. Catherine Perrine, Water Director of the League of Women Voters of Texas, presented a comprehensive statement at the Dallas-Fort Worth meeting last week.

Since our members reside on the High Plains, our special concern is ground-water mining and the fact that the water in storage in the Ogallala aquifer is being used up. We hope that the federal study of this six-state area will provide definitive information as to potential solutions for the water problems of this important agricultural area. Any proposal recommended should be both ecologically and financially sound.


We especially applaud the proposed RCA objective which reads:

"Minimize water use including soil moisture per unit of agricultural output consistent with environmental and economic defensibility by:

1) Increasing efficiency in agricultural irrigation...
2) Promoting (the word 'limiting' is obviously an error) water conservation measures...to better management, low capital intensive practices, and shifts to lower water use crops."

Shifting to lower water use crops is important. According to the February 1980 Cross Section, published by the High Plains Underground Water Conservation District No. 1, the water level dropped 28.86 inches in Parmer County the last ten years while it dropped only 6.18 inches in Lubbock County. Between 1970 and 1980, many Parmer County farmers shifted to corn, a high water use crop, while Lubbock County farmers irrigated cotton and grain sorghum--crops that are not as high water use as corn. The U. S. Department of Agriculture should examine its policies to assure that conservation, rather than increased use of water, is encouraged.

The Texas Division of the American Association of University Women has endorsed the water proposal amendments, Propositions 1 and 2 on the November 5th ballot. At its fall Board meeting, October 19-20 in Houston, the organization stated that this step toward a truly comprehensive water plan for Texas is needed at this time. In order for the state to avoid emergency measures and crisis management of water, the \$1.43 billion Texas water plan is essential to protect and restore water quality and ensure water supply. The American Association of University Women has recognized the value of water and the importance of conservation for several decades.

Rema Lou Brown of Houston, president of the Texas Division of the American Association of University Women, urged its 10,000 members to help get out a favorable vote for the measures. "Managing water resources for tomorrow begins today," Mrs. Brown said. "Funding is needed now for conservation of Texas rivers, streams, and estuaries, for encouragement of better management of groundwater, and for low interest loans to farmers for purchasing water-conserving irrigation equipment. The state with its diverse water needs must have a balanced, flexible, long-range plan for water," according to Brown.

The Texas Division of the American Association of University Women is composed of 10,000 college-educated women in over 100 communities throughout the state. The Association has long been supportive of wisely developed water resources and measures to conserve this decreasing natural resource.

## MINUTES OF ECUMENICAL COUNCIL ON SOCIAL CONCERNS May 6, 1971

The Ecomenical Council on Social Concerns met Thursday, May 6, at Mt. Vernon United Methodist Church, 2304 Cedar.

Dr. Alwyn Barr, director of minority studies at Texas Tech, moderated a panel on "Separation or Integration?" Members of the panel included the Rev. N. T. Reed, pastor of Mount Vernon United Methodist Church and president of the Lubbock chapter of NAACP; Dwight Gibson, president of Dunbar Studnet Council and a National Merit Scholar; Charles Brown, principal of Struggs J.H. School; and Jorge Moreno, president of L.E.A.R.N. and former president of the Community Action Agency.

Dr. Barr directed the following questions to the panel: How much separatism? What caused it? Where will separatism lead? and is integration possible for the future? Although the panelists expressed some discontent with the present integration process, most felt that the separatist phase was a temperary one.

Tom Burtis presided in the absence of President Dan Higgins. Mr. Burtis reviewed the Council's work the past year, mentioning representation on the CAA Board and the Majority Coalition and leadership in the ESAP proposal to be funded through L.E.A.R.N. The Council also supported Mi Casita in its position for scattered public housing in NE Lubbock and for the school bond issue. Through the exchange of information this year, our members have been able to act more effectively.

The Reverend Art Preisinger, chairman of the nominating committee, chaired the meeting for the election of officers. Nominees for next years officers are: Pres. Tom Burtis, Vice-President Maurice Richard, Secretary-Treasurer Sister Regina Poppe, and CAA representative Dan Higgins. Mr. Preisinger moved that the slate of officers be accepted. Mary Vines seconded the motion, and it carried.

The Ecumenical Council on Social Concerns met Friday, June 25th, at 6:00 p.m., 2009 Ave. K with members of the police union.

Members of the Council listened to the policemen discuss their working conditions, grievance procedures, insurance benefits, retirement plans, and communication problems within the city administration.

A short business meeting, chaired by Tom Burtis, followed the general meeting. Gerry Monash moved that the Mayor Pro Tem, a spokesman for the union and their attorney be invited to a ECSC meeting to explain police grievance precedures and other related matters. Rev. Reed seconded, and the motion carried. Mr. Reed moved that a letter be sent to Mayor Granberry commending his public announcement of free choice of selection of utility companies by city personnel. The Council discussed equal representation on the City Council, but decided until fall to make a decision on this matter. Minutes of General Meeting Sept. 16, 1971 8:00 to 10:30 P.M. First Unitarian Universalist Church 2104 36th Street, Lubbock

1. Emergency School Assistance Program (ESAP). Nev. Dan Higgins reported that the present grant of \$40,000 will end October 1971. The program was intended to unite the three ethnic groups, but has tended toward separate Chicano and Black programs.

A new application is being filed by LEANN. The proposed Advisory Board still has a Chicano majority, even though the federal guidelines call for one-third from each ethnic group, and at least 50% parents of children affected by school segregation,

Motion was made by Betty Anderson, seconded by Myrtle Rochelle, that we request HEV to review the proposed Advisory Board and that we withdraw our support unless the Advisory Board is constituted according to the guidelines, Motion carried.

- 2. Cultural Awareness Program. It was intended to be a tri-ethnic poster design project as an interracial experience at the Tech Museum, but the Museum turned it down.
- 3. Equal Justice. Copies of the News Report and Editorial by Den Hightower, Radion Station KDAV, May 27, 1971, were distributed to the members present. The facts listed in the Report have been documented by the Ecumenical Council.
- 4. Citizers Grievance Commission. Mrs. Faye Alexander, a member of the Commission, gave a brief report of the Commission's work. A copy of the Commission Report was available to those present.
- 5. City Charter Revision (City Council).

Motion was made by Myrtle Rochelle, seconded by Daniel Higgins, that the City Council be enlarged to seven members with all Councilmen elected at large by the place system, but with residence requirements in specified geographical areas for each place on the Council. Motion carried.

President is to send letter supporting this to the City Council and the Larter Revision Committee.

- 6. City Employment Grievences (especially grievences of policemen) were discussed at some length. No action taken.
- 7. City Waste Containerization and Garbage Fee. Demiel Higgins Reported that the general sentiment voiced by citizens at the hearing today was in favor of a tax increase, if necessary, rather than the flat \$2.00 garbage fee which would be unfair to poor families who generate the least garbage.
- 3. Attitudes in Guadalupe. Stan Carlson completed a thesis relating to the attitudes of citizens remaining in the Guadalupe Barrie after the termade. His survey showed that attitudes toward the police and the city, county and state governments were unfavorable before the termade, had become very favorable the week after the tormade, but three months later many had reverted to their former unfavorable attitudes.

Mation was made by Daniel Higgins, seconded by Maurice Richard, that the Ecumenical Council provide \$50.00 toward making ten complete copies of the thesis, and printing a summary when prepared, and work with LEARN to disseminate this information. Notion carried.

her proposal was turned down by the Humanities Foundation in Washington. It is being restudied by the Tech Government Department and another Tech School. Nembers agreed to support the proposal, if submitted, by a letter.

Statistics from the Lubbock Schools Distribution Sheet of October 1, 1971 on Free and Reduced Priced lunches in the Elementary Schools show that 33% qualify and are using the program. The Cafateria Director, Mrs. Stage, said the November peak in all schools reached 9000 of 33,000+ students or 26%. An OEO Texas Newsletter in January 1972 pointed out that the State of Texas had doubled the number by 101% since the new legislation. Bubbock Schools since the Quota System on the old policy was dropped in November 1969 increased it by 1600% from 525 to 9000 free or reduced priced lunches. The citizens of Lubbock and out School System are to be congratulated. It is doubtful that any Metropolitan City in the Nation surpasses this. Dropouts remain a problem. The Social Action Service of the Diocese of Amerillo has submitted a proposal "Building the West Texas Community of the Future by Leginning Now" to notivate the potential dropout in Grades 7 through 12 by providing tutoring on a one-to-one basis. 



This report highlights League activities during the past year, gives our preliminary plans for providing information to Texas citizens in 1980-1981, and recognizes major contributors.



### THE LEAGUE

The League of Women Voters of Texas is a nonpartisan organization which does not support or oppose any political party or any candidate. The Internal Revenue Service has determined that the League is a tax-exempt nonprofit organization, in accordance with Section 501(c) (4) of the Internal Revenue Code.

Established in Texas in 1919, the League has provided sixty-one years of responsible service to Texas citizens.

A member-based organization, the League determines topics for statewide study and action and state budget commitments at a state convention held each two years. Local Leagues choose local program topics and adopt local budgets at annual meetings of their members.

Action on issues is taken only after members have conducted studies and have reached consensus (member agreement).


### THE TEXAS EDUCATION FUND

The League of Women Voters of Texas Education Fund (TEF) is a research and education fund that provides reliable, impartial information about government. The Internal Revenue Service has determined that the TEF is an educational and charitable trust, in accordance with Section 501(c)(3) of the Internal Revenue Code. It is further classified as an organization not taxable as a private foundation as defined in Section 509.

The Board of Trustees meets at least four times a year to consider new projects and to evaluate completed projects. The Board adheres strictly to guidelines required by law. Directors of the League of Women Voters of Texas also serve as Trustees for the Education Fund.

Local Leagues in Texas are also involved in educational projects of the TEF, under the supervision of the Board of Trustees. These projects include publications on city and county government, local League-sponsored conferences, and election-related services.

Contributions to the Texas Education Fund may be deducted for income tax purposes, in accordance with Section 170 of the Internal Revenue Code. Gifts may be directed to the over-all educational efforts of the fund or to specific projects that meet TEF guidelines.



All citizens 18 years or older are welcome to join. The League DOES support issues that it has found are in the public interest. The League DOES NOT support or oppose any political party or any candidate.

# For what reasons may the judge excuse or postpone your jury duty?

The judge has discretion to excuse any person or groups of persons for reasons of hardship.

If you are leaving town, your jury duty can be postponed. If called for the petit jury, call the district clerk.

If called for grand jury, call the district judge.

If you are sick -

Obtain a doctor's affidavit to prove you cannot serve and mail this to the district clerk for the petit jury or to the district judge for the grand jury.

### How is the District Court grand jury selected?

The judge appoints a grand jury commission of not less than three nor more than five persons.

This commission selects names of 20 responsible, community-minded citizens. This group of 20 becomes the grand jury panel.

For the jury, the first twelve persons who qualify make up the grand jury. The judge then appoints the foreman.

The grand jury serves during the term of the court. There are generally four grand juries each year.

The grand jury usually meets at least once a week. Nine jurors constitute a quorum. The foreman may excuse a member from attending a meeting.


#### Are jurors paid?

District and county petit jurors are paid \$4 per day to serve on a jury; grand jurors may be paid up to \$10 per day. If the petit jury is summoned by special venire, persons on the special venire jury panel receive \$2 a day, and the final 12 jurors selected receive \$4 a day. Lodging and meals are provided when necessary.

All federal jurors are paid \$20.00 a day, plus travel expense of \$.10 per mile both ways (plus the amount, if any, expended for tolls), and an additional \$16.00 a day if the juror remains overnight.

### What may happen if a juror is late?

The judge may hold him in "contempt of court," and he may be fined or given a jail sentence.





## JURY SERVICE - A CITIZEN'S PRIVILEGE AND RESPONSIBILITY

### How many kinds of juries are there?

There are two types of juries: one investigates charges to discover whether a charge really exists; the other tries actual charges.

 The GRAND JURY investigates criminal charges, hears sworn testimony, and decides whether to dismiss the charge ("no-bill") or indict for court action ("true-bill" or "indictment").

In District (state) grand juries TWELVE persons form the jury.

- In Federal grand juries not less than SIXTEEN nor more than TWENTY-THREE persons form the jury.
- The PETIT JURY tries the actual charges in criminal cases and determines the facts in dispute in civil cases. It is the third part of the Court: the judge, the lawyers, and the jury. The jury decides questions of fact; the judge decides questions of law and makes the ruling in the case.

In County Courts SIX persons make up the petit jury. In District and Federal Courts TWELVE persons make up the petit jury.

### What different kinds of courts use jury trials?

- State District and County Courts.
   County Courts-at-law.
   A County Court which serves as Probate Court.
- 2. Federal Courts.
- In addition, the various Justice of the Peace, Juvenile, and Corporation courts may occasionally have jury trials.

### Who is eligible for jury duty?

 In District and County Courts: Any citizen of the State and County who is (1) at least 21 years old, (2) qualified to vote, (3) a freeholder in the State or a householder in the County (or the wife of a householder in the County), (4) of sound mind and good moral character, and (5) able to read and write.

No person may qualify as a juror, however, if he (1) has served as a juror in the District Court for six days during the preceding six months or in the County Court for six days during the preceding three months, (2) has been convicted of a felony, or (3) is under indictment for a felony. Furthermore, the following persons will be disqualified to serve as jurors in any particular case: (1) any witness in the case, (2) any person directly or indirectly interested in the case, (3) any person related by consanguinity or affinity within the third degree to either of the parties to the suit, (4) any biased person, or (5) any person who has sat as a petit juror in a prior trial of the same case, or a trial involving the

same questions of fact.

2. In Federal Courts: Any citizen of the United States who (1) is at least 21 years old, (2) has resided for a period of one year within the judicial district, (3) is able to read, write, speak, and understand the English language, (4) is both mentally and physically able to render efficient jury service, and (5) has not been convicted of, and does not have any charge pending against him for the commission of, a crime punishable by imprisonment for more than one year.

Any person summoned for jury service in a Federal Court may be excused by the judge upon a showing of undue hardship or extreme inconvenience. For example, in some Federal Districts individuals may be excused at their request if the distance to the courthouse, either in miles or in travel time, is "excessive" according to standards previously established by the Federal Court. Likewise, within a two-year period no person will be required by the Federal Courts to (1) attend court for more than thirty days for prospective service as a petit juror (except when the service is necessary to complete service in a particular case), or (2) serve on more than one grand jury, or (3) serve as both a grand and petit juror.

A person summoned for jury service may also be excluded by the Federal judge when the individual (1) will not be able to render an impartial decision, or (2) is otherwise unqualified for jury service.

### How are jurors selected in District and County Courts?

A list of qualified jurors is prepared by the tax assessor, the district clerk, the county clerk, and the sheriff in August each year. Each name is put on a card, and the cards put in a metal container known as the jury wheel. This wheel is locked with two keys (one is kept by the district clerk and one by the sheriff). The wheel is turned to mix the cards, then in the presence of the sheriff and the district clerk about 150 names are drawn at a time.

In cities and counties relatively small in population, slightly different selection methods may be employed.

### How are jurors selected in the Federal Court?

Each Federal District Court in the United States has its own written plan for the random selection of grand and petit juries. These plans provide for the selection of jurors from a fair cross section of the community — no person may be excluded from service because of his race, color, religion, sex, national origin, or economic status. Under these plans, the names of prospective jurors are selected at random either from the voter registration lists or from the lists of actual voters in the Federal Judicial District. These names are then placed in a "master" jury wheel and,

from time to time as directed by the district court, the clerk or district judge publicly draws from the "master" jury wheel the names of as many persons as may be required for jury service. These names are then placed in the "qualified" jury wheel and drawn as they are needed for grand and petit jury panels.

### What happens if your name is drawn?

If your name is drawn for a District or County Court, the sheriff sends you notification of the time and the court by mail.

If your name is drawn in a Federal court from the "master" jury wheel, the elerk or jury commission mails you a "Juror Qualification Form" accompanied by instructions to fill out and return the form to the clerk or jury commission by mail within ten days. If your name is drawn from the "qualified" jury wheel, you are notified either by personal service or by certified or registered mail of the court in which you must appear and the time for the appearance.

When the prospective jurors assemble, the roll is called, the requests to be excused are heard, and then the judge rules on the requests. Those not excused are allotted to as many groups as there are cases that need jury panels.

From the jury panel, of maybe 50 persons, the 12 (or 6) jurors for each case are chosen.

### What is a Special Venire Summons?

A special venire summons is sent out by, a district court to select a jury for a specific case in which the death penalty may be invoked. Special venire jurors are kept under custody throughout the trial.

### Who can claim exemptions from jury duty?

Federal Court:

- Members in active service in the armed forces of the U.S.
- 2. Members of fire or police departments.
- Public officers in the executive, legislative, or judicial branch of government.

#### District and County Courts:

- 1. All persons over 65.
- Ministers of the gospel actively engaged in the discharge of their duties.
- Practicing physicians, dentists, veterinarians, chiropractors, optometrists, attorneys and spouses of attorneys
- Railroad station agents, conductors, engineers, and firemen when engaged in the discharge of their positions.
- All members of the "Militia" of the State National Guard during periods of time when they are actually on active duty.
- Active members of fire departments (in cities having 1,000 or more inhabitants).
- All females who have legal custody of a child or children under the age of 16 years.
