Before the session evolves into the predictable madhouse it usually evolves into, let me thank all of you for the hard work you've put in so far and the hard work you'll be putting in during the next few weeks.

Now that we're more than halfway through the session it's time to send me a list of the bills you'll be following. I need this because it is not cost effective for me to send you committee substitutes and amendments, as well as engrossed and enrolled legislation if you are not interested in them. Furthermore, you are all human beings and haven't the strength or endurance to follow every bill in your portfolio that is filed--and by this time if a bill has not been heard in a committee in at least one house, it probably will not go anywhere.

We are also going to have ^{to} watch very closely our budget on the newsletter. Lovely as it might be to inform local Leagues about all the interesting issues we think they should know about, we don't have enough paper or postage money to do this. From now on, all bills that are just FYIs won't appear in the newsletter unless you think we might be taking a position on them soon. Of course, there are always exceptions to this rule (I know, Catherine, all that water legislation which was filed late and needs to be described; ignore this), and I am not anything if not flexible. But as a general rule, we'll be printing more information on bills we've already described and also what's happening in state finance as it affects our positions than we will new stuff.

The legislature will be going home after business on Wednesday, April 15, and will not return until Tuesday, April 21. We will be publishing a very short newsletter on Wednesday, and it will for sure contain an account of the two-day House and Senate hearings on the abortion bill and anything else you feel absolutely need to get in. The legislative office will be closed on Friday, April 17, and Monday, April 20. If possible, we will also close on Thursday; this depends on the production of the newsletter. We will not take anything for the newsletter after Wednesday.

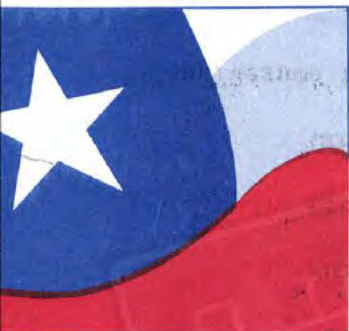
