Now--and I know you've been waiting with considerable anticipation for this part of the awards--it is at last time for the presentation of the winner and runner-up for the GROVER. Our judges assure me that they have labored long over these choice selections. So let's all try to be partly happy with the decisions.

THE GROVER

THE GROVER, our award given for the most outstanding performance of either classical tragedy or unintentional comedy, goes to our school's Board of Directors for their consistent ability to act emotionally and irrationally in situations requiring intelligent progressive and decisive actions. We feel that their performance has best approximated the essence --the spirit--of THE GROVER.

The runnerup for THE GROVER was the majority of the student body of our school for the sensitivity, thoughtfulness, and concern among them which produced, from an enrollment in excess of 17,000, only about 4,000 who were willing to take time to vote in the Executive elections or in the recent CHOICE '68 referendum.

Until Proven Guilty

Responsible news media reveal the truth about daily events. In criminal cases the media are obligated to maintain an atmosphere of doubt about the guilt of the accused who is 'innocent until proven guilty' by courts. The arrest of Benjamin Lach with subsequent news coverage demonstrated negligence of this obligation and may have convicted Lach in the public eye.

The media emphasized the ethnic element, printed parts of the accused's statement prior to its acceptance as evidence, prejudiced the case by editorials, overplayed circumstantial evidence, treating it as fact, exposed Lach's criminal record, and, finally, presented parts of the DA's hypothesis for fitting the facts together.

Local radio broadcasts hammered "foreign student" into the public's ear, failing to mention on several occasions his naturalized citizenship. Lubbock's A-J emphasized "Polish born" in the March 15 morning edition. Radio station KSEL however, did editorially castigate other news services for their handling of the case.

Parts of Lach's three - page statement were published in the A-J March 14 morning edition. Appearing on the front page under the headline "Student Gives DA Statement" was the following, "Although contents of the subject's statement were not publicly disclosed, the Avalanche-Journal learned that Lach had indicated Mrs. Morgan surprised him in room 304-J " Treating a statement of questionable validity (from a second-hand source) as a fact is considered poor journalism, but to print part of the accused's statement before it is accepted as evidence in the case can be illegal although in this case it is within the letter (only) of the law since no quota-tions are from the statement itself. Newspapers are also prohibited from calling a statement a confession before it is accepted as such in court. Radio and television stations don't seem to be held by the same law, though, for many actual-ly said Lach confessed. Later at the examining trial, Justice of the Peace Wayne LeCroy did accept Lach's statement as evidence, so any suits that could have resulted from these loose observances of the law were nullified. But one must ask this: Should one obey a law only to protect himself, or to prevent injury to others?

Two questionable editorials appeared in the University Daily. One was in the Thursday March 14 edition, under the title "Law Enforcement Difficult Business." The writer quotes Traffic-Security chief Bill Daniels as saying "I've never been so relieved in my life" about the capture of Lach. And, another paragraph down, the writer states, "The approximate \$20,000 spent on additional security for the campus immediately following the murder now seems unnecessary..." By the time the last paragraph says "If the man now charged with the crime is guilty or not is for the jury to decide," the damage is done. It is already stated in so many words that we can all rest easy because the killer is caught.

Roy McQueen's editorial, "Who'll Get Reward" in the Friday March 15 issue of the UD is the other questionable editorial. The author seems convinced that the case is broken, that the killer is caught and that the only thing left to do is to decide who should get the reward.

These UD articles can be excused fairly easily as the products of inexperienced criminal reporting. However, the staffs of the professional news services know (we hope) laws regarding criminal reporting and thus should receive no quarter.

Overplaying sensational circumstantial evidence and treating it as conclusive was more widespread than any other offense. In the March 13 evening edition on p. 14-A, the A-J stated that reporters obtained "positive identification from at least seven persons" that Lach was the same man seen loitering around the Science Building. But they failed to mention the time element: these identifications were obtained more than a month following the incident.

Patriotism And Nationalism

by Frank What is patriotism? We must ask ourselves this question just as we must also question the values by which we profess to live. A society which refuses to do so by taking them for granted is already spiritually dead. We accept or reject what is transmitted to us but by so doing we are transforming, we are in a sense creating our own values. Great Americans have always upheld this attitude.

Tyranny does not like this; it seeks to impose a deadly silence upon the speculative, inquiring mind. Does such a silence pervade Texas Tech?

Patriotism, as I understand it, is a love of one's native land, and as such, is tender and warm, a filial devotion acquired through understanding, experience and truth. It does not oppose the foreign but seeks to understand it, and by doing so, it may even assimilate it, thereby becoming in turn larger, more varied, often more superior and noble. Patriotism gives freely of itself but does not seek to coerce others: it bears arms in defense of the mother country rather than in conquest of a foreign people.

It springs of its own accord from the heart; it is innate and individual ---each may love his country in his own way, from his own experiences, from his own life.

Nationalism, on the other hand, is not so much a love of one's land as a hatred of others. It is inseparable from xenophobia and jungoism. Neither is it tender and warm. a filial devotion acquired through understanding, experience and truth. It thrives upon opposition to the foreign, upon an arrogant and brutal agggressiveness. Rather than assimilate the desirable attributes from other cultures, it promulgates the most negative and vicious aspects of its own. It seeks to drive us all into a bed of Frocustes, the measure of all tyranny, by forcing the abstract upon the real, thereby killing the individual who is not abstract. For it people are generalities, not individuals. Nationalism is the blood brother of racism: it sees the blackness of a face but not the face. Its hatreds are as irrational as the blood feud between the red and the black ants. Rather than recognizing the liberty of the individual mind, the ferment and excitement of free exchange, it seeks unconsciously to impose upon us the equality of the herd. It makes of men rapacious beasts who attack alien skin color or, most dangerous of all, the alien ideologies, that bundle of abstractions learned by heart and recited on the tip of a bayonet. A political belief thus becomes functionally identical to skin color, to racism. Both are arbitraty and means of catagorizing, therefore, of judging a priori (we know that all communists are bad).

Last all communists are bad). Because patrictism is free and spontaneous, it cannot be taught. Nationalism, however, is always indoctrinated, most generally in schools where it bends and distorts the mind of the young and innocent. It makes of the bond between a man and his country a vicious complexity, an obscene collusion. The average man of today, if he seeks his freedom, must first repudiate a nationalism forced upon him at a helpless age.

Nationalism is a tribal perversion exerted on a huge scale. It commits every crime but will confess to none. The plague of our century, it has become our sacrificial altar. It makes us less than human. Now I must ask you, as I ask myself, how do we stand before patriotism and nationalism at this moment? How so we stand before Vietnam and our flaming ghettos?

YARBOROUGH IS FORUM'S CHOICE IN '68

On Tuesday, April seventeenth, Don Yarborough spoke at a fund-raising dinner in Lubbock. His message was clear, simple, and definite--something quite unusual.

Yarborough is the avowed liberal candidate. Here in the Plains area, the word "liberal" is often the kiss of death to aspiring officeholders. Yet Mr. Yarborough offers more than liberal platitudes and do-gooder panaceas. To be sure, he desires good for as many as possible. But he has a definite program of legislative goals, and in our estimation his program is far and away the most promising and comprehensive of those offered. It is promising not only in long-range terms, but also in more immediate, tangible terms, in money-inthe-pocket and chicken-in-the-pot benefits designed to reach all the people rather than only those in the "higher" or more influential social levels.

Dear John,

I've I've been hearing about a small but vocal group at TSU who seem to have the utterly fallacious idea that they should have something to say about what affects them. Another of the circumstantial facts involved was Lach's similarity to the composite made by police from descriptions of a man seen in the Science Building the night of the murder. The A-J published the composite next to Lach's photograph in the March 14 morning edition, p. 6-A, with the cutline "Amazing Resemblance." The use of the adjective "amazing" not only is poor journalism, but also it exaggerates the importance of the evidence just as "positive" exaggerates the validity of the identifications.

On page 10 of the March 15 morning issue of the A-J, similarities between the Tech murder and the Suffolk University killing are expressed, but the 'coincidence' is put in quotations to make it imply something other than coincidence.

Dragging in the suspect's previous criminal record (which has no specific bearing on the case) is another mark against the news media. While all the above pertains to definite, if circumstantial, facts in the case, Lach's previous record is an irrelevant fact. While proving that he was in the Science Building at the time of the murder could be instrumental in proving his guilt, proving that he broke into a professor's house to see his grades last year is completely irrelevant to his possible guilt in this case. The DA can bring it into court but the news media may not say "Well, that's one of the facts in this case." The only purpose it serves is to degrade Lach's reputation and prejudice further the public against his innocence. Yet, both the A-J and UD mentioned his conviction for breaking and entering.

tion for breaking and entering. Finally, presenting the DA's hypothesis for fitting together the facts has also prejudiced public opinion against the suspect's innocence or possible innocence. The March 14 issue of the UD repeated on the front page Griffin's statement that "police theorized Lach had been in the biology lab when Mrs. Morgan entered it at about 7:30 pm Dec. 4. He said this probably surprised Lach, considering 'previous offenses of breaking into offices.' When asked what Lach was doing in the lab, Griffin replied 'hiding.'" A similar statement of the DA's theory appeared in the Thursday evening A-J on page 14-A.

Accounts of the arrest sent out by local wire service correspondents were also condemning. On the front page of the March 14 edition of the Amarillo Daily News was printed "District Attorney Alton Griffin Baid that Lach had signed a statement admitting the slaying...." And later in the same article, "'He gave a confession,' Griffin said." The article also played up "Folish-born" and repeated the statement by Griffin, explaining why the accused was supposed to be in the lab at the time of the murder; all of this, and it hasn't yet been proven even that Lach was in the laboratory.

They know they help keep America slightly insane. - - Norman Mailer On page three of the March 14 Fort Worth Press, more caution is observed than in the Amarillo paper. But the same statement is made: that Lach "signed a statement admitting the murder...." In this story also, "foreign student" is emphasized without further explanation until near the end.

The reporting of the examining trial was fair, if not thorough. But omissions are worthy of note. The quarrel over the acceptance of Lach's statement as evidence was completely overlooked.

Attorney Bill Gillespie tried repeatedly to question Lt. Carol Bartley about previous confessions made in connection with the case, but the witness was shielded by objections of the DA and the sustaining of these objections by Justice of the Peace LeCroy. Not until Lach's statement was accepted as evidence and read in full to the court with a copy given to the defense did Gillespie make any headway on getting information about the circumstances surrounding the other admissions of guilt. All that he was able to find was that there were three such statements: two which had come to the police (Bartley did not know how long ago) and one tape recording which the police After this there were a few sarcastic re-marks from both sides, but it all boiled down to this question: Were the previous statements pertinent to the validity of the confession under consideration? The judge considered the confession irrele-vant until Griffin proved its relevance. At this point, the defense attorney was allowed to question the witness about them.

The examining trial brought out another fact -- that the accused had been warned of his constitutional rights but had not been taken before a magistrate after his arrest, either before or after he gave the police his statement.

The newspaper articles and radio and TV broadcasts revealing the facts about the arrest of and case against the suspect were in most cases in strict accordance with the law. Opinions were given in quotations, as were any statements of questionable validity. However, the spirit of the law--a true concern for keeping the minds of the public open--was absent from all but a few of the news media.

So far there are no federal or state laws against this kind of reporting. However, in many states, such as Mass. and Utah, bar and press associations have gotten together and formulated guidelines for themselves to keep such laws from becoming necessary. Many news media bigger and better than anything here in Lubbock have imposed codes of ethics on themselves and have managed to work within them and still thoroughly report criminal cases to the public. The offenses we have cited above have been included in most if not all of these codes. Many news services like those in Lubbock do not yet accept their responsibility for keeping the public open-minded in regard to the accused's innocence.
