


This drawing needs to be 1" X 2" depicting a historical event. Some samples are enclosed in this letter. Among ideas suggested have been:

- 5. All Other Ideas Are More Than Welcome


SOME EXAMPLES OF OTHER CANCELLATION STAMPS


#### BORDEN COUNTY HISTORICAL SOCIETY MAKE PLANS FOR CHRISTMAS CELEBRATION

The Borden County Historical Society met in the Community Meeting Room of the Borden County Courthouse on Thursday, July 21, 1994, at 7:45 P. M. Members present were Kenneth and Shirley Bennett, Sue Smith, Van and Barbara York, Fannie Flint, Dorothy Browne, Buster Taylor, Joel Dennis and Larry Smith. Terry Smith was also present on behalf of the Gail, Borden County, Post Office. The meeting was called to order by chairman, Kenneth Bennett. Van York gave the treasurer's report. Bills incurred in cleaning the museum were approved for payment.

It was approved by the committee to pay for half the cost of preserving the Borden County Bi-Centennial Quilt. It was noted that this piece of art is now hanging in the Courthouse and everyone is urged to come by and see it. The quilt was preserved by Bill Clements of Snyder, Texas. Mr. Clements said that the quilt is probably preserved for another 100 years. Judge York explained about the time, expense and labor that was put into preserving the quilt. The wood matches the paneling in the Courthouse making it a very attractive display. The quilt is mounted to acid-proof material for the most protection. It is tacked

MAMIE LEMON, 79, OF Fluvanna died January 31, 1994 in Snyder. Born March 9, 1914 in Bosque County, ahe married H. B. Lemons on Dec. 24, 1936 in Snyder. Among her survivors are her husband, two sons, Hurston Lemons of Borden County and Bobby Lemons of Colorado City; a daughter, Darlene Jacob of Abilene; a brother, J. W. Pylant of CA.; five grandchildren & five great-grandchildren.

SYBIL KATHRYN HOLMES, of Temple passed away Jan. 20, 1994. She was born in El Paso and married J. Wiley (Jake) Holmes on Aug. 2, 1947 in Van Horn. She was a beautician, piano teacher, pianist in four different Baptist Churches, and worker in 4-H activities. She was a deputy in the Borden County Clerk's Office but above everything else, she was a caring and understanding County Agent's wife, helping the kids of Borden County in every way that she could. She also worked with and typed THE BORDEN CITIZEN NEWSLETTER. She is survived by her husband of Temple; one son, Gene Holmes of Belton; a daughter, Kathryn Smith of Laredo; five grandchildren and three great-grandchildren.

NICOLAI JANE LACKEY, of Midland, died Feb. 15, 1994. She was born in Beaumont and married there in 1945. They moved to West Texas in 1950 and lived in Goldsmith, Mentone and Gail before moving to Midland in 1990. She was the Postmaster in Gail. Among her survivoes are her husband, two sons and two grandchildren.

CLARENCE ISAACS, 82, died Feb. 16, 1994 in Lubbock. He was born in Fannin County and married Gertrude Kropp on May 23, 1931 in Borden County. She died on Nov. 10, 1980. He married Lyrtle Rierson on Nov. 7, 1981 in Lamesa. His brother, Leonard Isaacs of Borden County preceded him in death on 1985. Among his survivors are his wife, 2 sons, 2 stepsons, 2 step-daughters, a brother Elmo of Big Spring and a sister, Kathleen Rhodes of Dallas.

WAYNE CROW, 62, of Snyder passed away Feb. 24, 1994. Born in Fannin County, he married Rosa Lee Franklin on April 23, 1955 in Borden County. He had been a farmer in Borden and Scurry Counties since 1952. Survivors include his wife; two sons, James Wayne Crow of Wicks, Ark. and Kenneth Lee Crow of Anson; one daughter, Melynda Ann Sturdevant of Amarillo; five brothers; eight grandchildren; and three step-grandchildren.

EDITH McBRIDE, 83, of Vealmoor passed away March 5, 1994. Born July 29, 1910 in Polar, Tx, she married Otis McBride in Mammoth Springs, Ark. They moved to Borden County in 1936 from Arkansas. She taught on the Miller Ranch, in Vealmoor, Ackerly and at Airport Elementary in Big Spring. She taught school for 39 years. Survivors include her husband; two daughters, Donna Kruse of Ira, and Kay Leek of Vealmoor; and 4 grandchildren.

NELLIE WILLIAMS, 78, of Borden County died March 17 in a Lubbock hospital. She grew up near Cove, Arkansas and moved to Texas in 1930. She married Harlin Durant Williams on February 17, 1934 in Dickens, Tx. They moved to Brownfield and then to Borden County in January, 1941. She was a member of Berry Flat Baptist Church for over 30 years before joining First Baptist in O'Donnell. She was a homemaker, beloved wife, mother and friend. Survivors include her husband; two sons, Ralph of Lamesa and Kenneth of Borden County; eight grandchildren and six great-grandchildren.

CLAUDE "TOOTER" SWAN, 74, of Gail died April 15, 1994 in Lamesa. Born Jan 16, 1920 in Loraine he married Glenn Scott May 23, 1942 in Sweetwater. He was a veteran of the U.S. Army Air Corps during World War II. He was a foreman of the Spade(Dean Ranch Lease) for 20 years. He retired from the Texas Highway Department. Survivors include his wife; two daughters, Iris Smith of Lamesa and Claudia Ogden of Midland, a sister, and three grand children.

OTIS McBRIDE, 86, of Vealmoor passed away April 26, 1994. He was born July 2, 1907 in Camp, Ark. and married Edith Clanton on Sept. 7, 1928 in Ark. She prededed him in death on March 5, 1994. Mr. and Mrs. McBride moved to Borden County on the Miller Ranch in 1936. They later moved to Vealmoor (Borden County) in 1944. Mr. McBride farmed and ranched all his life. His daughter, Donna Kruse of Ira preceded him in death in 1994. Among his survivors are a daughter, Kay Leek of Vealmoor, 3 granddaughters and one grandson.

MARSHALL DAVIS, 90, of Purmela, Texas died April 9, 1994. Born Dec. 28, 1903 in Borden County, he married Ethel Matthews on March 26, 1926 in Borden County. She died June 12, 1989. He farmed for many years in the Murphy Community, farming land that is now under Lake J. B. Thomas and land that is now lake shore property. His six children were born on his place in Borden County. He taught Bible Class in the Murphy Baptist Church and continued to teach after moving to Coryell County, teaching for more than 50 years. He was preceded in death by a daughter, Nora Buchanan, three brothers and three sisters.

Survivors include two daughters, Ertis Kulla of Purmela, Mae Addison of Snyder; three sons, Marvin and Calvin of Brownsboro and Carl of Clinton, OK.; a brother, Melton Davis of Borden County; four sisters, Mildred Skelton and Lura Perry of Borden County, Esther Peveyhouse of Midland, and Della Brooks of Loop; 12 grandchildren and 18 great-grandchildren.

R. C. "BABE" UNDERWOOD, 70, of Gail, died May 15, 1994. He was born in the "cedar breaks" in Kent County. He grew up and worked in Kent County for awhile, then moved to Loving, N.M., where he worked for the Cotton Oil Mill. There he met and married Patsy Ware on Dec. 12, 1953. He moved back to Kent County and then moved to Borden County in 1969. He worked on ranches and raised four children who attended Borden County ISD. He worked as a welder for Borden County ISD until 1990 when he retired. Survivors include his wife; a son, Ray Don of Gail; three daughters, Patricia Zant and Kathy Goodman of Vealmoor, and Connie Hart of Gail; two brothers, two sisters; and four grandchildren.

VADA FOSTER, 66, of Lamesa passed away May 15, 1994. She was born Oct. 16, 1927 in Borden County and married Cecil Foster on Dec. 21, 1945. She and her husband owned and operated Allen's Galley Restaurant for 10 years in Lamesa. She had previously owned other shops. Survivors include her husband; a son, Gregory of Arlington; two brothers, Jack Smith of Lamesa and Johnny Smith of Pyote; four sisters, Irene Creighton of Borden County, Nig Watkins of Lamesa, Joey Ballew and Pat Hubble of Seminole, and four grandchildren.

NELL SCOTT, 58, of Lamesa died May 17, 1994. She was born March 5, 1936 in Loraine. She lived in Borden County before moving to Lamesa. She married Butch Scott on Dec. 20, 1957. She owned and operated Nell Scott Agency. Survivors include a son, Clint of Houston, a daughter, Janette Menix of Lamesa; her mother, Bonnie Kingston of Lamesa; 3 brothers, Bobby of Visalia, CA, Glenn of Garden City, and Jerald of El Paso; 2 sisters, Pearl Armstrong of Ackerly and Ollie Holmes of Borden County and four grandchildren.

IVA REEDER, of Dublin passed away May 26, 1994. She was a longtime resident of Gail and was buried in Gail Cemetery. She was born Feb. 9, 1909 in Luling, Young County, Tx. She was the widow of Sid Reeder, long-time Sheriff of Borden County, that she married Sept. 23, 1934 in Snyder. Sid died in office on May 11, 1963 and she finished his term as Sheriff which lasted until Dec. 31, 1964. She moved from Gail to Dublin 7 years ago. Among her survivors are two sons, Larry of Ft. Sumner, NM, and Borden Reeder of Dublin; one daughter, Sidney Pharr of Cisco; one sister, Azlee Reeder of Borden County, 9 grandchildren & 7 greats.

MAURICE D. DORWARD, of Clifton, Tx., died on \_\_\_\_\_\_. Mr. Dorward was born Jan. 27, 1906 in Gail. He married Margaret Vaughn on Dec. 23, 1928. He was a Methodist and a Mason. He moved from Gail many years ago but never forgot his roots. He was always interested in the Museum, Historical Society and Cemetery in Gail and supported them in all ways. He was a rancher and real estate developer in Clifton. Survivors include his wife; three sons, Don Dorward of Dallas, David Dorward and Russell Dorward of Clifton; seven grandchildren and a great-grandson. (Editor's Note.
